The Site is located within the Shui Lau Tin Site of Archaeological Interest (SAI). Other than the proposed drainage work, no other ground excavation work will be carried out. Subject to final approval of the Drainage Authority, peripheral drainage u-channels of not more than 1 m in depth will be proposed along the site boundary to collect the run-off to minimise the adverse drainage impact to the surrounding area. Given that the scale of excavation for the proposed drainage work is minimal, adverse impact to the SAI is not anticipated.
