The applicant seeks approval from the TPB for renewal of the Permission for Rural Workshop (Food Processing Workshop) for a further Period of 3 Years so that he can continue his operation at the application site (Please see Figure 1 and 2 for reference).

The justifications in support of the application are as follows:

1. The proposed use is exclusively serve as an ancillary food processing workshop for the nearby South Garden Seafood Restaurant (the Restaurant) located at Kam Sheung Road. The using rate for the food processing of "Basin Meal" at the application site is very low. It only served as a support facilities to prepare the "Basin Meal" during the Festival Days, such as Lunar New Year, Mid-Autumn, Dragon Boat, etc., It played an important role for the applicant to inherit the traditional "Basin Meal" in the these rural areas. The current situation of the application site showed at the Illustration at Appendix 3.
2. The approval condition under the previous permission had been complied with within the specified time as stipulated (Please see the Compliance Letter at Appendix 2)
3. There will be no change in the operation hours in this application which is the same as the approved operation hours (i.e. No operation between 5:00 pm to 8:00) under the planning permission no. TPB/A/YL-SK/334.
4. the site conditions including the layout and the use remain unchanged since the last approval.
5. The development under application is temporary in nature. The applicant undertakes to reinstate the land if planning permission for further renewal cannot be obtained.
6. Upon the Planning Permission period, there is no complaint lodged against the application site on traffic, nuisance, noise and hygiene aspects so far.
7. The transportation of food materials between the application site and the restaurant solely rely on trolley given the close proximity between them. No additional vehicular traffic will be brought to the nearby area.
8. The applicant would submit the application for Short Term Wavier (STW) to DLO/Yuen Long and he is willing to pay the STW fee from the date he first obtained the planning permission.
9. The drainage system implemented under previous approved layout plan (Figure 3 refers) are well maintained.
10. The Fire Safety Installation are all well maintained by the applicant. The F.S. 251 (Rev) was issued on 31.07.2025 (Please see copy of FS 251 (Rev) at Appendix 1).

I should be very grateful if renewal of the planning permission for a further period of 3 years can be given by the Town Planning Board.
