The justifications in support of the application are as follows:

- 1. The proposed use is exclusively serve as an ancillary food processing workshop for the nearby South Garden Seafood Restaurant (the Restaurant) located at Kam Sheung Road. The using rate for the food processing of "Basin Meal" at the application site is very low. It only served as a support facilities to prepare the "Basin Meal" during the Festival Days, such as Lunar New Year, Mid-Autumn, Dragon Boat, etc., It played an important role for the applicant to inherit the traditional "Basin Meal" in the these rural areas. The current situation of the application site showed at the Illustration at Appendix 3.
