申請臨時汽車修理工場及相關填土工程的理由如下：

一、滿足本地社區需求，填土具備技術必要性

擬議的臨時汽車修理工場能有效滿足新界鄉郊地區日益漸長的私家車維修需求，填補現有合法設施的不足。為配合工場運作，適度的填土工程具備技術必要性，旨在平整地面以確保維修設備與車輛能安全進出及停泊。作為為期3年的臨時用途，此申請能為就近提供專業服務、減少車輛長距離行駛，在不改變社區長遠規劃意向的前提下，惠及本地社區。

二、不會對周邊環境、消防安全及規劃造成負面影響

申請地點位於鄉郊地區，周邊以農地或低密度發展為主。擬議工場規模適中，將嚴格遵守環保及消防指引。在填土方面，工程只屬局部性，目的為平整低窪地面以防止積水滋生蚊蟲，並會規劃完善的臨時排水系統，確保不對周邊造成水浸影響。同時，工場將設有足夠防火措施及設備，完全符合消防安全條例。申請人亦會實施安裝隔音屏障、限制工作時間及妥善處置廢物等緩解措施，確保與周邊環境兼容。

三、優化土地資源利用及提供短期經濟效益

批准此3年臨時工場可善用閒置土地，避免因長期荒廢而引致雜草叢生或被非法傾倒廢物。擬議用途亦能創造本地就業機會，帶來正面經濟貢獻。此臨時安排符合城規會對鄉郊地區臨時用途的彈性處理原則，達致土地資源有效利用與規劃控制的平衡。

因此，申請人懇請城規會批准是項申請。
