7. Justifications 理由

The applicant is invited to provide justifications in support of the application. Use separate sheets if necessary.

1. The application site is subject to a previous planning permission No. A/YL-TT/617 and it was an application related to the relocation of affected business at Yuen Long (Lots 1478 (Part), 1479 (Part) & 1481 in D.D.119, Kung Um Road, Yuen Long, N.T.) due to the resumption of land for Yuen Long South Development.
2. The proposed development is temporary in nature and it would not jeopardize the planning intention of "AGR" zone in the long run. Also, similar relocation of business has been approved in adjoining lots. (A/YL-TT/695).
3. The nature, layout, form and scale of the proposed development is not incompatible with the surrounding environment.
4. Similar precedence for open storage was approved in "AGR" zone within the same Outline Zoning Plan such as A/YL-TT/695.
5. Minimal traffic impact as shown in the attached estimated traffic generation.
6. Insignificant environmental impact because no operation will be held between 5:00p.m. to 9:00a.m. The proposed development involves only open storage of construction materials such as barricades and packed tiles.
7. Insignificant drainage impact as drainage proposal has been submitted in support of the application.
