**7. Justifications 理由**

1. The application site is zoned 'Village Type Development' zone. The proposed development is temporary in nature and it would not jeopardize the long term planning intention of the zone.
2. The nature and form of development is not incompatible with the surrounding environment.
3. The proposed development is shop & services, eating place and associated public vehicle park which would benefit the adjacent villagers.
4. The proposed development is static in nature. It would not generate adverse impact to the surrounding environment.
5. The operation hour of the proposed development is 7:00a.m. to 1:00p.m. from Mondays to Sundays including public holidays.
6. Loading/unloading bays are proposed for the proposed development. Only light goods vehicle not exceeding 5.5 tonnes will be allowed to enter/park at the application site for the convenience of staff and public use.
7. Similar precedence were noted in "V" zone of the same Outline Zoning Plan such as A/YL-TT/591.
