1. Due to the release of TPB Guideline No. 13G, the applicant submits a fresh planning application for open storage and warehouse use.
2. The proposed warehouse is intended for the storage of vehicle and vehicle parts from the port and they will be stored in enclosed warehouse and opened area for port back-up uses.
3. The proposed development conforms to the Town Planning Board Guidelines for Application for Open Storage and Port Back-up Uses (TPB PG-NO. 13G) because it falls within 'Category 2' areas.
4. The proposed development is a temporary use for a period of 3 years which would not jeopardize the long term planning intention of the current zoning.
5. The proposed development is not incompatible with the surrounding environment including open storage use and port back-up activities.
6. Open storage & port back-up uses adjacent to the application site were granted with planning permission. Similar preferential treatment should be granted to the current application.
7. The planning circumstance pertaining to the application site is similar to the recent approval of adjacent open storage yards and port back-up uses.
8. No repairing, dismantling, cleaning or other workshop activities is proposed within the application site.
9. No medium or heavy goods vehicles exceeding 5.5 tonnes, including container tractors/trailers, as defined in the Road Traffic Ordinance will access the application site.
10. Minimal traffic impact.
11. Insignificant environmental and noise impacts because no operation will be held during sensitive hours.
12. Insignificant drainage impact because surface U-channel has been built for previous planning permissions.
13. Shortage of land for port back-up purpose in Tong Yan San Tsuen.
14. Drainage proposal and FSI proposal are submitted herewith in support of the application.
