1. The proposed development is a shop for selling grocery and bean products. The GFA and number of structure in the current application have been reduced when comparing to the last planning permission No. A/YL-TT/609.
2. The proposed development would benefit the nearby residents within the "V" zone.
3. The proposed development is a temporary use for a period of 3 years which would not jeopardize the long term planning intention of the current zoning.
4. The proposed development is not incompatible with the surrounding environment including residential developments.
5. Similar shop and services were granted with planning permission within "V" zone. Similar preferential treatment should be granted to the current application.
6. Shop and services is a column 2 use in the 'Village Type Development' zone. It is a complementary use to the village houses.
7. Minimal traffic impact.
8. Insignificant environmental and noise impacts because the applied use is housed within an enclosed structure.
9. Insignificant drainage impact because surface U-channel has been provided at the application site.
