1. The application site is intended for warehouse use. The application site is subject to a previous planning permission No. A/YL-TYST/1184 approved for similar use. In view of that the as-built structures at the application site has been amended, a fresh planning application is submitted.
 The electronic goods to be stored at the site includes brand new mobile phones, tablets and computer parts. The application site situates within the 'Category 1 areas' according to Town Planning Board Guidelines for Open Storage and Port Back-up Uses under Section 16 of the Town Planning Ordinance (TPB PG-No. 13G) and the application site is subject to previous planning permissions. The proposed development is a temporary use for a period of 3 years which would not jeopardize the long term
