1. The proposed shop & services situates at “V” zone. It would serve the need of the nearby residents and benefit the local community.
2. Shop and services is a Column 2 use in “V” zone according to the Approved Tong Yan San Tsuen Outline Zoning Plan No. S/YL-TYST/14.
3. The proposed shop & services meets the planning intention of the “V” zone which is to support the local communities.
4. The application site is close to the residential dwellings at Shan Ha Tsuen so that it could serve the daily needs of the neighbourhood.
5. Shop and services is a Column 2 use in “V” zone and “R(D)” zone.
6. The nature, form, scale and layout of the proposed development is compatible with the surrounding environment.
7. The proposed development is a complementary use for the “V” and “R(D)” zone.
8. The proposed development is limited in scale. Having considered its nature and limited size, the impact to the surrounding environment is minimal.
9. The applicant submitted drainage proposal and estimated traffic generation to demonstrate that the proposed development would not generate significant impact to the surrounding environment.
10. The proposed development is not the first of its kind. Similar shop and services (car beauty services) has been approved by Town Planning Board such as A/YL/241.
