Proposed Temporary Shop and Services and Associated Excavation of Land for a Period of 3 Years at Lots 1552, 1553 RP & 1554 RP in D.D.121, Shan Ha Tsuen, Yuen Long, N.T.

The extent of proposed excavation of land within ‘Village Type Development’ (“V”) zone is shown on the updated Figure 5. The area of excavation within ‘Village Type Development’ (“V”) zone has been updated to 18.9m² and the updated page 6 of the S.16-III application form is attached for your further processing of the captioned application.

The application site will be occupied for selling of second hand private car and car beauty services. The applicant was previously operating a car beauty services and selling of second hand private car at the adjoining lots under planning permission No. A/YL-TYST/1219 under the name of Wingly Car Services Co. at Lots 1552 (Part), 1553 (Part) and 1554 RP (Part) in D.D. 121 and Adjoining Government Land, Shan Ha Tsuen, Yuen Long, New Territories. It is noted that part of the site is overlapping with the application site of the current application. Due to the resumption of land by Government, he wishes to relocate his business to the application site. The site area for the planning permission No. A/YL-TYST/1219 was 980m² whereas the site area of the application site of the current application is 1,580m². The application site is the only site available for the applicant to relocate his business at the closest possible to continue to serve the community of Shan Ha Tsuen where his patronage are living. The application site would also meet the operation needs of the proposed development because the site under planning permission No. A/YL-TYST/1219 demonstrated that it is not adequate to serve the use of car beauty services and selling of second hand private car simultaneously.

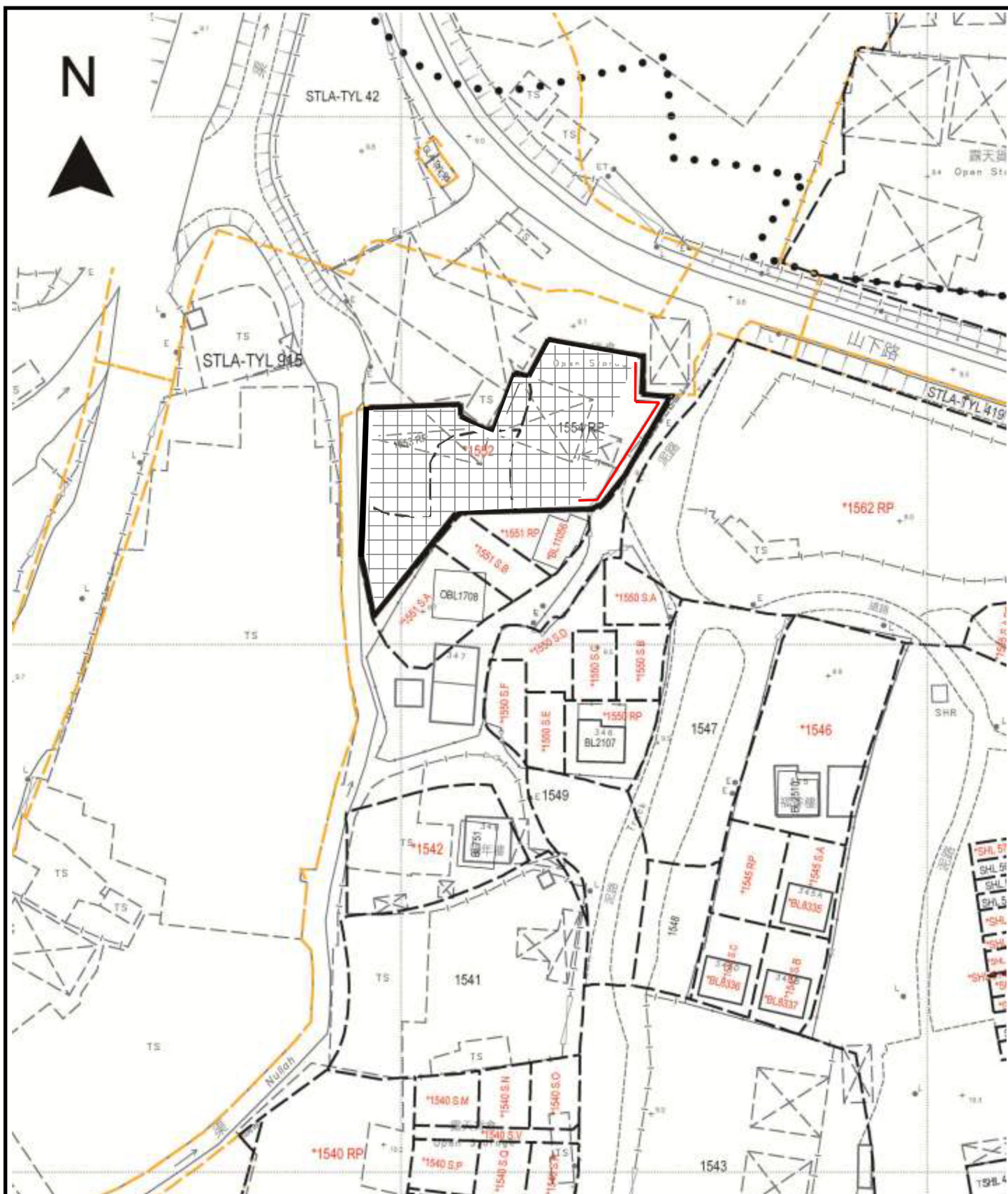
