i) The subject site is accessible from Tong Yan San Tsuen Road (via Sha Tseng Road). Bounded on its N-E side is a 4.5m wide side lane. Across this side lane is a row of 4-storeys residential developments. On the opposite side of the main access road, is an open public car park and 4-storeys residential blocks known as Park Hill (see Photo 1 & 2). So the area is predominantly mid to low rise developments.

ii) Under the current zoning which is R(B)1, the site can be developed to a 4 storeys residential block (under 15m) over single storey car port with maximum site coverage of 40% and plot ratio 1;

iii) Under the current Mother Lease conditions for Lot 1890, the site could only be re-developed into a 2-storeys European type of house with maximum site coverage of 50% and open space minimum of 50% at grade area. The plot ratio is the same i.e. 1 (see App. A – Lease Conditions).

iii) Due to the above planning restrictions, the Owner will be obliged to face a situation that the site couldn't be redeveloped to its full potential and there will be a reduction of GFA by about 20% i.e. from 422 sq m to 338 sq m due to reduction of site coverage by 10%.

iv) To overcome the above “drop” of Gross Floor Area, we would like to seek for the Board's approval on minor relaxation of the current site coverage 40% restriction as imposed on the zoning plan by relaxing to 50% such that the site coverage limitation is tally with the lease conditions.

2) Justifications:

i) The original Lot 1890 with site area 7,599 sq ft (705.96 sq m) was built with one single storey and partly two storey house with coverage area of about 270 sq m (Appendix B). The land was resumed twice by Government

a) along Tong Yan San Tsuen Road about 2,530 sq ft in year 1989;

b) along side lane about 510 sq ft in year 2002.

All land resumed garden area and the lot is now retitled as Lot 1890 RP with site area reduced to about 423.545 sq m. The original house was constructed long before the first OZP published and was found collapsed due to age. The collapsed house was removed several years ago. The Owner of the land / house considered they have the legitimate right of keeping the house with the same site coverage percentage if given the chance of developing the residual site to its full potential.

ii) The proposed building height of the proposed development is a two storey house which is about 7.3m high and the site coverage after relaxation is about 211 sq m. When comparing with the old house (demolished 4 years ago) originally occupying an area of 270 sq m is found much lesser in site coverage (see Survey Plan at App. B). We believe the proposed relaxation will not causing any adverse impact to its immediate neighbouring building owners at 48 Sha Tseng Road and 138 Tong Yan San Tsuen Road either environmentally and visually.

iii) The proposed 2-storeys development will provide a variation of building height along Tong Yan San Tsuen Road and visually more attractive in the streetscape (see Photo 1 and attached GBP as App. C).

iv) The Owner intends to provide tree planting along Tong Yan San Tsuen Road and the side lane along the boundary walls and inner open courtyard. This would mitigate the visual effect when viewing at high level from adjoining properties mentioned above. The overall landscape design will be submitted to PlanD for consideration and approval before works commencement.

v) Under the Building (Planning) Regulations (B(P)R), the site is considered as a Class B site development with allowable site coverage 75% (about 8.4% more than a Class A site) for residential building under 15 m. Under this circumstance, our request for 50% site coverage is still well below that permitted under B(P)R.
