7. Justifications 理由

To meet the demand for driving school facilities, the Town Planning Board (TPB) approved the establishment of a temporary driving school (Ankor Driving School) in April 2021 (Application No. A/YL-TYST/1084) and October 2023 (Application No. A/YL-TYST/1237). The school commenced operations in November 2025.

To avoid causing any disruptions to the driving training/ test services arrangement, Transport Department has requested Ankor Driving School to renew the operation approval in advance. Letters from Transport Department is attached with the application.

The current proposal is largely consistent with the previous approvals, with the following adjustment:

1. Premises size reduced from 3,816 sq.m to 2,945.3 sq.m due to the Yuen Long South re-Development and land resumption. Updated site boundary and layout are provided in the attached location and layout plan.

2. The Traffic Impact Assessment (TIA) has been updated to reflect the latest traffic generation estimates, traffic count surveys, existing traffic conditions, and future traffic projections. Operational arrangements, including driving routes and training periods, remain unchanged.

The school would like to request for an extension of external training hours. Currently, weekday daytime training is restricted to 10:00am – 12:00pm, which limits learners' ability to gain practical experience under typical traffic conditions. The proposed extension of external operations will allow more learners to practice during normal traffic periods, while remaining fully compliant with the Transport Department's Mandate.

A stress test has been conducted to confirm that the proposed extension will not result in over-capacity or adverse traffic impacts. Full details are provided in the updated TIA report.

3. Partial use of gasoline vehicles as training vehicles. This is necessary because
