
1. The application site is subject to previous planning permission and it is "Category 1" area so that sympathetic consideration should be given according to Town Planning Board Guidelines for Open Storage and Port Back-up Uses under Section 16 of the Town Planning Ordinance (TPB PG-No. 13G).
2. There was a change of ownership of the application site so that the applicant cannot implement the drainage and FSI proposal accordingly. The applicant obtained the mutual understanding of another owner to implement now.
3. The application site is subject to a previous planning permission, i.e. A/YL-TYST/1021 & 1185. The applied use of the current application is the same as the approved use of the last planning permission.
4. The proposed development is a temporary use for a period of 3 years which would not jeopardize the long term planning intention of the current zoning.
5. The proposed development is not incompatible with the surrounding environment including open storage use and warehouse use.
6. Open storage & warehouse uses adjoining the application site were granted with planning permission. Similar preferential treatment should be granted to the current application.
