
1. In view of that additional structure is proposed, a fresh planning application is submitted for the consideration of the Town Planning Board.
2. The application site subjects to five planning permissions since 2011 for similar open storage use.
3. The proposed development conforms to the Town Planning Board Guidelines for Application for Open Storage and Port Back-up Uses (TPB PG-NO. 13G) because the site is subject to previous planning permissions and it is Category 1<sup>st</sup> area.
4. The proposed development is a temporary use for a period of 3 years which would not jeopardize the long term planning intention of the current zoning.
5. The proposed development is not incompatible with the surrounding environment including open storage use and port back-up activities.
6. Open storage & port back-up uses adjoining the application site were granted with planning permission. Similar preferential treatment should be granted to the current application.
7. Significant portion of the site is being occupied for open storage use. The ancillary workshop occupies a minor portion of the site and covered by structures. No workshop activities will be carried out at uncovered area.
