The Guidelines are available at the above locations, the Secretariat of the Board as well as the Board's website.

In accordance with sections 12A(14)(c) and 12A(12) of the pre-amended Ordinance, any comment made to the Board will be available for public inspection during normal office hours at locations (i) and (ii) above until the Board has considered the application in question under section 12A(16) of the pre-amended Ordinance.

The meeting for considering planning applications, except the deliberation parts, will be open to the public.
