5.1	Noting that total 670 existing trees are proposed to be felled but only 272 new trees are proposed within the Site, the compensation ratio of 1:0.4 is below the 1:1 level. Please explore tree planting opportunities, in particular roadside at-grade tree planting along the planters adjacent to Chung Mun Road, to mitigate the loss of trees due to the development. Justification should be provided if 1:1 compensation ratio cannot be met.	Our landscape master planning will base on the concept of maximizing new tree planting opportunity without compromising long-term tree health, safety and maintainability. Tree planting will be provided: • at ground level (e.g. along internal driveways and at recreational open spaces) • at podium level (e.g. at sitting gardens) • at perimeter for buffering (e.g. interfacing with the adjacent, future DSD flood attenuation pond outside the Application Site) • along Chung Mun Road for ensuring roadside greenery interfacing with the general public while not hindering traffic requirements such as sightlines A total of 338 nos. new trees in suitable spacing depending on species will be planted within the Application Site [See attached revised Landscape Master Plan (identical to the one submitted to the Board on 21.3.2025 and herewith attach again for easy reference)]. (Note: Among the 670 nos. existing trees, 615 nos. are fruit crops cultivated on agricultural land. With or without the current Application, these crops may be harvested, removed or replaced with other crops (e.g. Chinese New Year's Cherry Trees or even vegetables) from time to time under standard agricultural practices. These fruit crops have been planted in an exceptionally overcrowded manner, causing them to have potential long-term health and/ or structural issues). Only 55 nos. existing trees are not fruit crops and are considered as relevant. Our landscape master planning for new trees does not utilize the concept of tree compensation ratio.)
