

Relevant indicative rezoning scheme drawings (i.e. **Figures 14a, 15a, 17a-19a, 22a and 24a**) as attached in **Annex J**, and relevant Replacement Pages of the Planning Statement (i.e. **pages 1, 2, 9-12 and 15-16**), as attached in **Annex K** have been revised and are included in this FI Submission.
