



EXECUTIVE SUMMARY

The Application Premises ("the Premises") is a Portion of Workshop 2, G/F, Poly Centre, No. 15 Yip Fung Street, On Lok Tsuen, Fanling, New Territories (Lot No. 5347 in D.D. 51). It is located at about 160m northeast of Fanling Hong Lok Park. It is proposed to apply for the use of "Dangerous Goods Godown (Storage of Refrigerant)" at the Premises. The Premises has a total floor area of about 281.826m² with a volume of about 1,231.58m³.

In accordance with the Approved Fanling/Sheung Shui Outline Zoning Plan (OZP) No. S/FSS/26 gazetted on 16.12.2022, the Premises falls within an area zoned "Industrial" ("I") in which "Dangerous Goods Godown" is a column 2 use. Therefore, a planning permission from the Town Planning Board ("the Board") is required.

The subject application is justified on the following grounds: 1) In Line with Planning Intention of "Industrial" Zone; 2) Planning Permissions for "Dangerous Goods Godown" Use near the Premises; 3) Compatible with Surrounding Land Uses; 4) No Usage of Dangerous Goods within the Premises; 5) Provision of Appropriate Fire Precaution Measures; 6) No Adverse Traffic Impact; 7) No Adverse Environmental Impact; and 8) Holding Licensed Vehicles for Transporting Dangerous Goods.






