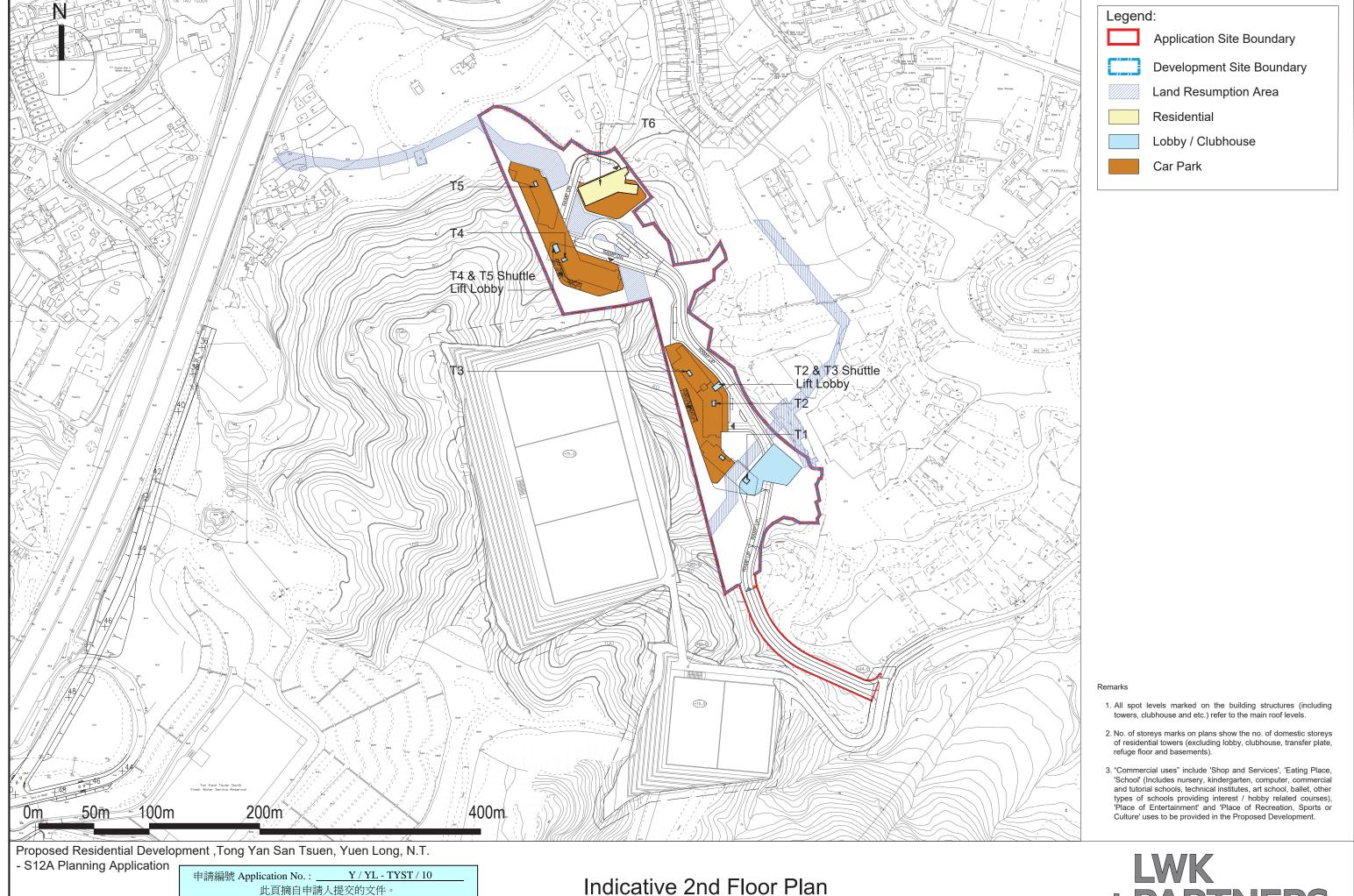
Indicative Ground Floor Plan

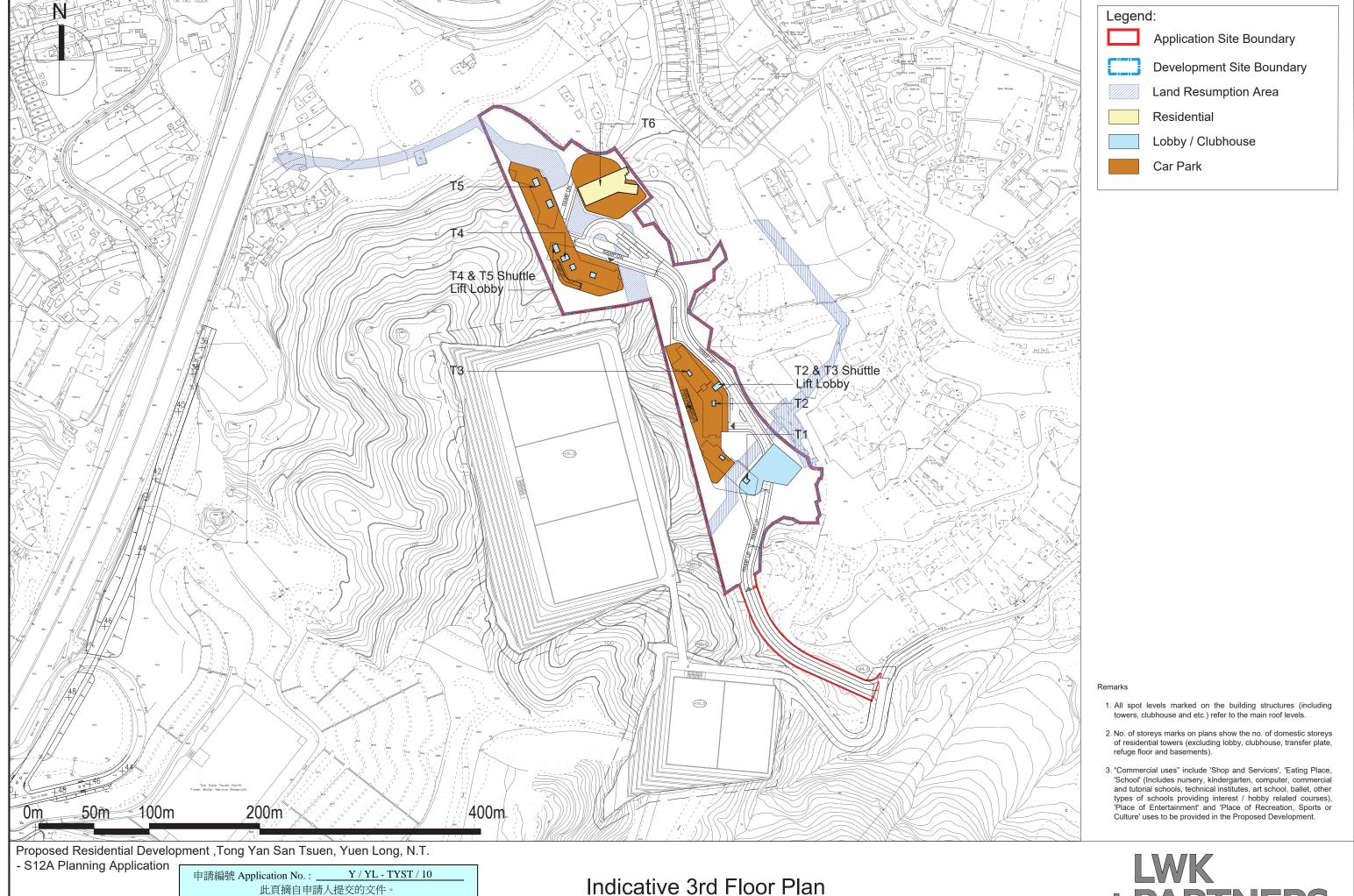

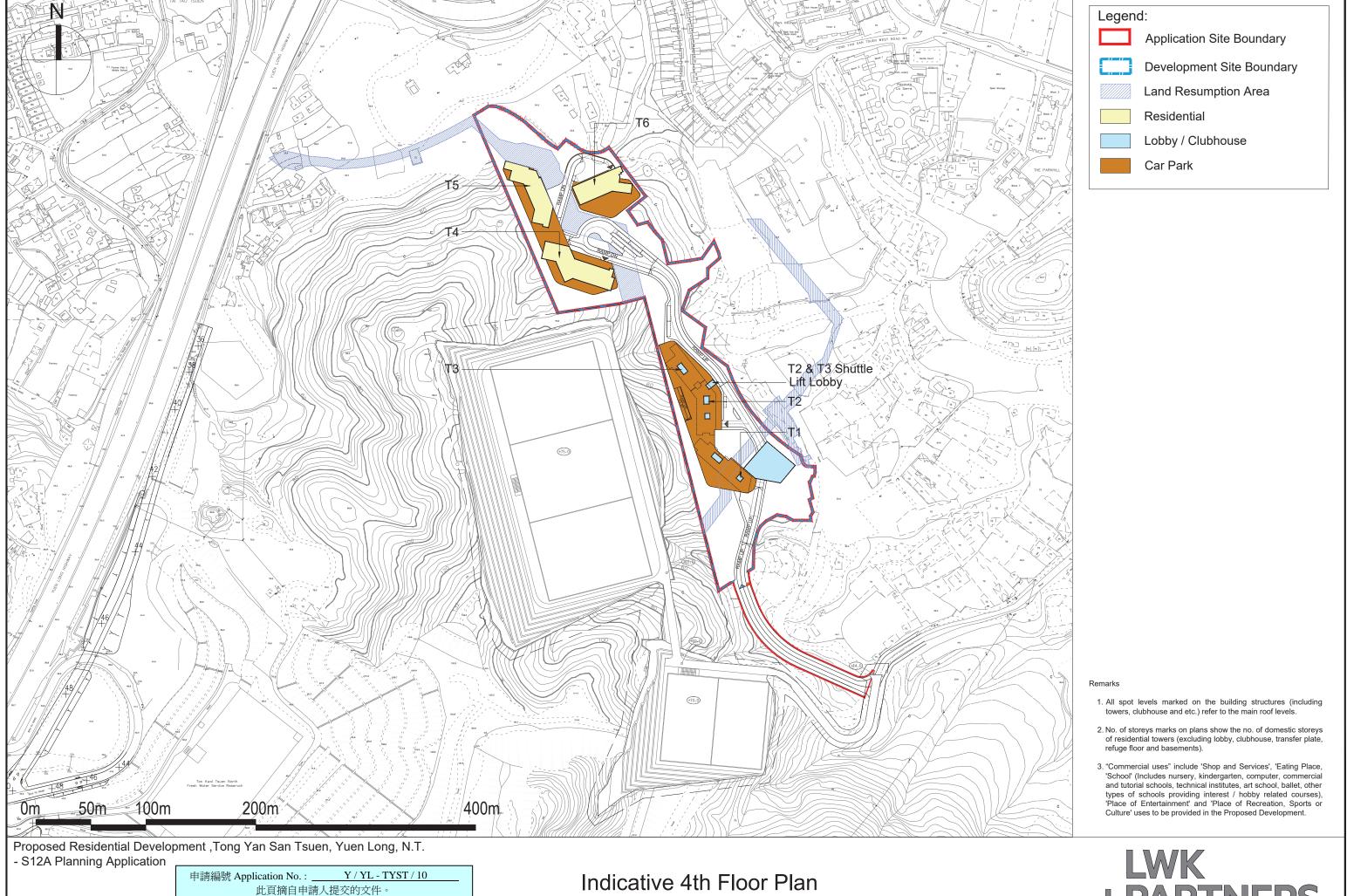

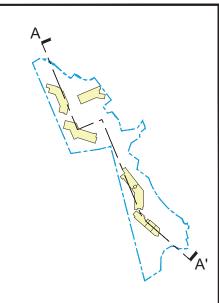
Indicative 4th Floor Plan

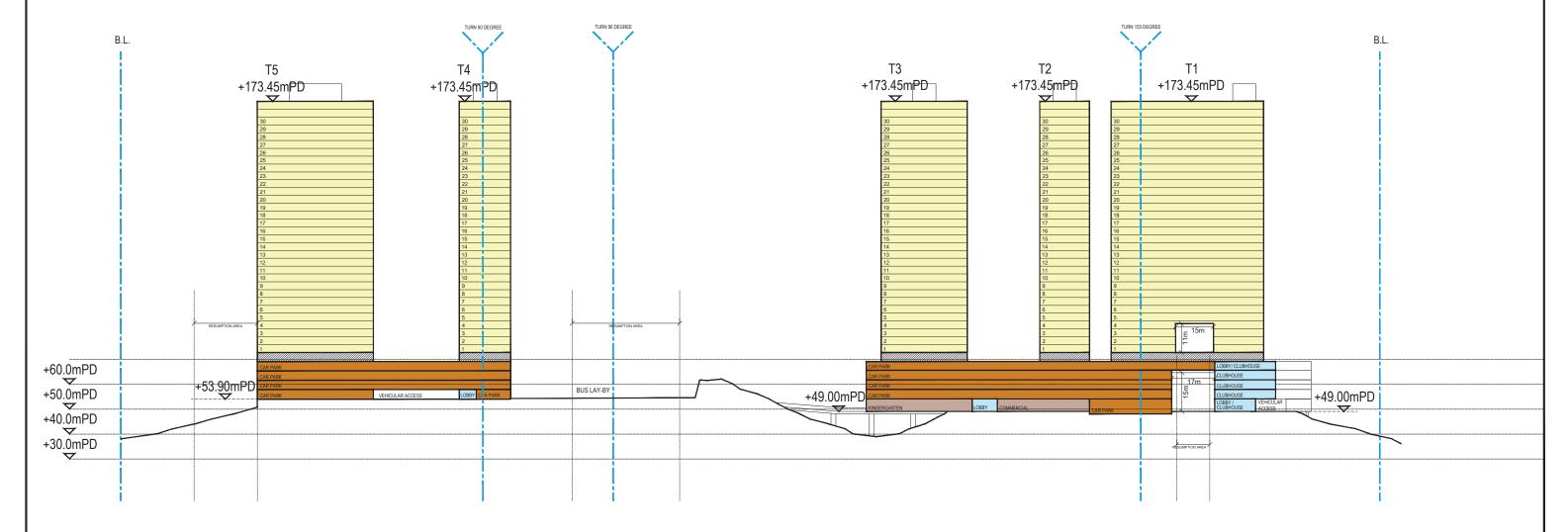

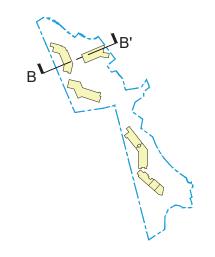

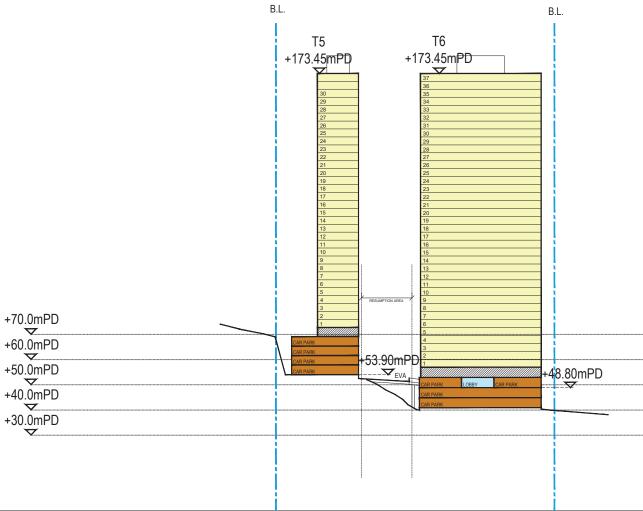
