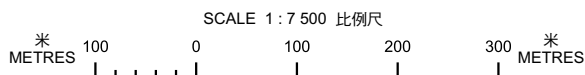

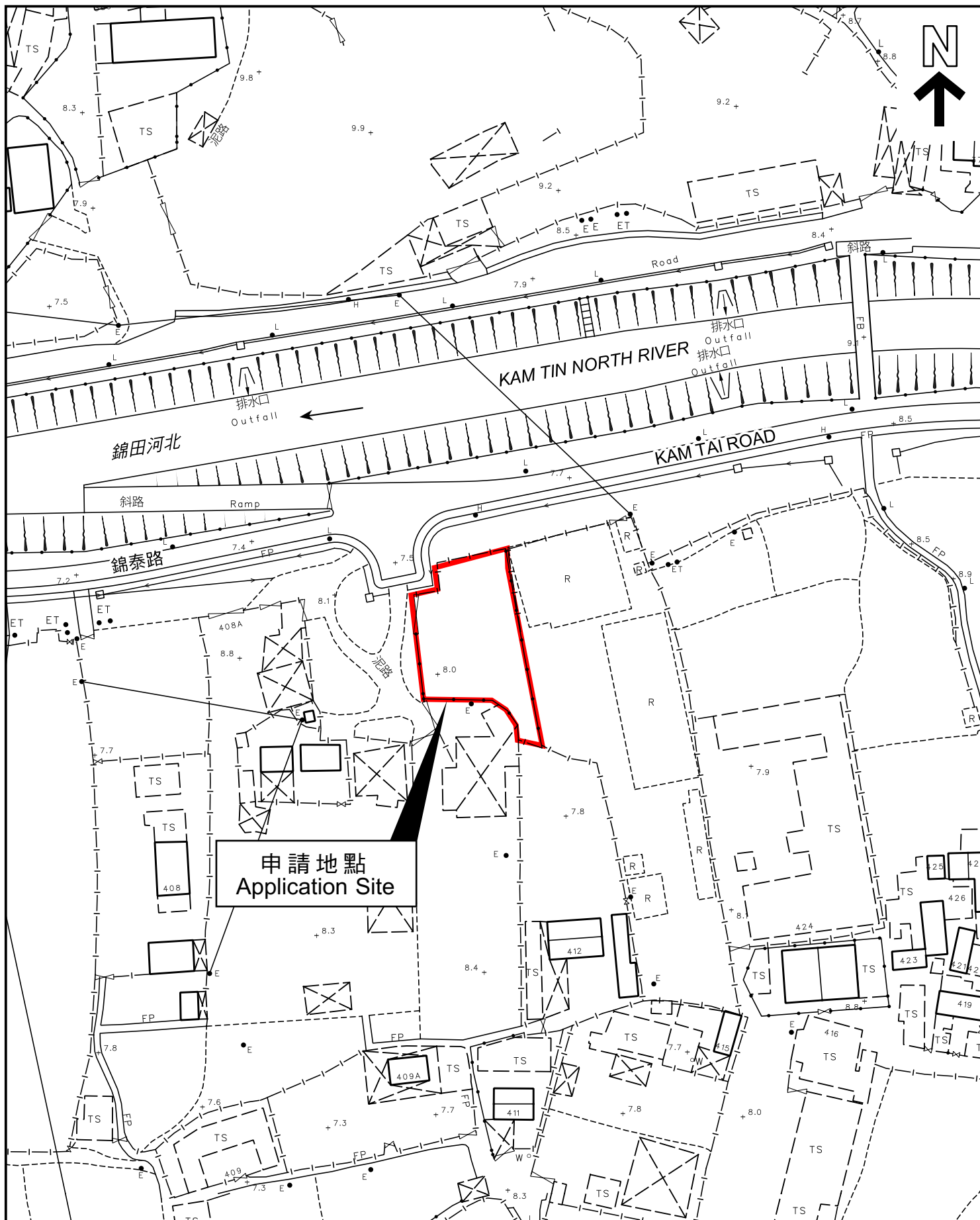
## 位置圖 LOCATION PLAN
