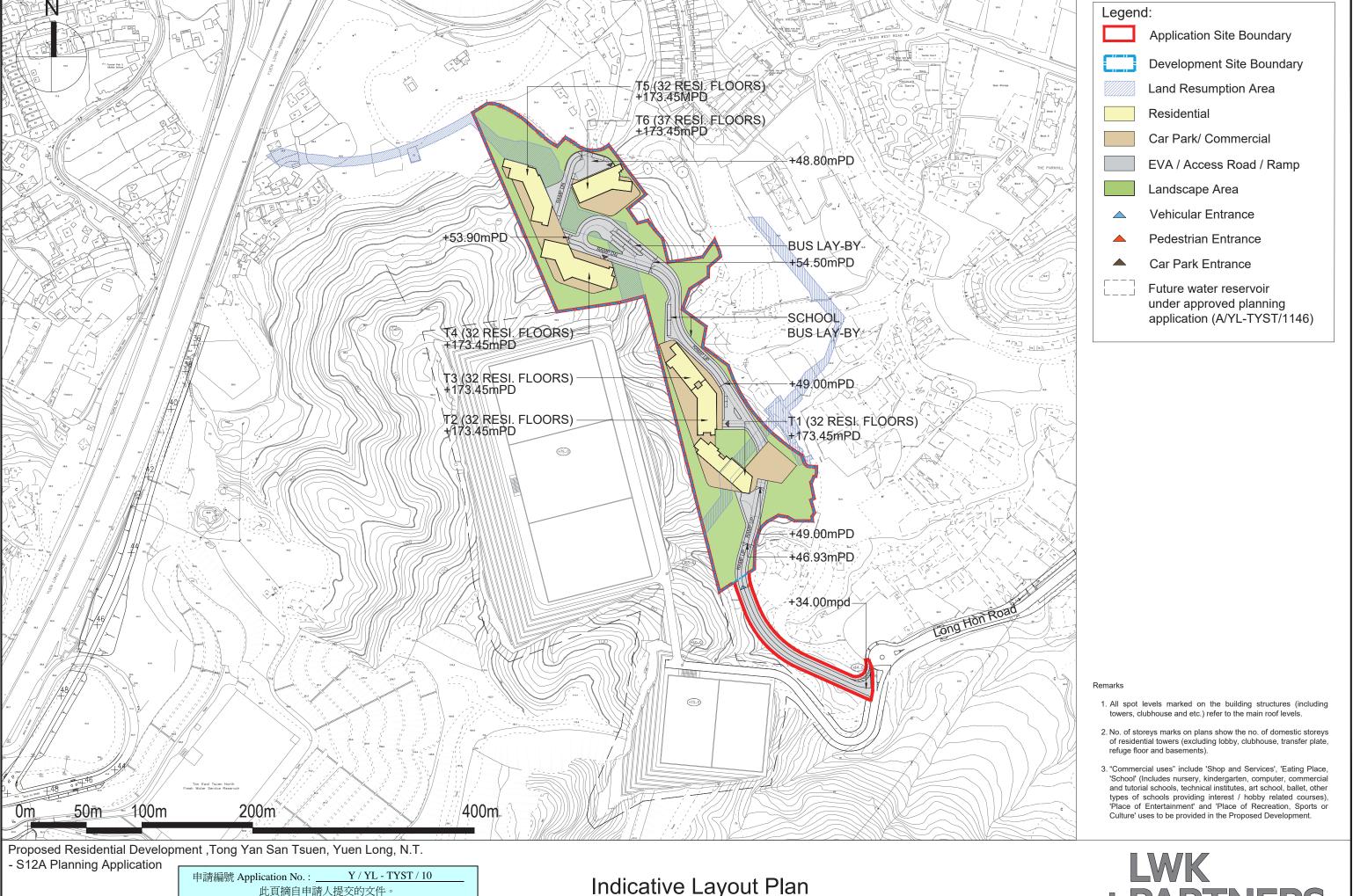

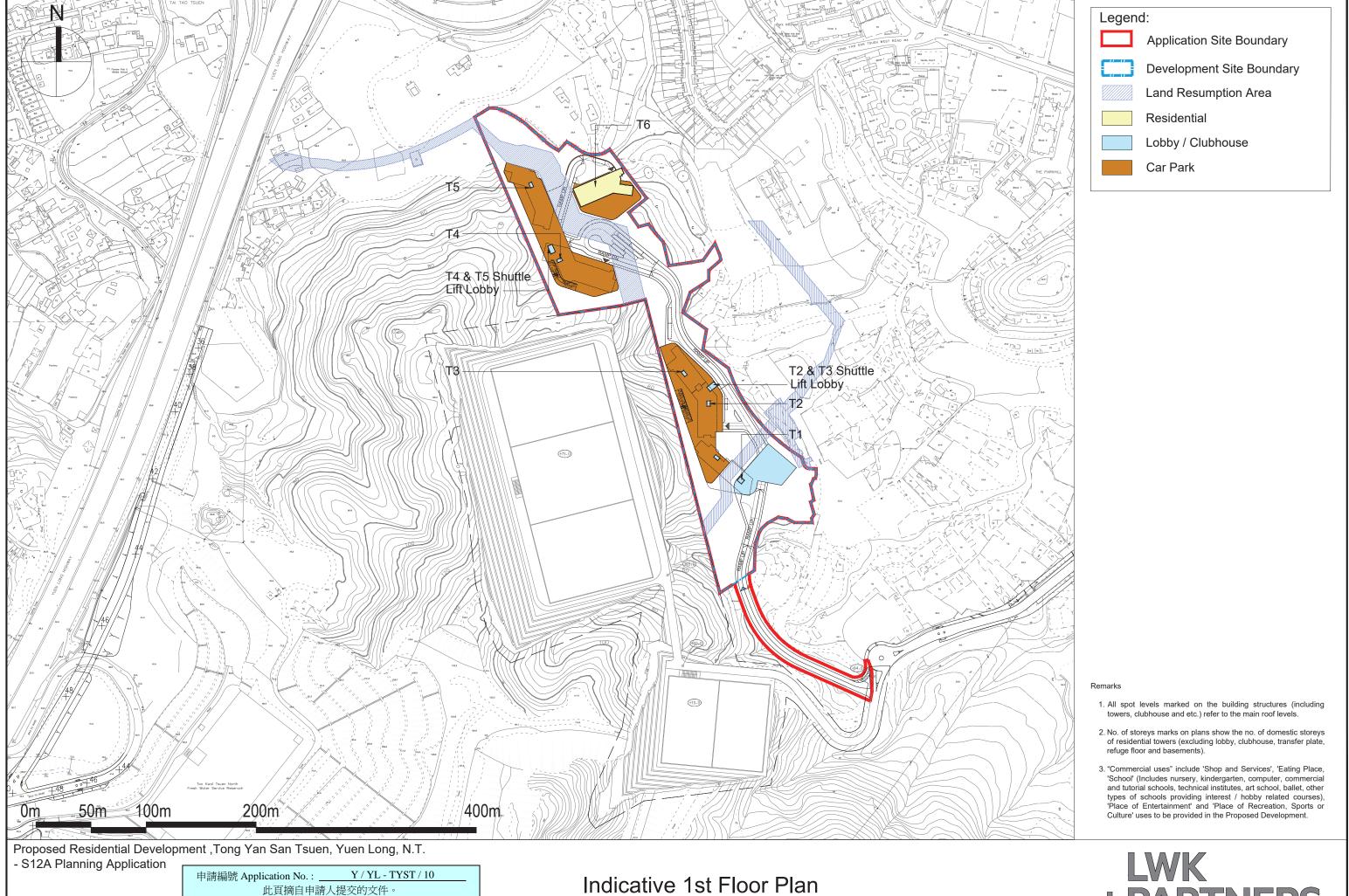

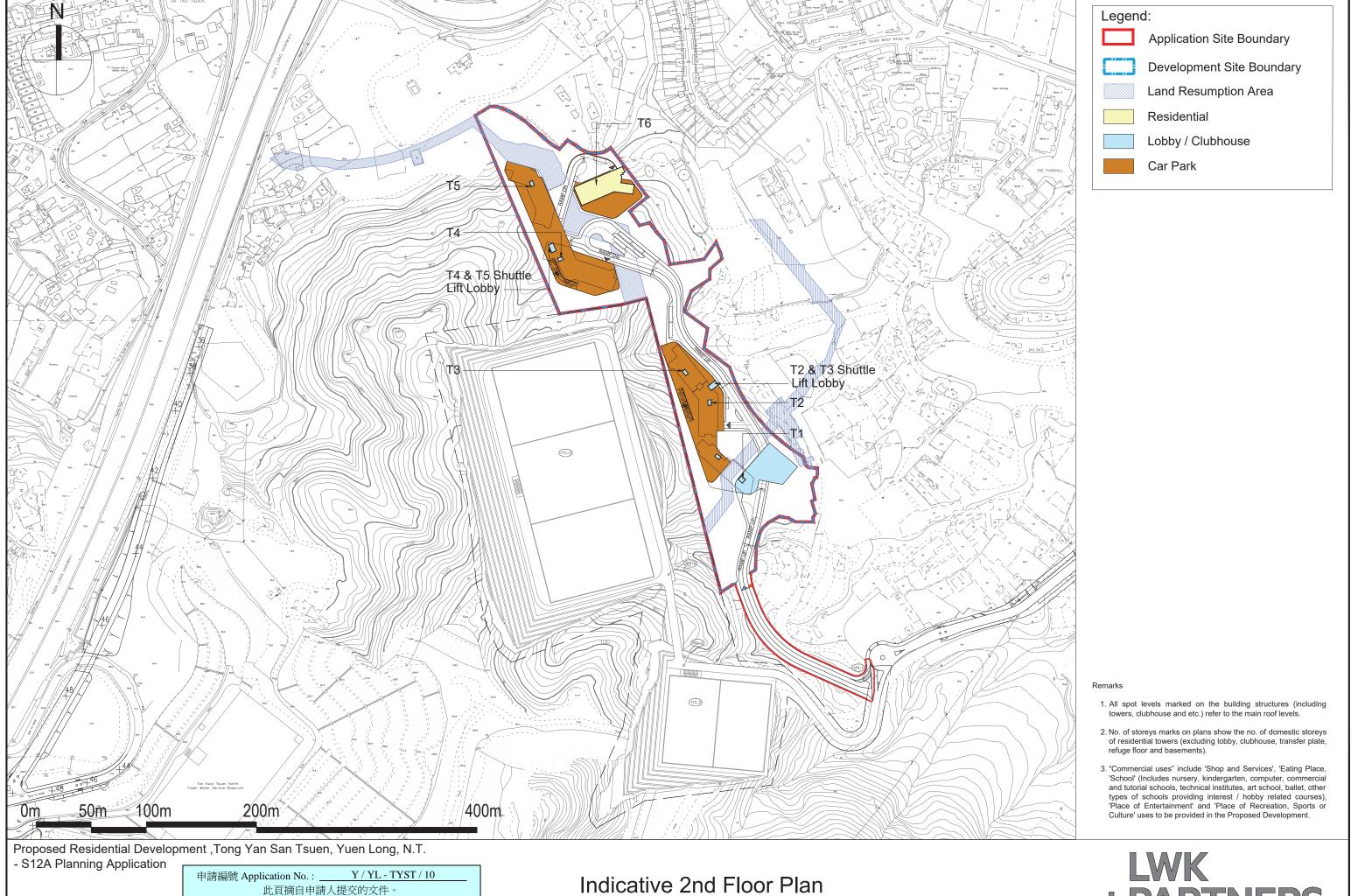

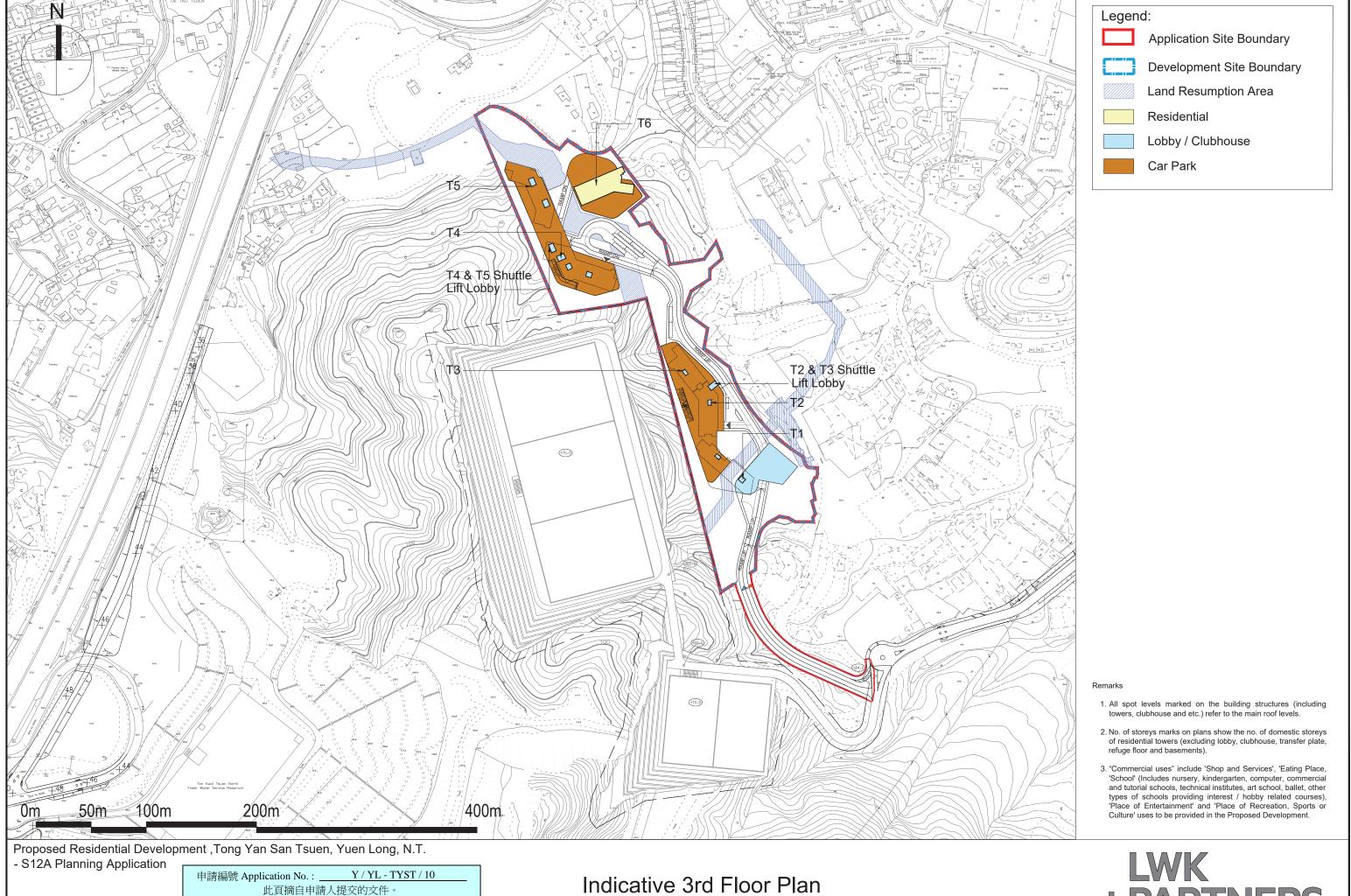

Indicative 2nd Floor Plan

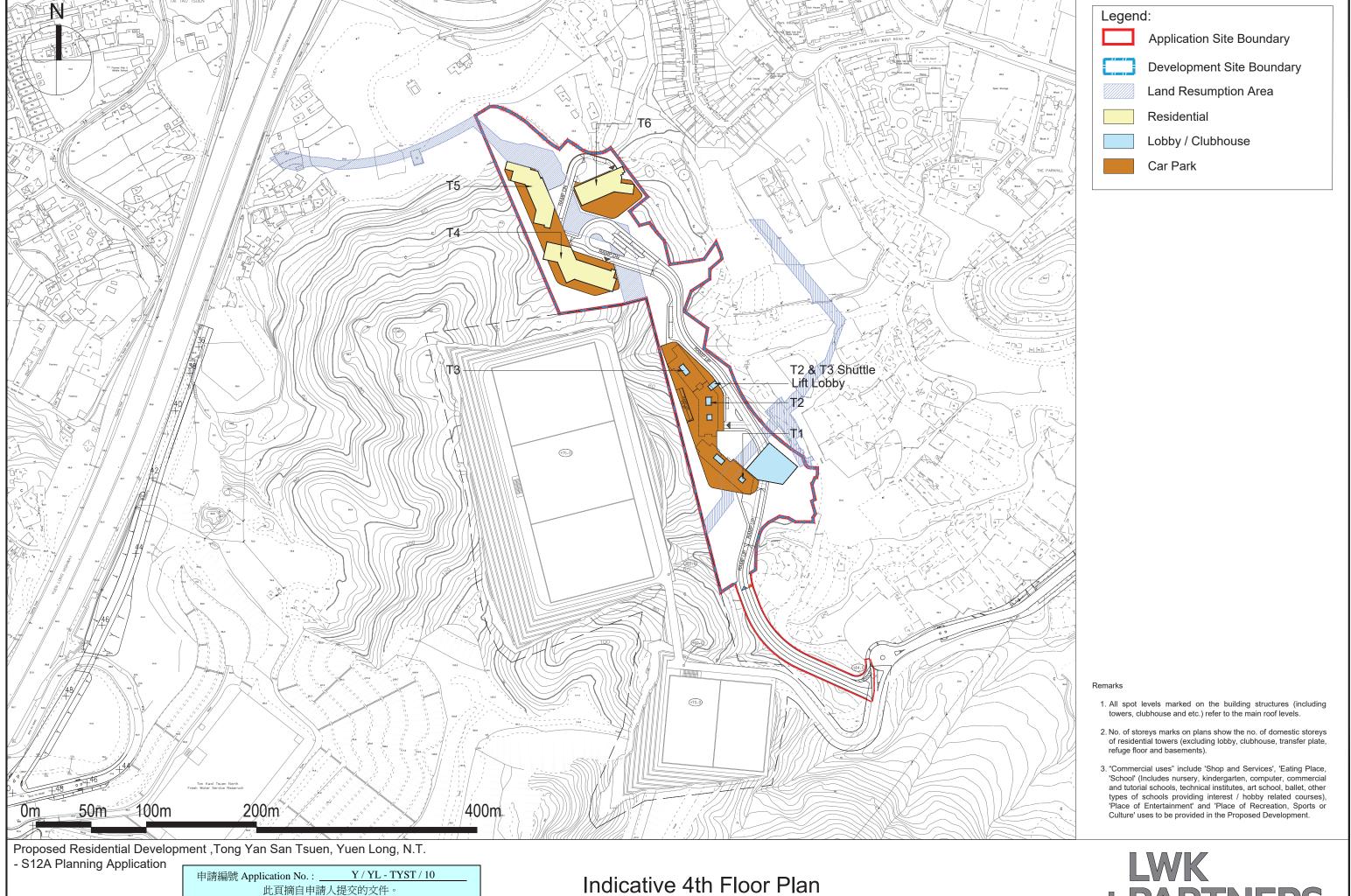

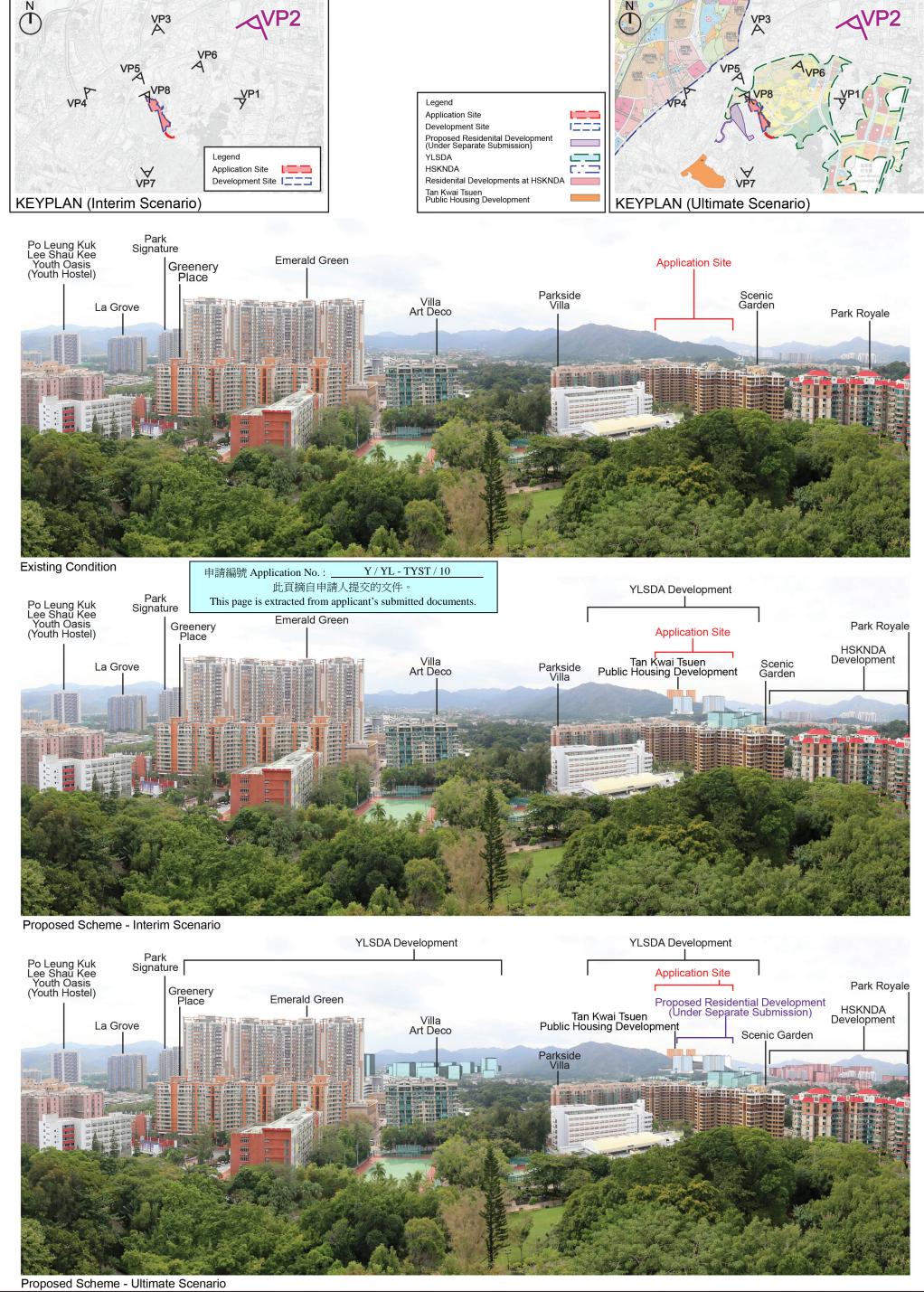


Indicative 4th Floor Plan
