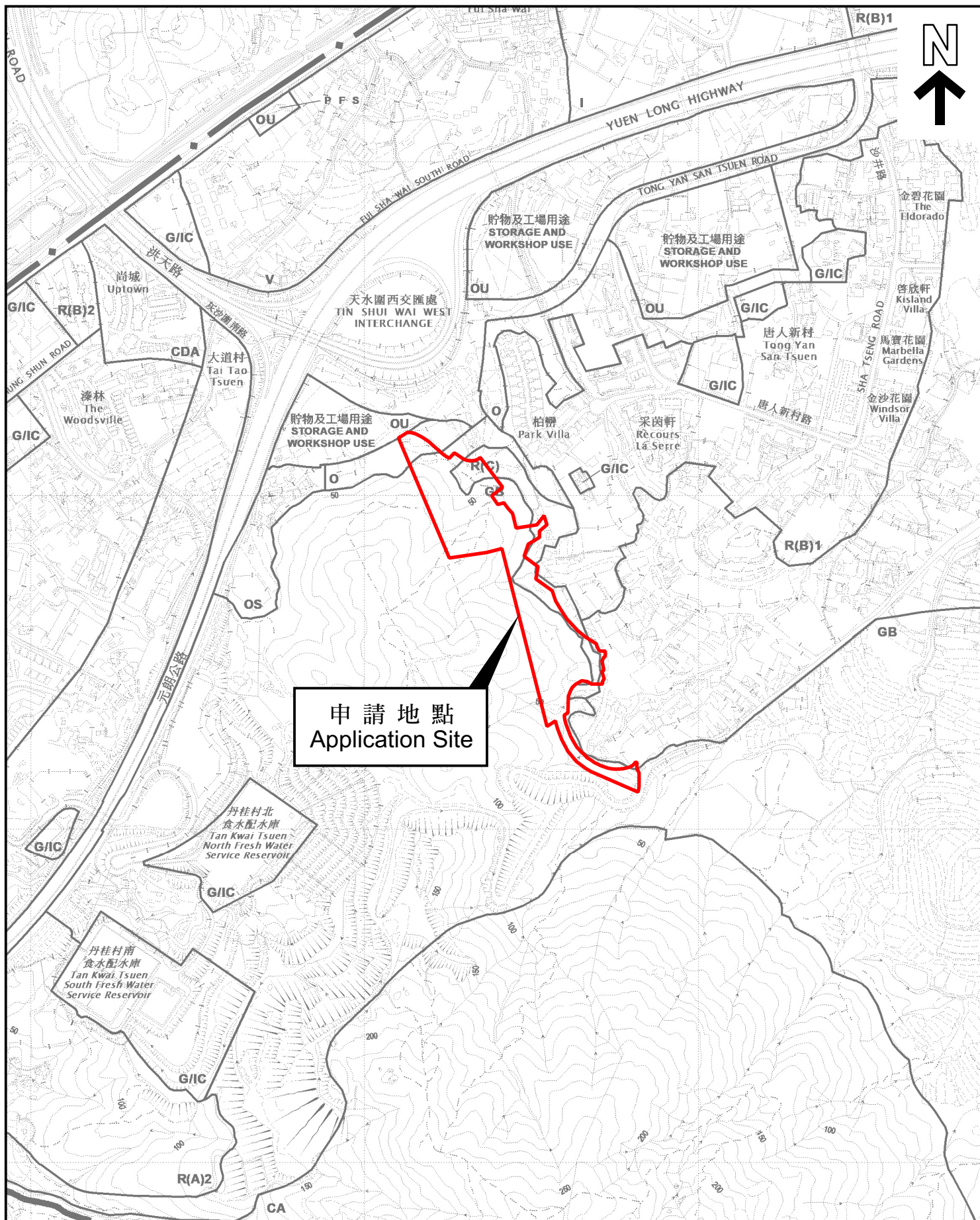

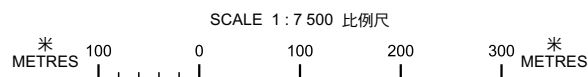

位置圖 LOCATION PLAN

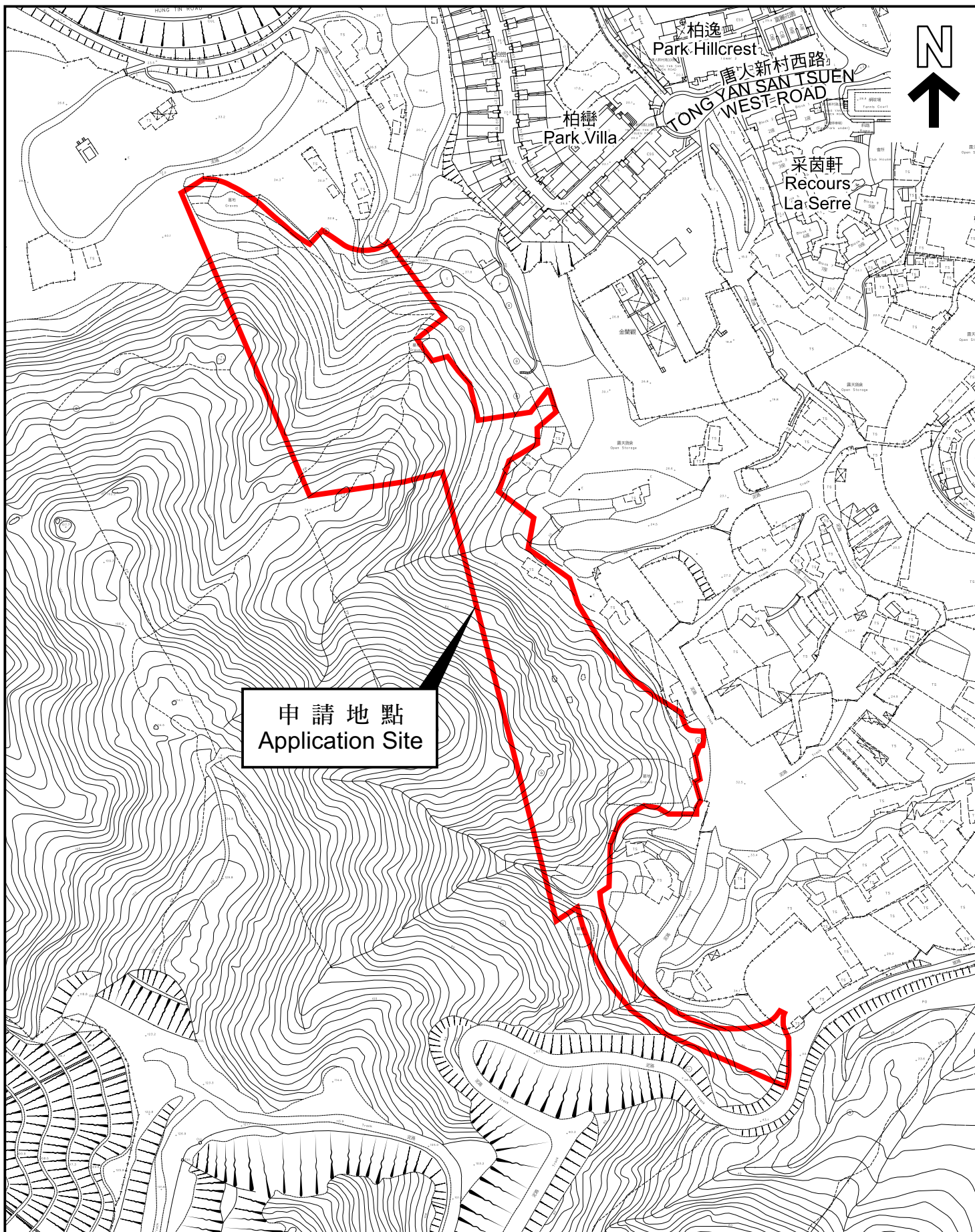

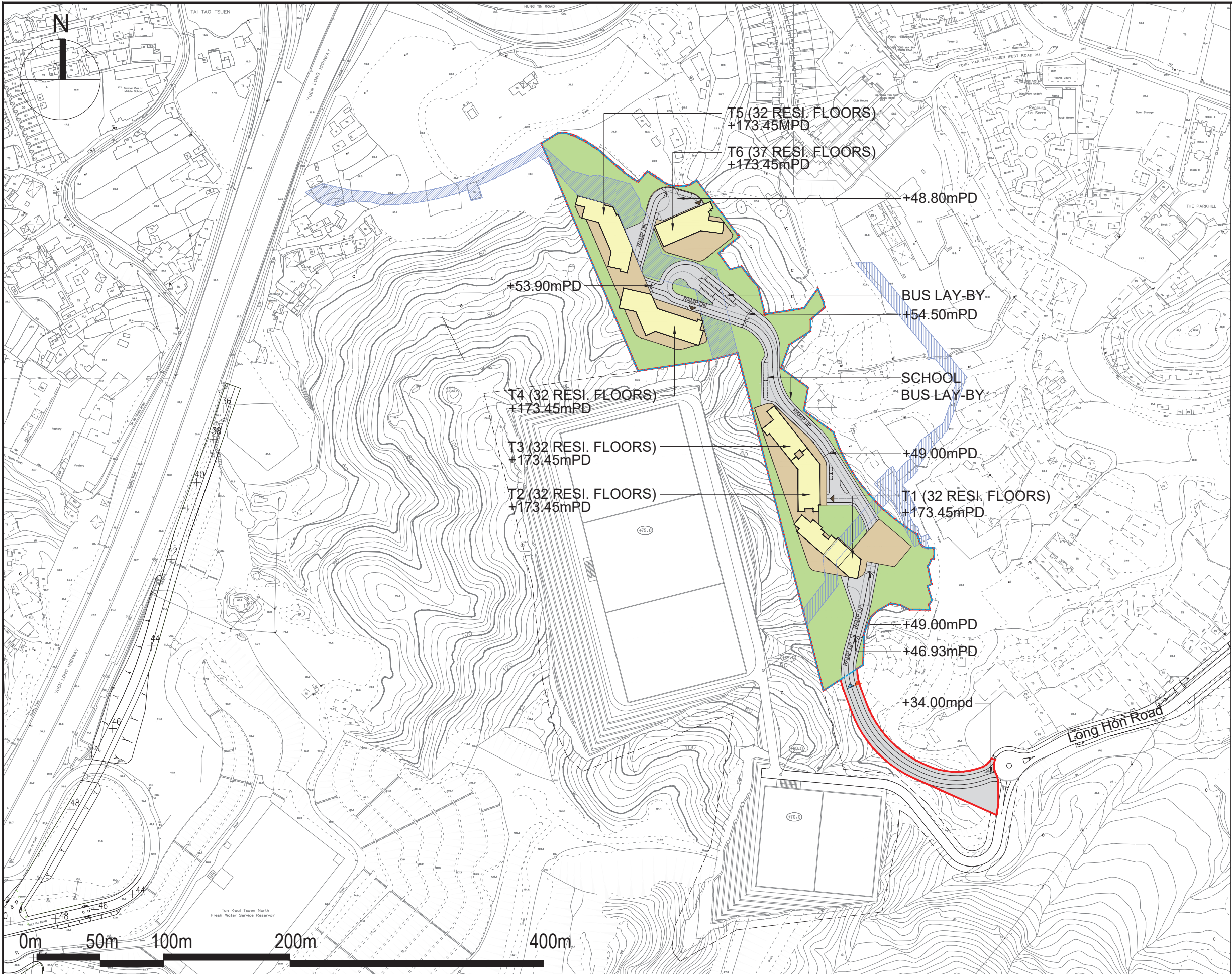

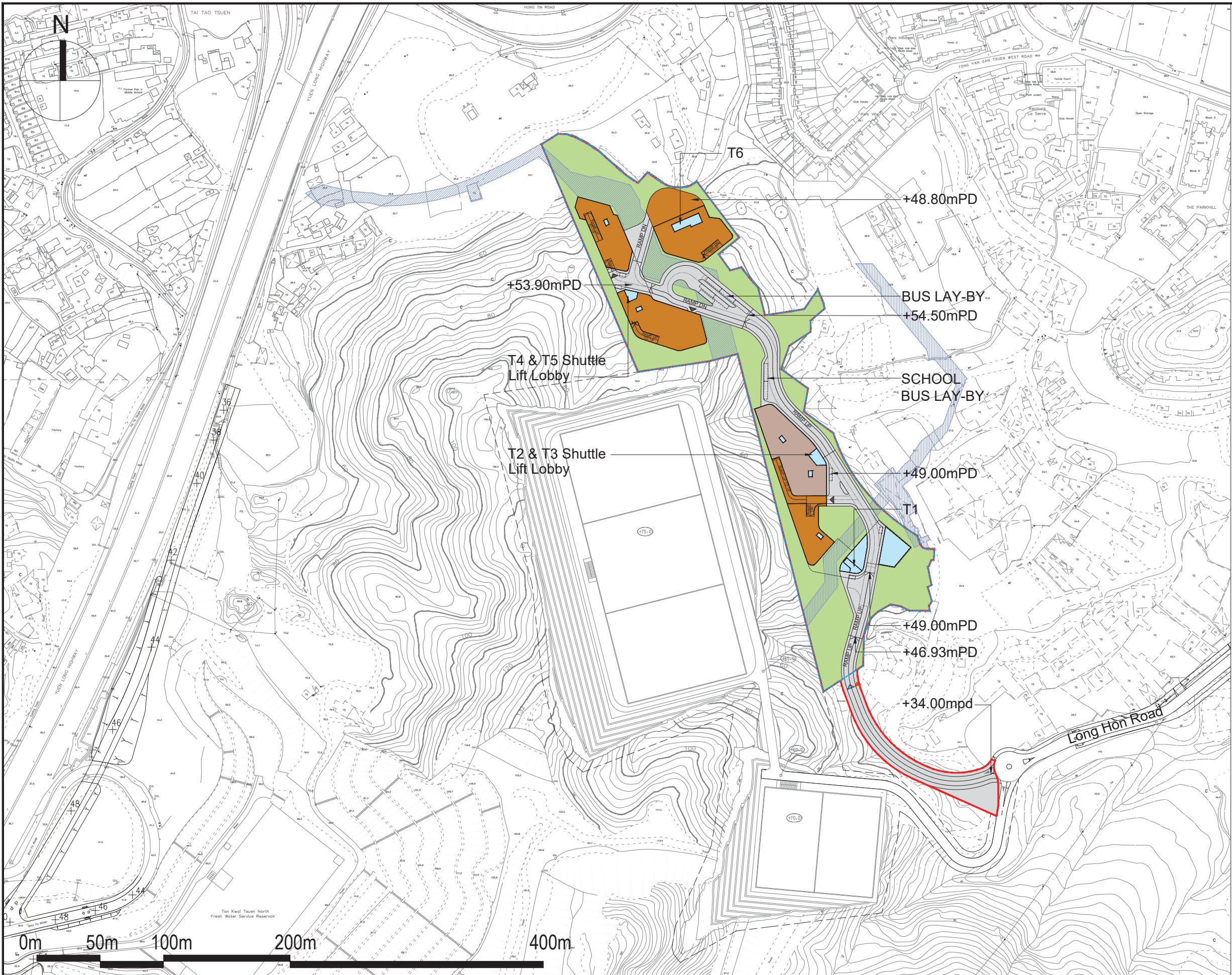

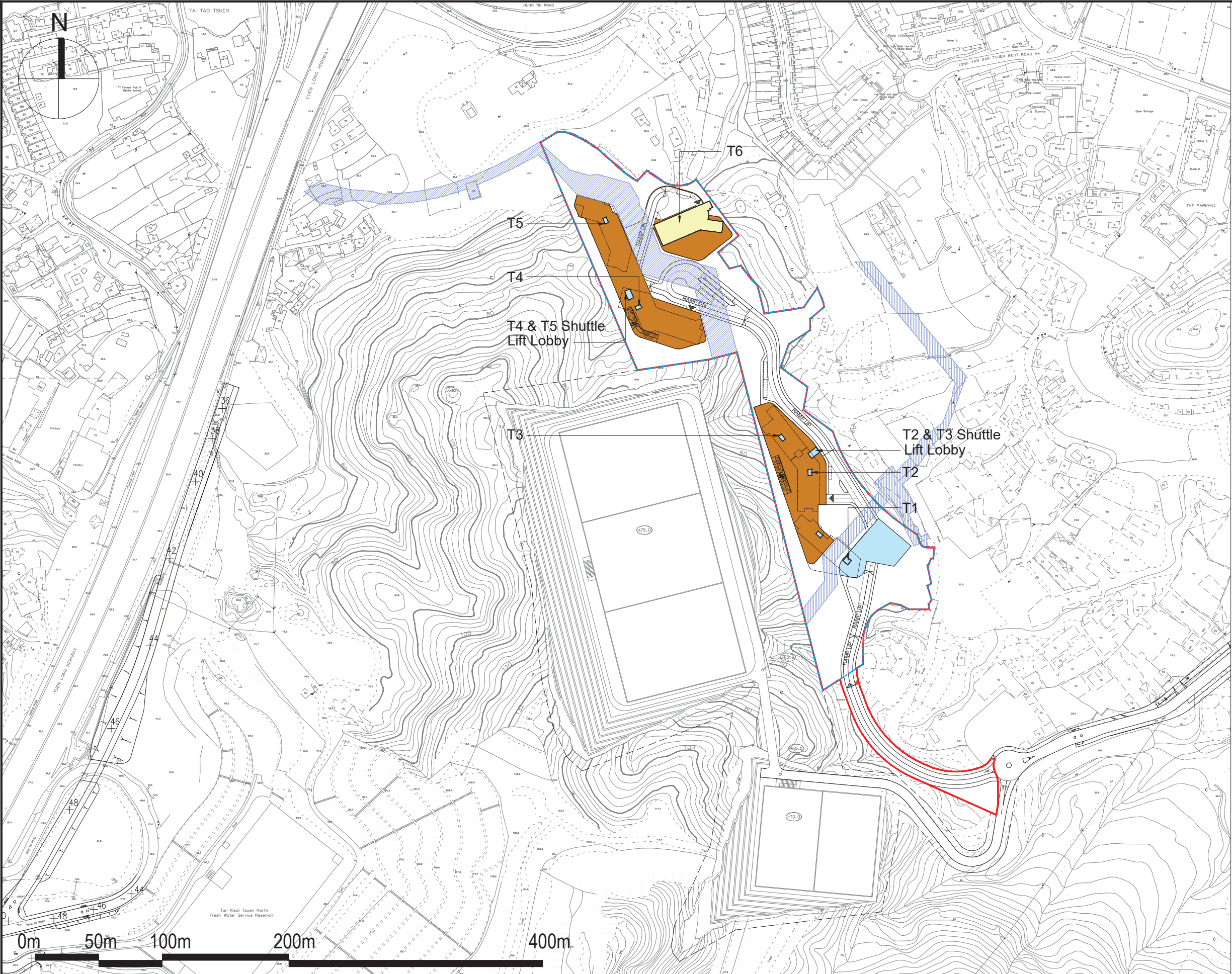

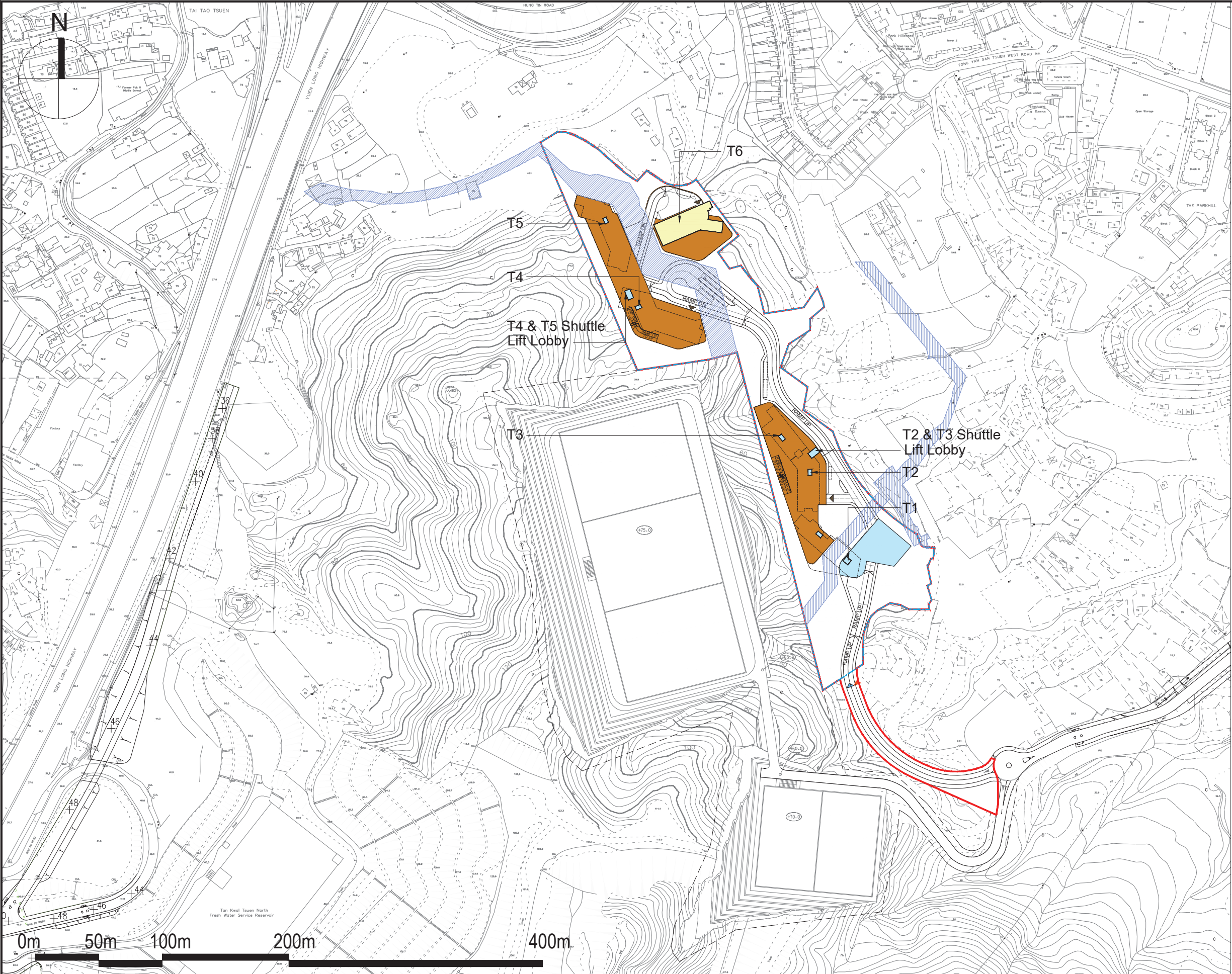

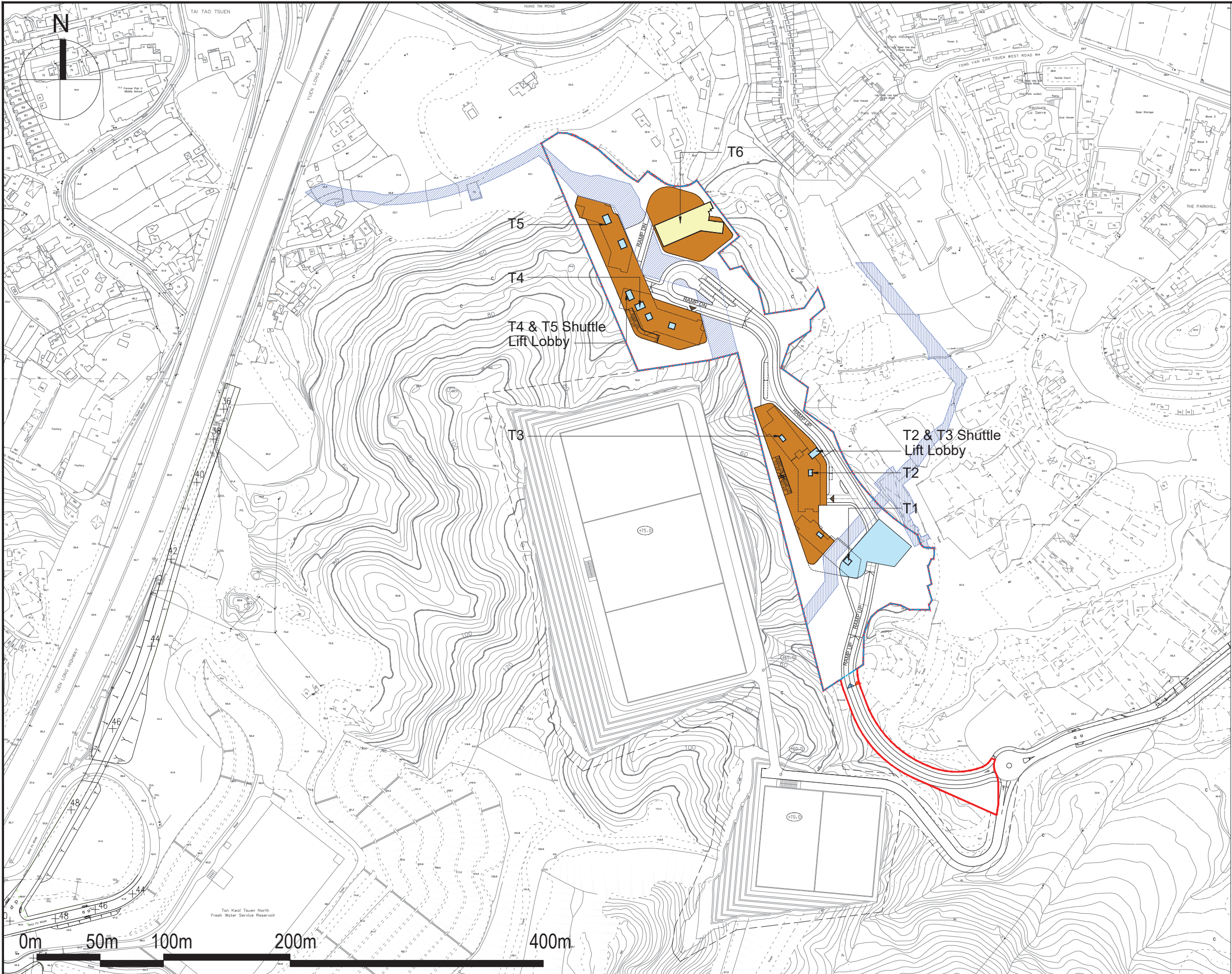

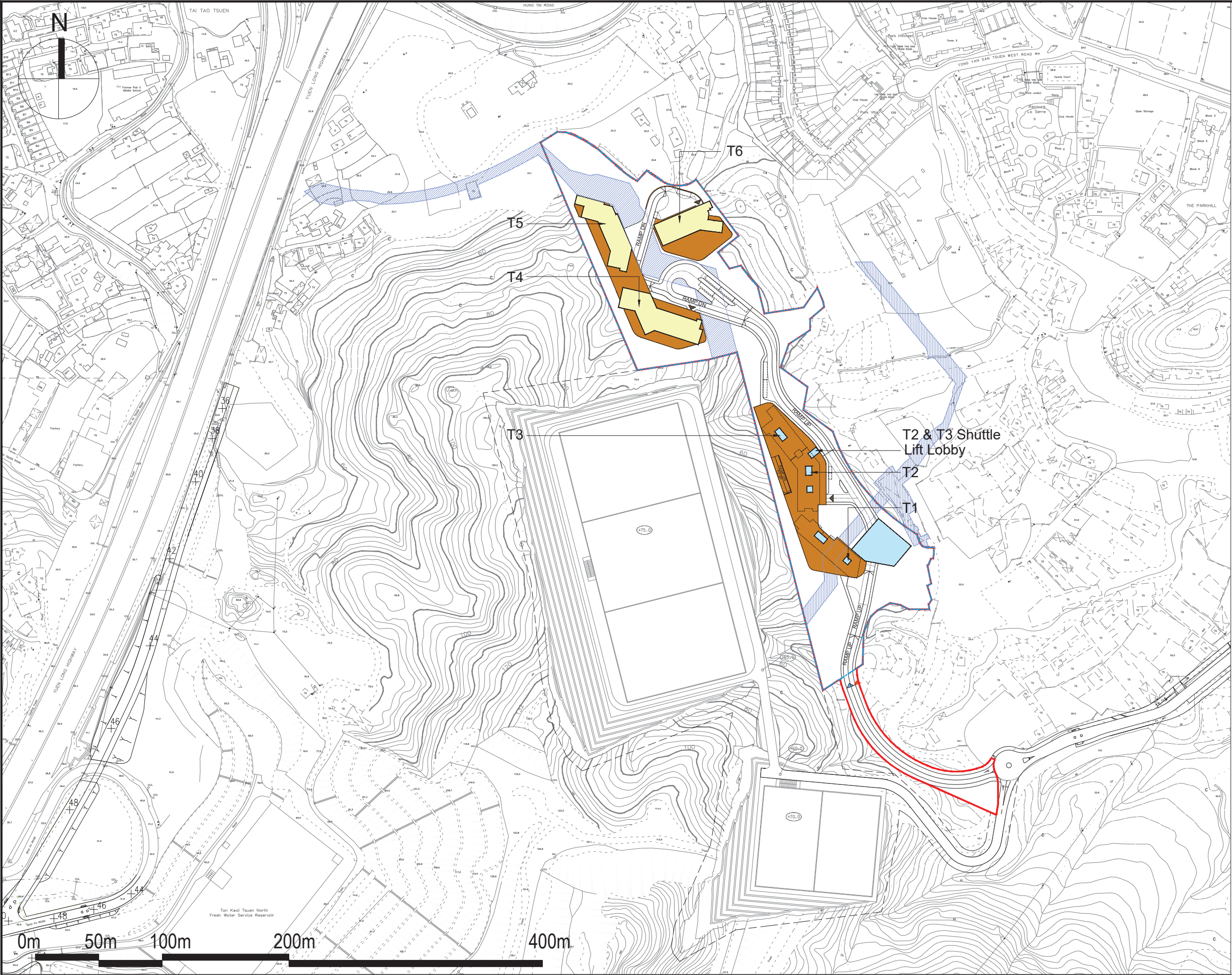
