

BASEMENT PLAN SK-5 22 SEPTEMBER 2023



GROUND FLOOR PLAN (BLOCK 1 & 2) SK-6 25 SEPTEMBER 2023




GROUND FLOOR PLAN (BLOCK 3 & RCHE) SK-7 25 SEPTEMBER 2023

TYPICAL FLOOR PLAN (BLOCK 1 & 2) SK-11 22 SEPTEMBER 2023



TYPICAL FLOOR PLAN (BLOCK 3) SK-12 22 SEPTEMBER 2023





26/F PLAN (BLOCK 1 & 2) SK-13 22 SEPTEMBER 2023




VP1: View from Tsing Yi Northeast Park






