# **Executive Summary**

- 1. The application site (the Site) is on Lot Nos. 176 (Part) and 179 RP (Part) in D.D. 110, Yuen Long, New Territories.
- 2. The site area is about 1,518 m<sup>2</sup>. No Government Land is involved.
- 3. The Site falls within an area zoned "Agriculture" ("AGR") on the Approved Kam Tin North Outline Zoning Plan (OZP) No. S/YL-KTN/11.
- 4. The applied use is 'Proposed Temporary Public Vehicle Park (Excluding Container Vehicles) and associated Filling of Land and Pond' for a Period of 3 Years. According to the covering Notes of the OZP, temporary use or development of any land or building not exceeding a period of 3 years requires planning permission from the Board, notwithstanding that the use or development is not provided for in terms of the OZP.
- 5. A total of 53 nos. of parking space for private cars and light goods vehicles are proposed at the Site.
- 6. Operation hours are 24-hours daily (including Sundays and public holidays).
- 7. Potential adverse impacts on drainage, traffic, fire safety and environment to the surrounding area arising from the applied use are not anticipated.

# **Planning Statement**

#### Introduction

1. This Planning Statement is submitted to the Town Planning Board ("the Board") on behalf of ZHANG Mingzhao ("the Applicant") in support of the planning application for a 'Proposed Temporary Public Vehicle Park (Excluding Container Vehicles) and associated Filling of Land and Pond for a period of 3 years' ("the Proposed Development") at Lot Nos. 176 (Part) and 179 RP (Part) in D.D. 110, Yuen Long, New Territories ("the Site") under Section 16 of the Town Planning Ordinance.

## **Application Site (Plans 1 and 2)**

- 2. The Site comprises Lot Nos. 176 (Part) and 179 RP (Part) in D.D. 110, Yuen Long, New Territories. The Site is accessible from Kong Po Road via a local track leading to the ingress to its east.
- 3. The site area is about 1,518 m<sup>2</sup>. No Government Land is involved.

## **Planning Context**

- 4. The Site falls within an area zoned "Agriculture" ("AGR") on the Approved Kam Tin North Outline Zoning Plan (the "OZP") No. S/YL-KTN/11.
- 5. The planning intention of the "AGR" zone is primarily to retain and safeguard good quality agricultural land/farm/fish ponds for agricultural purposes. It is also intended to retain fallow arable land with good potential for rehabilitation for cultivation and other agricultural purposes.
- 6. According to the covering Notes of the OZP, temporary use or development of any land or building not exceeding a period of 3 years requires planning permission from the Board, notwithstanding that the use or development is not provided for in terms of the OZP. Besides, any filling of land and pond within the "AGR" zone shall not be undertaken without the permission from the Board.
- 7. Given that no structures will be erected in the Proposed Development, approval of the application on a temporary basis for a period of 3 years would not frustrate the long-term planning intention of the "AGR" zone.

# **Development Parameters**

- 8. The Proposed Development serves to meet the parking demand of local residents and operators in the vicinity. 49 and 4 nos. of parking space for private cars and light goods vehicles (LGV) are proposed at the Site respectively (**Plan 3**).
- 9. Operation hours are 24-hours daily, including Sundays and public holidays.

10. About 1,478 m<sup>2</sup> of the Site has been paved with concrete of about 0.2 m in depth for the provision of a solid ground for vehicle manoeuvring. The pond (about 40 m<sup>2</sup>) within the Site has been filled with soil and concrete of about 1.5 m in depth to provide a solid ground for vehicle manoeuvring (**Plan 5**).

# **Similar Applications**

11. There are 6 similar applications approved by the Committee within or straddling the "AGR" zone on the OZP in the past 3 years:

- 12. The similar applications were approved by the Committee between 2024 and 2025 on considerations that temporary approval would not frustrate the long-term planning intention of the "AGR" zone; not incompatible with surrounding land uses; and no adverse departmental comments or the concerns could be addressed by relevant approval conditions.
- 13. Given that the planning context of the adjacent areas has not been significantly altered, it is considered that the planning circumstances of the current application are relevant to the similar approved applications.

# No Adverse Impacts to the Surroundings

## Visual and Landscape

14. Given that no structures will be erected at the Site, the applied use is considered not incompatible with surrounding land uses intermixed with warehouses, residential dwellings and agricultural land. Adverse visual impacts to the surrounding areas are not anticipated.

15. The trip attraction and generation rates are expected as follows:

- 16. In view of the low trip attraction and generation rates, it is expected that the Proposed Development should not cause adverse traffic impacts to the adjacent areas and road network.
- 17. 49 nos. of parking space for private cars and 4 nos. of parking space for LGVs are provided at the Site. Sufficient space is provided for vehicle manoeuvring within the Site (**Plan 4**). No parking, reversing or turning of vehicles on public road is expected. No container vehicles and vehicles exceeding 5.5 tonnes will be allowed to park at the Site.

## Environment

- 18. The Applicant undertakes to follow the measures as set out in the 'Code of Practice on Handling the Environmental Aspects of Temporary Uses and Open Storage Sites' issued by the Environmental Protection Department in order to minimise any possible environmental nuisances, and to comply with all environmental protection/pollution control ordinances.
- 19. The Proposed Development is intended for the use of parking of vehicles only. No container vehicles/tractors and vehicles exceeding 5.5 tonnes will be allowed to park at, stall at, enter or exit the Site. No car beauty services, vehicle repairing, dismantling or other workshop activities will be allowed at the Site. No public announcement systems, whistle blowing or portable loudspeaker will be allowed within the Site. As such, potential adverse noise impacts to the surrounding areas are not anticipated.

## Drainage

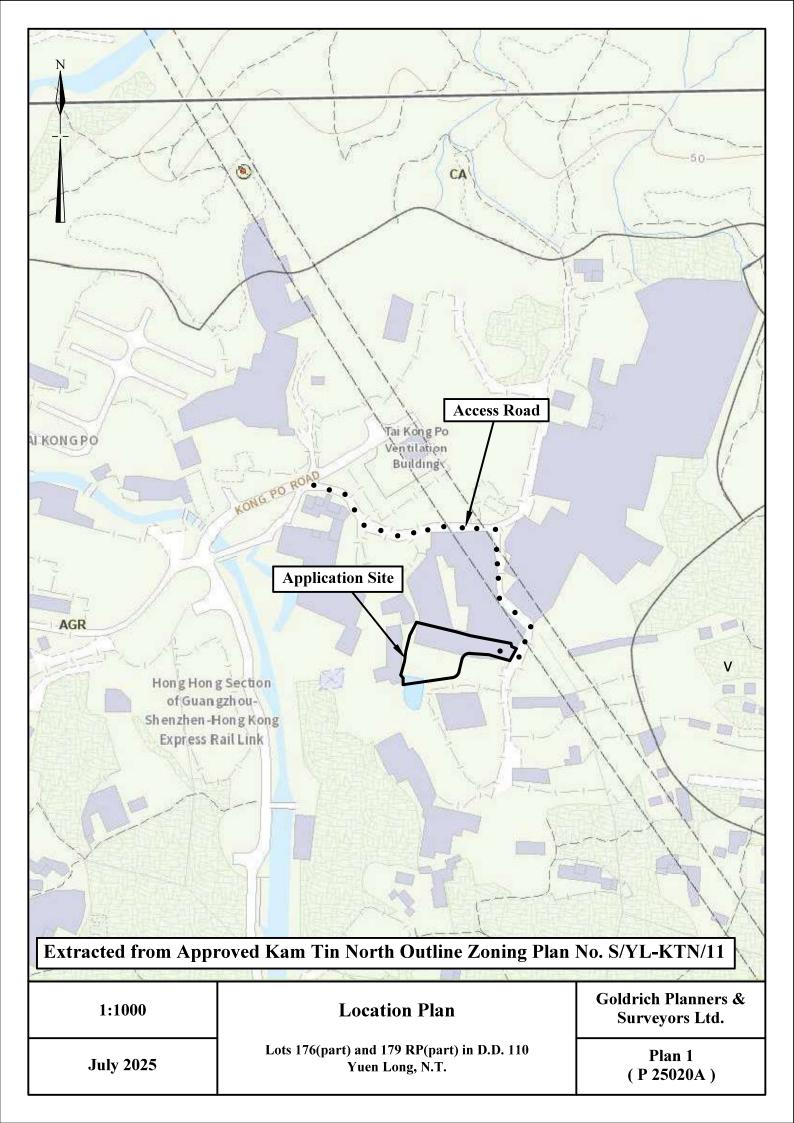
20. The Applicant will submit a drainage proposal, with the provision of periphery u-channels and catchpits to mitigate the potential adverse drainage impacts generated by the Proposed Development after planning approval has been granted from the Board. The Applicant will proceed to implement

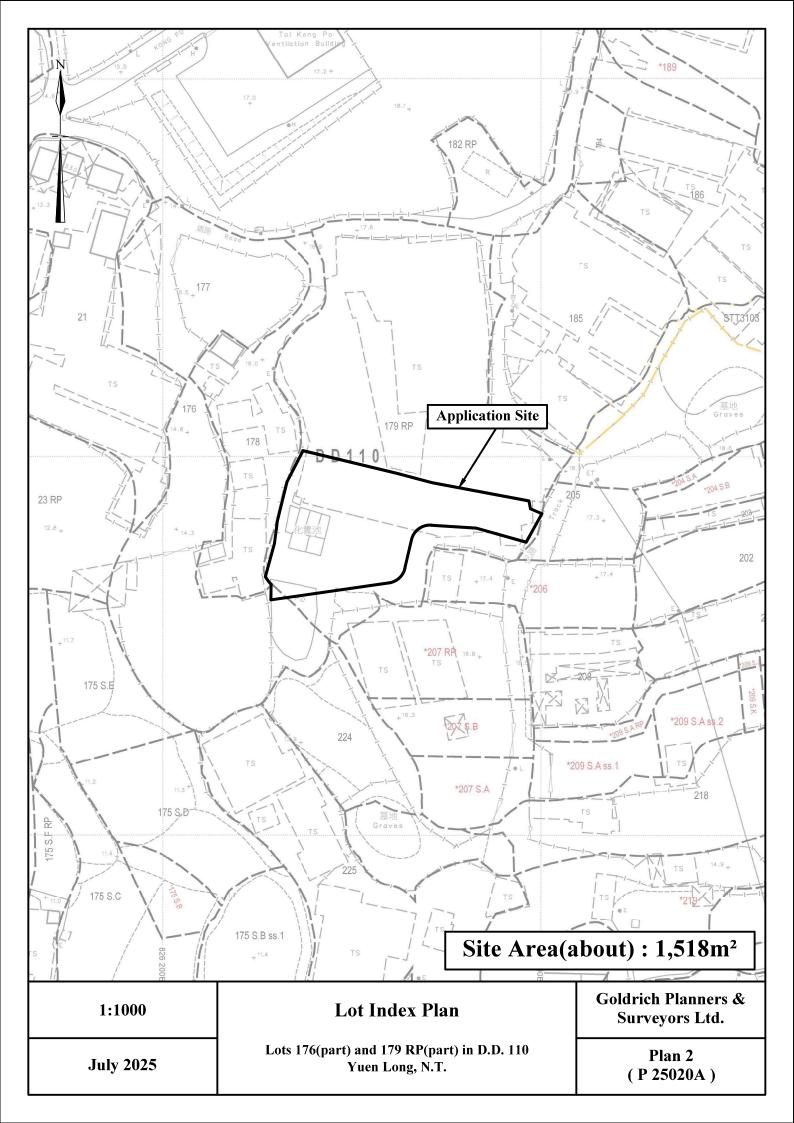
the proposed drainage facilities at the Site once the drainage proposal is accepted by the Drainage Services Department.

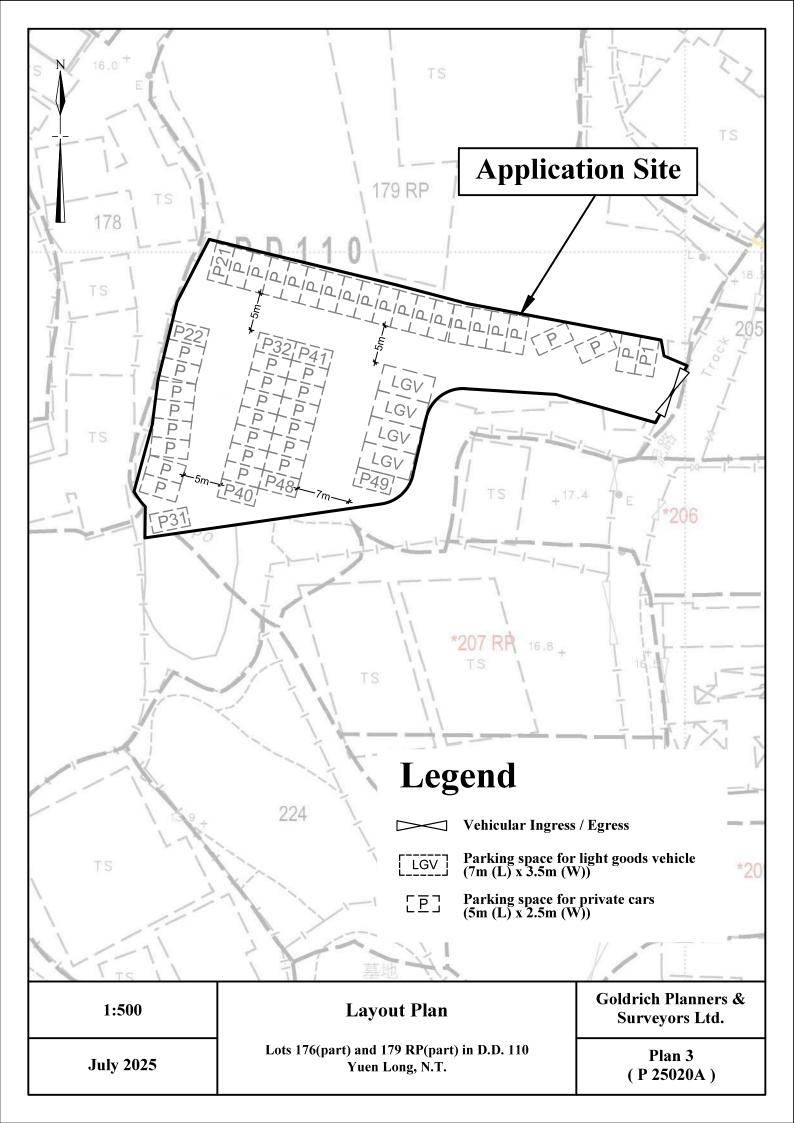

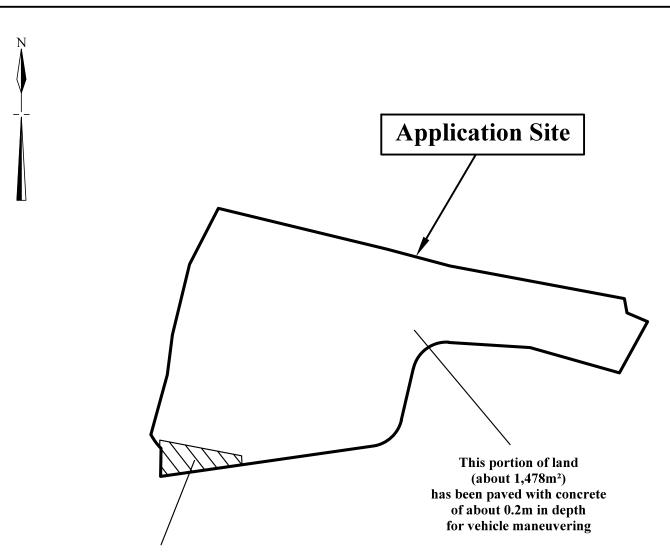

## **Recommended Advisory Clauses**

  - (ii) the applicant shall follow the relevant guidelines and requirements in relevant Professional Persons Environmental Consultative Committee Practice Notes (ProPECCPNs), in particular the ProPECCPN 1/23 'Drainage Plans subject to Comment by the Environmental Protection Department';
  - (iii) the applicant shall provide adequate supporting infrastructure/facilities for proper collection, treatment and disposal of waste/wastewater generated from the proposed

use: and

- (iv) the applicant shall meet the statutory requirements under relevant environmental legislation;
- (g) to note the comments of the Chief Engineer/Mainland North, Drainage Services Department that:
  - (i) the detailed comments on the drainage proposal previously provided to the applicant shall be taken into account in the revised drainage proposal;
  - (ii) the applicant shall rectify the drainage system if they are found to be inadequate or ineffective during operation. The applicant shall also be liable for and shall indemnify claims and demands arising out of damage or nuisance caused by a failure of the drainage system;
  - (iii) the applicant shall consult District Lands Officer/Yuen Long, LandsD and seek consent from the relevant owners for any drainage works to be carried out outside his lot boundary before commencement of the drainage works; and
  - (iv) the applicant shall be liable for any adverse drainage impact due to the proposed use;
- (h) to note the comments of the Chief Building Surveyor/New Territories West, Buildings Department (BD) that:
  - (i) it is noted that associated filling of land and pond are proposed in the application. Before any new building works (including containers/open sheds as temporary buildings, demolition and land filling, etc.) are to be carried out on the Site, prior approval and consent of the Building Authority (BA) should be obtained, otherwise they are unauthorized building works (UBW) under the Buildings Ordinance (BO). An Authorized Person should be appointed as the co-ordinator for the proposed building works in accordance with the BO;
  - (ii) the Site shall be provided with means of obtaining access thereto from a street and emergency vehicular access in accordance with Regulations 5 and 41D of the Building (Planning) Regulations (B(P)R) respectively;
  - (iii) the Site does not abut on a specified street of not less than 4.5m wide and its permitted development intensity shall be determined under Regulation 19(3) of the B(P)R at building plan submission stage;
  - (iv) if the existing structure is erected on leased land without the approval of the BA, they are UBW under the BO and should not be designated for any proposed use under the captioned application;
