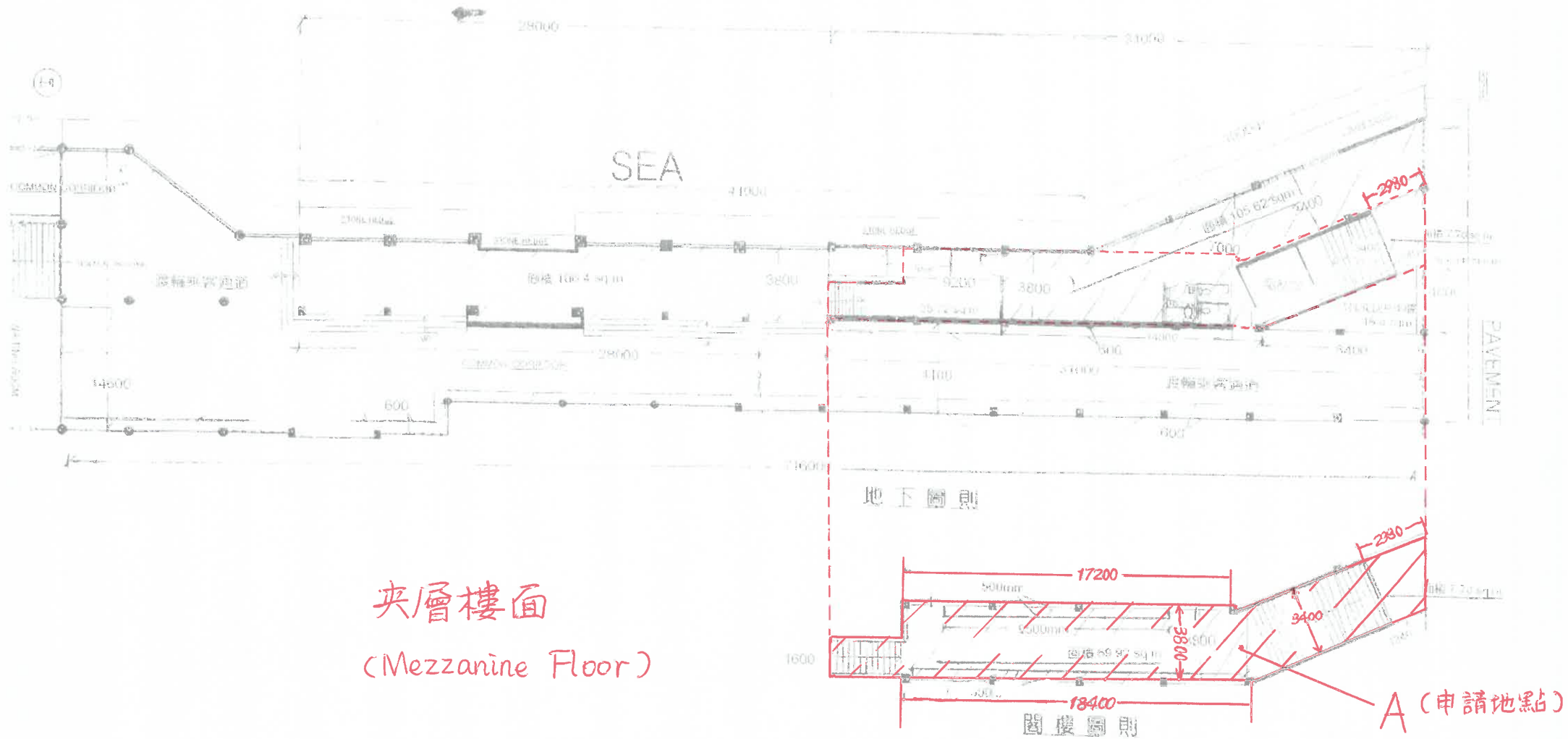

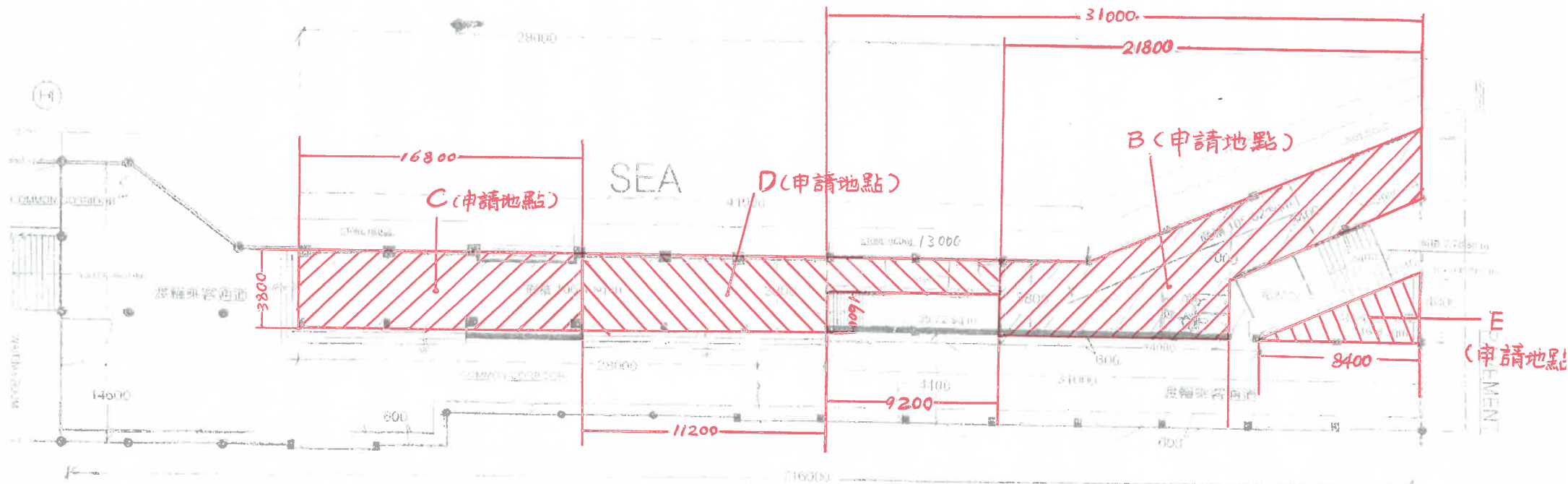

Approval Conditions

- (1) The south-eastern boundary of the proposed office area should be set back to allow more space for passengers to use the stairs.
- (2) At least two exits should be provided for the proposed office.
- (3) The provision of fire service installations and equipment to the satisfaction of the Director of Fire Services or of the Town Planning Board (the Board).
- (4) The submission and implementation of a sewerage connection proposal to the satisfaction of the Director of Drainage Services or of the Board.

Reasons for Rejection

- (1) There are no sufficient planning justifications to use a “G/IC” site for commercial uses as there is a shortfall of community and open space facilities in North Point.
- (2) There were no sufficient planning justifications to use a “G/IC” site for office development as there was a shortfall of open space facilities in North Point.
- (3) There are inherent design incompatibility to accommodate dangerous goods vehicle ferry pier and queuing area in office/commercial and residential development.
- (4) The proposed development will have adverse traffic impact on the area.
- (5) The provision of car parking spaces is excessive whilst that of loading/unloading facilities is inadequate.
- (6) Approval of the application will set an undesirable precedent for similar applications for intensive commercial developments in other ferry piers/concourses.
- (7) The location and design of the proposed open space are not satisfactory.
- (8) The development intensity of the proposed development is excessive.
- (9) The Quantitative Risk Assessment does not meet the Government Individual Risk Guidelines and the proposed risk mitigation measures are not sufficient.
- (10) The provision of loading/unloading and lay-by facilities for the excursion ferry services is inadequate and the arrangement of the vehicular ingress/egress to the proposed development is not satisfactory.
- (11) The proposed development will have adverse traffic impact on the nearby road system and the traffic impact assessment is not satisfactory.
- (12) The application premises should be used for pier-related uses in the long-term or put to other beneficial uses which can better facilitate public enjoyment of the waterfront. The applicant has not provided sufficient information to justify the need for the proposed office use within the application premises.

Recommended Advisory Clauses

- (a) to note the comments of the Harbour Office, Development Bureau that in view that the East Coast Boardwalk has been gradually opened for public enjoyment since early 2025, the applicant is advised to explore how the proposed development could better blend with the overall planning of the North Point harbourfront development to enhance its attractiveness and diversity;
- (b) to note the comments of the Government Property Administrator that application for commercial concession shall be submitted for Government Property Agency's consideration under the mechanism in the existing tenancy to implement the proposal. Such application, if received, would be circulated to relevant government bureau/departments (B/Ds) (including Fire Services Department) for consideration and upon receipt of no adverse comments from all relevant B/Ds, approval may be given subject to terms and conditions based on the comments received;
- (c) to note the comments of the Director of Environmental Protection that since there are two air pollution sources, i.e. ship emissions from ferry piers and vehicle emissions from Island Eastern Corridor, in the vicinity of the Premises, the applicant is advised to install air conditioning system with fresh air intakes at the northern end of the pier as far as practicable to minimise the potential air nuisances from the said pollution sources; and
- (d) to note the comments of the Director of Fire Services that detailed fire safety requirements will be formulated upon receipt of a formal submission of short-term tenancy/short-term waiver, general building plans or referral of application via relevant licensing authority.
