7. Justifications 理由

The applicant is invited to provide justifications in support of the application. Use separate sheets if necessary. 現請申請人提供申請理由及支持其申請的資料。如有需要,請另頁說明)。

The justifications for the temporary animal boarding establishment (Cattery) are as follows:

- 1. The size of the application site is about 90.6m². It is currently zoned 'Agriculture' ("AGR") according to the Approved Kam Tin North Outline Zoning Plan (OZP) NO. S/YL-KTN/11. The proposed development is temporary use which would not jeopardize the long-term planning intention of the site.
- 2. The proposed development is a Column 2 use which does not violate the planning intention of the "AGR" zone.
- 3. The operation hours of the proposed development is 9:00 a.m. to 7:00 p.m. from Mondays to Sundays including public holidays.
- 4. During the operation hour, no more than 6 cats will stay inside the proposed development at a time.
- 5. Not cat and staff will be resided at the application site outside the operation hours.
- 6. Only 1 2 trips are generated by the operation per day so it would not affect the traffic of public road nearby.
- 7. The applicant and its visitors have the right to use the private road within Tai Kong Po Farm for people and vehicles.
- 8. Before the applicant being the owner of the land, the pond within the whole application site (area about 90.6 sq.m) has been filled by soil with depth no more than 4.6m by others. The applicant would like to reflect this situation in this application.
- 9. An area of no more than 84.6sq.m (depth 0.5m) of land has been filled by concrete at the application site by the applicant for the purpose of constructing the structure and car parking space. No further filling work will be carried out in the future.
- 10. Drainage and fire services systems have been built at the application site and are ensured to be functioning properly.
- 11. The applicant has planted 2 nos. of Bauhinia Blakeana at the site, which will not be removed during the application period.
- 12. The nature, form and layout of the proposed development are compatible with the surrounding environment. It would not affect the character of the surrounding environment.
- 13. Town Planning Board has approved a good number of similar developments in rural Yuen Long. Similar preferential treatment should be granted to this application.
- 14. The result of preliminary technical proposals demonstrated that the actual impact generated by the proposed development would be insignificant. No adverse traffic, environmental, landscape and drainage impacts are foreseen.

The Board is hereby respectfully requested to approve in Lots 3 S.E (Part) and 8 S.L in D.D.110, Tai Kong Po, Kam Tin, Yuen Long, N.T. for Temporary Animal Boarding Establishment (Cattery) and Associated Filling of Land and Pond for a period of three years on sympathetic grounds.

- 2. 根據錦田北分區計劃大綱核准圖編號S/YL-KTN/11,擬議發展是屬於第二欄用途,並沒有違背「農業」用途的規劃憶向。
- 3. 擬議用途的營業時間為星期一至星期日包括公眾假期上午九時至下午七時。
- 4. 於營業時間內,擬議用途的地點同一時間內不會寄養多於6隻小貓。
- 5. 於營業時間以外的時間,貓及擬議用途的職員不會於申請地點留宿。
- 6. 每日估計只有1至2輪私家車進出,對附近公眾道路不會造成影響。
- 7. 申請人及其訪客已擁有大江埔農莊內私家路之人及車的使用權。
- 8. 申請人獲得此土地擁有權之前,整個申請地點(約90.6平方米面積)之池塘已被其他人用泥土填滿,深度不多於4.6米。申請人就是次申請反映此情況。
- 9. 申請人已將申請地點用水泥填土不多於84.6平方米面積(深度0.5米),作為已興建的建築物及車位用途,日後亦不會 再作任何填土工作。
- 10. 申請地點已建設了排水及消防系統,並確保系統正常運作。

1. Land Administration

Comments of the District Lands Officer/Yuen Long, Lands Department:

- no adverse comment on the application;
- the application site (the Site) comprises Old Schedule Agricultural Lots No. 3 S.E and 8 S.L both in D.D. 110 held under the Block Government Lease which contains the restriction that no structures are allowed to be erected without the prior approval of the Government; and
- advisory comments are at **Appendix IV**.

2. Traffic

Comments of the Commissioner for Transport:

- no adverse comment on the application from traffic engineering perspective; and
- advisory comments are at Appendix IV.

Comments of the Chief Highway Engineer/New Territories West, Highways Department:

- no in-principle objection to the application from highways maintenance point of view; and
- advisory comments are at **Appendix IV**.

3. Drainage

Comments of the Chief Engineer/Mainland North, Drainage Services Department:

- no in-principle objection to the application from drainage point of view;
- according to the applicant's submission, the existing drainage facilities which were implemented under an approved application No. A/YL-KTN/839 will be maintained for the subject development;
- should the application be approved, approval conditions should be stipulated requiring the maintenance of the existing drainage facilities and submission of revised record of the existing drainage facilities to the satisfaction of his division or the Town Planning Board; and
- advisory comments are at **Appendix IV**.

4. Environment

Comments of the Director of Environmental Protection:

- no objection to the application from environmental planning perspective;
- based on the applicant's submission, the applied use would not cause traffic of heavy vehicle and dusty operation. According to his review, there are residential structures within 100m from the boundary of the Site;
- there was no environmental complaint received against the Site in the past three years; and
- advisory comments are at Appendix IV.

5. Fire Safety

Comments of the Director of Fire Services:

- no in-principle objection to the application subject to fire service installations being provided to his satisfaction; and
- advisory comments are at **Appendix IV**.

6. Landscape Aspect

Comments of the Chief Town Planner/Urban Design and Landscape, Planning Department:

- no adverse comment on the application from landscape planning perspective;
- based on the aerial photo of 2024, the Site is located in an area of rural inland plains landscape character comprising temporary structures and natural woodland. The applied use is not entirely incompatible with the surrounding landscape character; and
- according to the site photos of 2025, the Site is hard-paved and occupied by a building structure. Significant adverse landscape impact on landscape resources arising from the applied use is not anticipated.

7. Agriculture, Fisheries and Nature Conservation

Comments of the Director of Agriculture, Fisheries and Conservation:

- no strong view on the application from agricultural perspective. The Site is zoned "Agriculture" and is generally occupied by a structure. Agricultural infrastructures such as road access and water source are available in the area. The Site can be rehabilitated for agricultural activities such as open-field cultivation, greenhouses, plant nurseries, etc., though whether there will be agricultural activities on a specific site will hinge on a lot of factors;
- the Site has no license granted by his department;

- the historical use of the subject pond in the past is uncertain. Based on the applicant's submission, the subject pond had been filled for years and no actual pond filling activities are proposed in the application;
- no comment on the applied filling of land and pond from nature conservation and fisheries perspectives; and
- advisory comments are at **Appendix IV**.

8. **Building Matters**

Comments of the Chief Building Surveyor/New Territories West, Buildings Department:

- no objection to the application; and
- advisory comments are at Appendix IV.

9. <u>District Officer's Comments</u>

Comments of the District Officer (Yuen Long), Home Affairs Department:

• his office has not received any local's comment on the application and he has no particular comment on the application.

10. Other Departments

The following government departments have no objection to/no comment on the application and their advisory comments, if any, are at **Appendix IV**:

- Project Manager (West), Civil Engineering and Development Department;
- Chief Engineer/Construction, Water Supplies Department; and
- Director of Electrical and Mechanical Services.

Recommended Advisory Clauses

- (a) prior planning permission should have been obtained before commencing the applied use at the application site (the Site);
- (b) failure to reinstate the Site as required under the relevant approval condition upon expiry of the planning permission might constitute an unauthorized development under the Town Planning Ordinance and be subject to enforcement and prosecution actions;
- (c) to note the comments of the District Lands Officer/Yuen Long, Lands Department (DLO/YL, LandsD) that the lot owner(s) shall apply to his office for a Short Term Waiver (STW) to permit the structure(s) erected within the private lots of the Site. The application(s) for STW will be considered by the Government in its capacity as a landlord and there is no guarantee that they will be approved. The STW, if approved, will be subject to such terms and conditions including the payment of waiver fee and administrative fee as considered appropriate by LandsD. Besides, given the applied use is temporary in nature, only erection of temporary structure(s) will be considered;
- (d) to note the comments of the Commissioner for Transport that:
 - (i) the Site is connected to the public road network via a section of a local access road which is not managed by the Transport Department. The land status of the local access road should be checked with LandsD. Moreover, the management and maintenance responsibilities of the local access road should be clarified with the relevant lands and maintenance authorities accordingly;
 - (ii) sufficient manoeuvring space shall be provided within the Site; and
 - (iii) no vehicle is allowed to queue back to or reverse onto/from public road at any time during the planning approval period;
- (e) to note the comments of the Chief Highway Engineer/New Territories West, Highways Department (HyD) that:
 - (i) the proposed vehicular run-in/out is adjoining to a section of Kong Tai Road, which is not maintained by HyD. HyD shall not be responsible for the maintenance of the proposed access connecting the Site, including the adjoining section of Kong Tai Road; and
 - (ii) adequate drainage measures shall be provided to prevent surface water running from the Site to the nearby public roads and drains;
- (f) to note the comments of the Director of Environmental Protection that:
 - (i) the applicant shall ensure that no public announcement system, portable loudspeaker or any form of audio amplification system will be used at the Site at any time;
 - (ii) the applicant shall follow the revised 'Code of Practice on Handling the Environmental Aspects of Temporary Uses and Open Storage Sites';

- (iii) the applicant shall follow the relevant guidelines and requirements in relevant Professional Persons Environmental Consultative Committee Practice Notes (ProPECCPNs), in particular the ProPECCPN 1/23 'Drainage Plans subject to Comment by the Environmental Protection Department';
- (iv) the applicant shall provide adequate supporting infrastructure/facilities for proper collection, treatment and disposal of waste/wastewater generated from the applied use; and
- (v) the applicant shall meet the statutory requirements under relevant environmental legislation;
- (g) to note the comments of the Chief Engineer/Mainland North, Drainage Services Department that the detailed comments on the record of the existing drainage facilities previously provided to the applicant shall be taken into account in the revised records of the existing drainage facilities;
- (h) to note the comments of the Director of Fire Services that:
 - (i) the detailed comments on the fire service installations (FSIs) proposal previously provided to the applicant shall be taken into account in the revised FSIs proposal; and
 - (ii) if the proposed structure is required to comply with the Buildings Ordinance (BO) (Cap. 123), detailed fire services requirements will be formulated upon receipt of formal submission of general building plans;
- (i) to note the comments of the Director of Agriculture, Fisheries and Conservation that:
 - (i) under the Public Health (Animals) (Boarding Establishment) Regulations (Cap. 139I) (the Regulations), any person who provides food and accommodation for animals in return for a fee paid by the owner must apply for a Boarding Establishment Licence from his department. The establishment and ancillary facilities which is licensed under the Regulations must always fulfill the criteria listed in the Regulations; and
 - (ii) the applicant shall observe the Prevention of Cruelty to Animals Ordinance (Cap. 169) at all times;
- (j) to note the comments of the Chief Building Surveyor/New Territories West, Buildings Department (BD) that:
 - (i) it is noted that one structure and associated filling of land and pond are applied in the application. Before any new building works (including containers/open sheds as temporary buildings, demolition and land filling, etc.) are to be carried out on the Site, prior approval and consent of the Building Authority (BA) should be obtained, otherwise they are unauthorized building works (UBW) under the BO. An Authorized Person should be appointed as the co-ordinator for the proposed building works in accordance with the BO;
 - (ii) the Site shall be provided with means of obtaining access thereto from a street and emergency vehicular access in accordance with Regulations 5 and 41D of the Building (Planning) Regulations (B(P)R) respectively;

- (iii) the Site does not abut on a specified street of not less than 4.5m wide and its permitted development intensity shall be determined under Regulation 19(3) of the B(P)R at building plan submission stage;
- (iv) for UBW erected on leased land, enforcement action may be taken by BD to effect their removal in accordance with the prevailing enforcement policy against UBW as and when necessary. The granting of any planning approval should not be construed as an acceptance of any existing building works or UBW on the Site under the BO;
- (v) if the applied use under application is subject to issue of a license, the applicant should be reminded that any existing structures on the Site intended to be used for such purposes are required to comply with the building safety and other relevant requirements as may be imposed by the licensing authority;
- (vi) any temporary shelters or converted containers for office, storage, washroom or other uses are considered as temporary buildings are subject to the control of Part VII of the B(P)R; and
- (vii) detailed checking under the BO will be carried out at building plan submission stage.
