





Relevant Interim Criteria for Consideration of Application for New Territories Exempted House (NTEH)/Small House in New Territories (promulgated on 7.9.2007)

- (a) sympathetic consideration may be given if not less than 50% of the proposed NTEH/Small House footprint falls within the village 'environs' ('VE') of a recognised village and there is a general shortage of land in meeting the demand for Small House development in the "Village Type Development" ("V") zone of the village;
- (b) if more than 50% of the proposed NTEH/Small House footprint is located outside the 'VE', favourable consideration could be given if not less than 50% of the proposed NTEH/Small House footprint falls within the "V" zone, provided that there is a general shortage of land in meeting the demand for Small House development in the "V" zone and the other criteria can be satisfied;
- (c) development of NTEH/Small House with more than 50% of the footprint outside both the 'VE' and the "V" zone would normally not be approved unless under very exceptional circumstances (e.g. the application site has a building status under the lease, or approving the application could help achieve certain planning objectives such as phasing out of obnoxious but legal existing uses);
- (d) application for NTEH/Small House with previous planning permission lapsed will be considered on its own merits. In general, proposed development which is not in line with the criteria would normally not be allowed. However, sympathetic consideration may be given if there are specific circumstances to justify the cases, such as the site is an infill site among existing NTEHs/Small Houses, the processing of the Small House grant is already at an advance stage;
- (e) if an application site involves more than one NTEH/Small House, application of the above criteria would be on individual NTEH/Small House basis;
- (f) the proposed development should not frustrate the planning intention of the particular zone in which the application site is located;
- (g) the proposed development should be compatible in terms of land use, scale, design and layout, with the surrounding area/development;
- (h) the proposed development should not encroach onto the planned road network and should not cause adverse traffic, environmental, landscape, drainage, sewerage and geotechnical impacts on the surrounding areas. Any such potential impacts should be mitigated to the satisfaction of relevant Government departments;
- (i) the proposed development, if located within water gathering grounds, should be able to be connected to existing or planned sewerage system in the area except under very special circumstances (e.g. the application site has a building status under the lease or the applicant can demonstrate that the water quality within water gathering grounds will not be affected by the proposed development*);
- (j) the provision of fire service installations and emergency vehicular access, if required, should be appropriate with the scale of the development and in compliance with relevant standards; and
- (k) all other statutory or non-statutory requirements of relevant Government departments must be met. Depending on the specific land use zoning of the application site, other Town Planning Board guidelines should be observed, as appropriate.
- *i.e. the applicant can demonstrate that effluent discharge from the proposed development will be in compliance with the effluent standards as stipulated in the Water Pollution Control Ordinance Technical Memorandum.

Rejection Reasons

- R1 The proposed development did not comply with the Interim Criteria for assessing planning application for NTEH/Small House development as the application site fell entirely outside the "Village Type Development" zone and village 'environs' of a recognised village. There was no exceptional circumstances to merit special consideration of the application.
- R2 The approval of the application would set an undesirable precedent for other similar applications within the "Agriculture" zone. The cumulative impacts of approving such application would result in adverse traffic impact of the area.

Government Departments' General Comments

1. Land Administration

Comments of the District Lands Officer/North, Lands Department (DLO/N, LandsD):

- the application site (the Site) falls within the village 'environs' ('VE') of Lung Yeuk Tau Wing Ning Wai, Wing Ning Tsuen, Tung Kok Wai, Ma Wat Tsuen, Ma Wat Wai, Tsz Tong Tsuen and Lo Wai;
- all the Small House applications submitted by the current applicants had been rejected. All the applicants claimed themselves as the indigenous villagers of Lung Yeuk Tau, Fanling Heung. Their eligibilities for Small House grant are yet to be ascertained;
- the Site is Old Schedule Agricultural Lots held under Block Government Lease; and
- Lots 966 S.A, 966 S.B and 966 S.C in D.D. 83 are covered by Modification of Tenancy (MOT) No. 33094 and Letter of Approval (L of A) No. L1218, whilst Lots 967 S.A and 967 S.B. in D.D. 83 are covered by MOT No. 38430 and L of A No. 5386. Besides, the Site is currently not covered by Building Licence.

2. Traffic

Comments of the Commissioner for Transport (C for T):

- no objection to the application from traffic engineering perspective;
- the application only involves construction of five Small Houses at the Site, she considers that the application could be tolerated on traffic ground;
- though additional traffic generated by the proposed development is not significant, the permission of developments outside the "Village Type Development" ("V") zone will set an undesirable precedent case for similar applications in the future. The resulting cumulative adverse traffic impact has to be reviewed on case-by-case basis in the future; and
- her advisory comments are at Appendix V.

Comments of the Chief Highway Engineer/New Territories East, Highways Department (CHE/NTE, HyD):

- no comment on the application from highways maintenance perspective; and
- his advisory comments are at **Appendix V**.

3. Environment

Comments of the Director of Environmental Protection (DEP):

• no in-principle objection to the application provided that the applicants will provide adequate sewer connection for disposal of sewage from the Small Houses to the existing public sewer at their own costs and reserve adequate land for the sewer connection; and

• his advisory comments are at **Appendix V**.

4. **Drainage**

Comments of the Chief Engineer/Mainland North, Drainage Services Department (CE/MN, DSD):

- no objection to the application from public drainage perspective; and
- her advisory comments are at **Appendix V**.

5. Fire Safety

Comments of the Director of Fire Services (D of FS):

- no objection in principle to the application at this stage provided that the proposed Small Houses would not encroach on any existing Emergency Vehicular Access (EVA) or planned EVA under application in accordance with LandsD's record; and
- his advisory comments are at **Appendix V**.

6. Landscape

Comments of the Chief Town Planner/Urban Design and Landscape, Planning Department (CTP/UD&L, PlanD):

- no adverse comment on the application from landscape planning perspective;
- the Site is located in an area of rural landscape character comprising village houses/domestic structures, active/fallow farmlands, vacant land and tree clusters and vegetated areas. The proposed development is considered not incompatible with the surrounding environments;
- based on the site visit conducted on 4.11.2025, the Site is fenced-off, largely hard-paved, partly occupied by temporary structures, and covered by vegetated areas at the eastern portion (**Plans A-4a** and **A-4b**). Significant adverse landscape impact within the Site is not anticipated; and
- her advisory comments are at **Appendix V**.

7. Agriculture

Comments of the Director of Agriculture, Fisheries and Conservation (DAFC):

does not support the application from agricultural perspective as the Site possesses
potential for agricultural rehabilitation. There are agricultural activities in the vicinity, and
agricultural infrastructures such as road access and water source are also available. The
Site could be used for agricultural activities such as open-field cultivation, greenhouses,
plant nurseries, etc.

8. Water Supplies

Comments of the Chief Engineer/Construction, Water Supplies Department (CE/C, WSD):

- no objection to the application; and
- his advisory comments are at **Appendix V**.

9. Demand and Supply of Small House Sites

According to the DLO/N, LandsD's records, the total number of outstanding Small House applications for Lung Yeuk Tau village cluster is 102 while 10-year Small House demand forecast for the same village is 585. According to the latest estimate by PlanD, about 10.26ha (equivalent to about 409 Small House sites) of land are available within the "V" zone of Lung Yeuk Tau village cluster for Small House development. There is insufficient land in the "V" zone of Lung Yeuk Tau village cluster to meet the future demand of land for Small House development (i.e. about 17.2ha of land which is equivalent to 687 Small House sites).

10. Other Departments

The following government departments have no objection to/no comment on the application:

- (a) District Officer (North), Home Affairs Department (DO(N), HAD);
- (b) Director of Electrical and Mechanical Services (DEMS); and
- (c) Project Manager (North), Civil Engineering and Development Department (PM(N), CEDD).

Recommended Advisory Clauses

- (a) to note the comments of the Commissioner for Transport (C for T) that the local village access leading to the application site (the Site) from Sha Tau Kok Road Lung Yeuk Tau is not managed by the Transport Department (TD);
- (b) to note the comments of the Chief Highway Engineer/New Territories East, Highways Department (CHE/NTE, HyD) that:
 - (i) the proposed access arrangement should be commented by TD;
 - (ii) HyD is not/shall not be responsible for the maintenance of any access connecting the Site and the nearby public roads; and
 - (iii) adequate drainage measures should be provided to prevent surface water running from the Site to the nearby public roads and drains;
- (c) to note the comments of the Director of Environmental Protection (DEP) that public sewage connection is available in the vicinity of the Site and the applicants shall obtain the written consent(s) from the adjacent lot owner(s) and/or the Lands Department (LandsD) for laying and maintaining sewers, if any, may be required;
- (d) to note the comments of the Chief Engineer/Mainland North, Drainage Services Department (CE/MN, DSD) that:
 - (i) the existing watercourse at the western boundary of Lot 967 S.A and 967 S.B in D.D 83 shall be maintained all the time:
 - (ii) there is no DSD's stormwater system in the vicinity of the Site. The applicants shall provide adequate stormwater drainage collection and disposal facilities to deal with the surface runoff of the Site or the same flowing on to the Site from the adjacent areas. The stormwater drainage facilities to be completed under the proposed development (whether within private lots or Government Land) shall be solely maintained by the applicants and the successive owners of the proposed development at their own resources; and
 - (iii) the Site is within an area where connection to existing public sewerage network is available in the vicinity. Should the applicants choose to connect their proposed sewerage systems to DSD's networks, they shall furnish her office with the connection proposal for agreement. Upon DSD's agreement, the applicants shall submit a duly completed Form HBP1 with a cross cheque covering the technical audit fee and a plan showing the details of the proposed connection works to her office for formal application for the required connection. Upon acceptance of the connection application, the applicants shall carry out the proposed connection works in accordance with DSD Standard Drawings at the resources of the applicant. The Environmental Protection Department should be consulted regarding the sewage treatment/disposal facilities for the proposed development;
- (e) to note the comments of the Director of Fire Services (D of FS) that the applicants should observe 'New Territories Exempted Houses A Guide to Fire Safety Requirements' which is administrated by LandsD. Detailed fire safety requirements will be formulated upon receipt of formal application via LandsD;

- (f) to note the comments of the Chief Town Planner/Urban Design and Landscape, Planning Department (CTP/UD&L, PlanD) that approval of the application does not imply approval of tree works such as pruning, transplanting, felling and compensatory/new tree planting. The applicants are reminded to seek approval for any proposed tree works from relevant department(s) prior to commencement of the works;
- (g) to note the comments of the Chief Engineer/Construction, Water Supplies Department (CE/C, WSD) that:
 - (i) for provision of water supply to the proposed development, the applicants may need to extend their inside services to the nearest suitable government water mains for connection; and
 - (ii) the applicants shall resolve any land matter (such as private lots) associated with the provision of water supply and shall be responsible for the construction, operation and maintenance of the inside services within the private lots to WSD's standard; and
- (h) to note that the permission is only given to the development under application. If provision of an access road is required for the proposed developments, the applicants should ensure that such access road (including any necessary filling/excavation of land) complies with the provisions of the relevant statutory plan and obtain planning permissions from the Town Planning Board where required before carrying out the road works.
