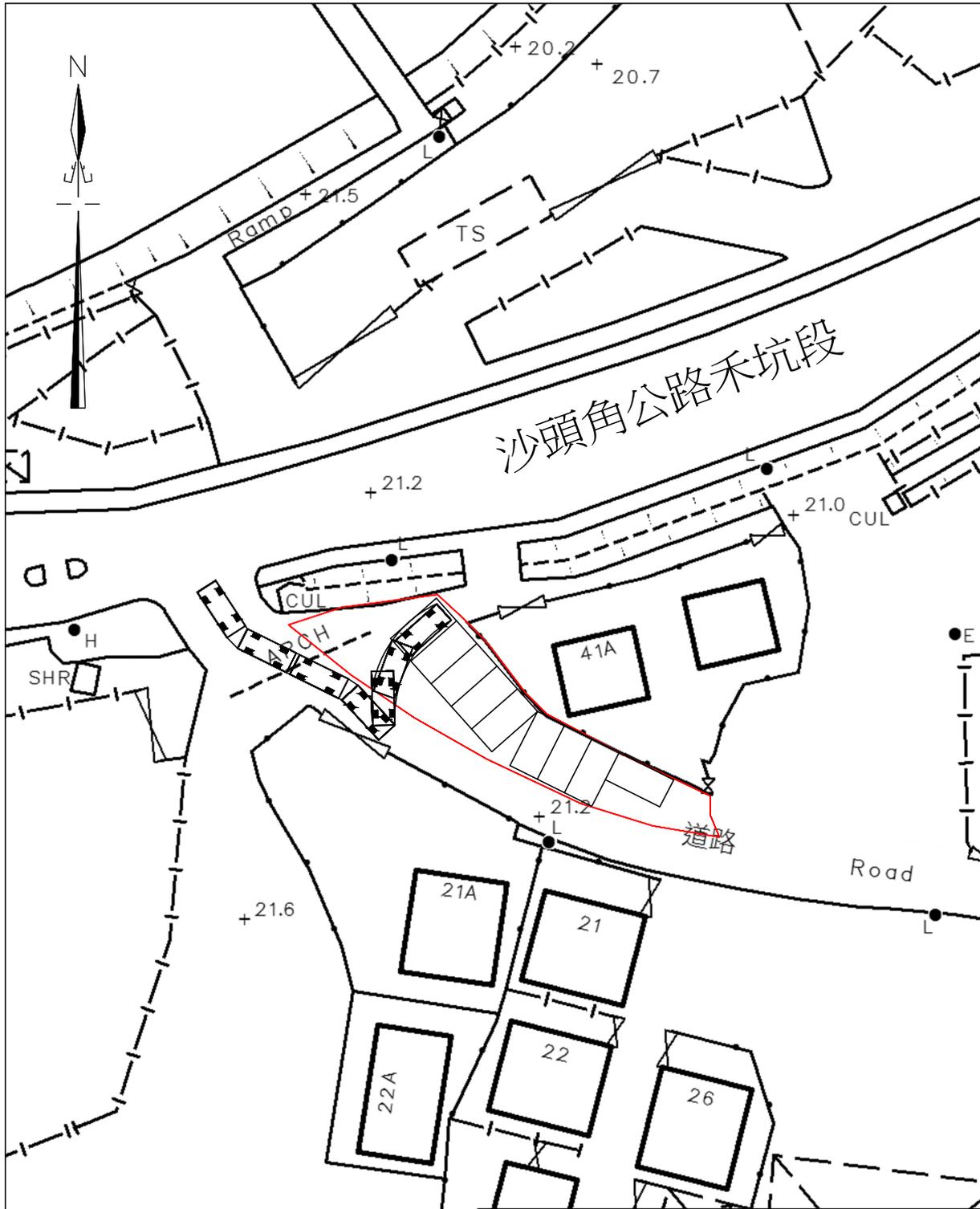

Comments of the District Lands Officer/North, Lands Department (DLO/N, LandsD):

- no objection to the applications;
- the application sites (the Sites) comprise Old Schedule Agricultural Lots held under the Block Government Lease which contains the restriction that no structures are allowed to be erected without the prior approval of the Government. The proposed ingress/egress of the Sites is required to pass through Government land (GL) but no right of access via GL is granted to the Sites;
- portion of the Site under application No. A/NE-MUP/228 is covered by the Short Term Waiver (STW) No. 1585 for the existing Pai Lau erected at the Site. The applicants are the waiverees of the STW;
- it is noted that no structure is proposed in the planning applications; and
- his advisory comments are at **Appendix IV**.

2. Traffic

Comments of the Commissioner for Transport (C for T):

- no comment on the applications from traffic engineering perspective;
- should the applications be approved, approval conditions on the submission and maintenance of the traffic management measures, as proposed by the applicants, to her satisfaction or of the Town Planning Board should be included in the planning approval; and
- her advisory comments are at **Appendix IV**.

Comments of the Chief Highway Engineer/New Territories East, Highways Department (CHE/NTE, HyD):

- no comment from highways maintenance perspective; and
- his advisory comments are at **Appendix IV**.

3. Environmental

Comments of the Director of Environmental Protection (DEP):

- no objection to the applications from environmental perspective, noting that the applications do not involve heavy vehicle or dusty operation;

- should the applications be approved, approval conditions should be included to request the applicants to submit and implement a drainage proposal for each of the Sites to ensure that the proposed use will not cause adverse drainage impact on the adjacent areas, and implemented drainage facilities at the Sites shall be maintained at all times during the planning approval period; and
- her advisory comments are at **Appendix IV**.

5. Landscape

Comments of the Chief Town Planner/Urban Design and Landscape, Planning Department (CTP/UD&L, PlanD)

- no adverse comments on the applications from landscape planning perspective;
- the Sites are located in an area of rural inland plain landscape character mainly comprising village houses/domestic structures, vacant/unused land, and tree groups/tree clusters or vegetation area. The proposed use on each of the Sites is considered not entirely incompatible with the landscape character of their surroundings; and
- based on the site photos taken on 16.1.2026, the Sites are paved or partly paved, and currently vacant. No distinctive landscape resources are observed within the Sites. According to the Application Forms, no tree-felling will be involved at the Sites. Significant adverse landscape impacts arising from the proposed use on each of the Sites are not anticipated; and
- her advisory comments are at **Appendix IV**.

6. Building Matters

Comments of the Chief Building Surveyor/New Territories West, Buildings Department (CBS/NTW, BD):

- no objection to the applications; and
- his advisory comments are at **Appendix IV**.

7. Other Departments

The following government departments have no objection to/no comment on the applications:

- (a) Director of Fire Services (D of FS);
- (b) District Officer (North), Home Affairs Department (DO(N), HAD);
- (c) Chief Engineer/Construction, Water Supplies Department (CE/C, WSD);
- (d) Project Manager (North), Civil Engineering and Development Department (PM(N), CEDD); and
- (e) Head of the Geotechnical Engineering Office, Civil Engineering and Development Department (H(GEO), CEDD).

Recommended Advisory Clauses

- (a) prior planning permissions should have been obtained before commencing the proposed use on each of the application sites (the Sites);
- (b) failure to reinstate the Sites as required under the relevant approval condition upon expiry of the planning permission might constitute an unauthorized development under the Town Planning Ordinance and be subject to enforcement and prosecution actions;
- (c) to note the comments of the District Lands Officer/North, Lands Department (DLO/N, LandsD) that:
 - (i) the Sites comprise Old Schedule Agricultural Lots held under the Block Government Lease which contains the restriction that no structures are allowed to be erected without the prior approval of the Government. The proposed ingress/egress of the Sites is required to pass through Government land (GL) but no right of access via GL is granted to the Sites; and
 - (ii) the applicants should comply with all the land filling requirements imposed by relevant Government departments. GL should not be disturbed unless with prior approval;
- (d) to note the comments of the Commissioner for Transport (C for T) that the Sites are connected to Sha Tau Kok Road – Wo Hang via a section of a local access road which is not managed by the Transport Department. The land status of the local access road should be checked with LandsD. Moreover, the management and maintenance responsibilities of the local access road should be clarified with the relevant lands and maintenance authorities. Sufficient manoeuvring space within the Sites shall be provided. No vehicle is allowed to queue back to or reverse onto/from public road at any time during the planning approval period;
- (e) to note the comments of the Chief Highway Engineer/New Territories East, Highways Department (CHE/NTE, HyD) that:
 - (i) HyD is not/shall not be responsible for the maintenance of any access connecting the Sites and Sha Tau Kok Road – Wo Hang;
 - (ii) adequate drainage measures should be provided to prevent surface water running from the Sites to the nearby public roads and drains; and
 - (iii) the applicants should take adequate precautionary measures to avoid damaging roads, street furniture, drainage and slopes etc. maintained by his office. Damage caused to roads, street furniture, drainage and slopes etc. maintained by his office due to the proposed use shall be repaired to his satisfaction at the applicants' own costs;
- (f) to note the comments of the Director of Environmental Protection (DEP) that the applicants shall observe the requirements of the latest "Code of Practice on Handling Environmental Aspects of Temporary Uses and Open Storage Sites" to avoid causing nuisance to the surroundings and implement relevant mitigation measures listed in the Recommended Pollution Control Clauses for Construction Contracts (https://www.epd.gov.hk/epd/english/environmentinhk/eia_planning/guide_ref/rpc.html) during land filling;

- (g) to note the comments of the Chief Engineer/Mainland North, Drainage Services Department (CE/MN, DSD):
 - (i) the Sites are in an area where public sewerage connection is available. The Environmental Protection Department should be consulted regarding the sewage impact assessment and sewage treatment/disposal facilities for the proposed use;
 - (ii) the drainage facilities should be properly maintained at all times during the planning approval period and rectified if they are found inadequate/ineffective during operation;
 - (iii) the applicants should construct and maintain the proposed drainage facilities within or outside the Sites at their own expense;
- (h) to note the comments of the Chief Town Planner/Urban Design and Landscape, Planning Department (CTP/UD&L, PlanD) that approvals of the applications do not imply approvals of tree works such as pruning, transplanting and felling. The applicants are reminded to seek approvals for any proposed tree works from relevant department(s) prior to commencement of the works; and
- (i) to note the following comments of the Chief Building Surveyor/New Territories West, Buildings Department (CBS/NTW, BD) that:
 - (i) land filling works is building works under the control of the Buildings Ordinance (Cap. 123) (BO). Before the proposed filling of lands are to be carried out at the Sites, the prior approvals and consents of the Building Authority (BA) should be obtained, otherwise they are unauthorised building works (UBWs). An Authorized Person (AP) should be appointed as the co-ordinator for each of the proposed site formation in accordance with the BO; and
 - (ii) if any existing structure is erected on leased land without the approval of the BA, they are UBWs under the BO and should not be designated for any proposed use under the applications;
 - (iii) for the UBWs erected on leased land, enforcement action may be taken by BD to effect their removal in accordance with the prevailing enforcement policy against UBWs as and when necessary. The granting of any planning approval should not be construed as an acceptance of any existing building works or UBWs on the application sites under the BO;
 - (iv) before any new building works (including containers/open sheds as temporary buildings and demolition, etc.) are to be carried out at the Sites, prior approval and consent of the BA should be obtained, otherwise they are UBWs under the BO. An AP should be appointed as the co-ordinator for each of the proposed building works in accordance with the BO;
 - (v) if the proposed use under the applications is subject to issue of licenses, the applicants should be reminded that any existing structures at the Sites intended to be used for such purposes are required to comply with the building safety and other relevant requirements as may be imposed by the licensing authority; and
 - (vi) any temporary shelters or converted containers for office, storage, washroom or other uses are considered as temporary buildings are subject to the control of Part VII of the Building (Planning) Regulations.

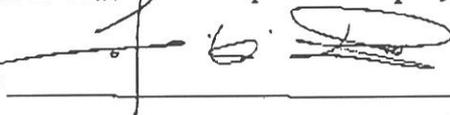


