行政摘要

根據城市規劃條例第16-III條作出規劃許可申請擬在新界大嶼山東涌丈量第1約地段1890RP及1886號

作為期3年的臨時康體文娛場所(休閒農莊)

- 1. 本擬議發展為農業用途(漁菜共生農場)。根據東涌谷分區計劃大綱核准圖編號 S/I-TCV/2申請地點現時被規劃作「住宅(丙類)」地帶。符合住宅(丙類)的規劃用途第二欄在有附帶條件或無附帶條件下獲准的用途「康體文娛場所」地帶的規劃意向。
  - 2. 申請地點的地盤面積約為 278.7平方米(不涉及政府土地)。將設有1個1層(高度不多7米)的約123.4平方米。總樓面面積約123.4平方米 的構築物。用作電錶房、接待處與學習中心、魚糞及魚具貯物室、農具貯物室。地點將提供 1個輕型貨車上落客貨車位及1個私家車車位。
  - 3. 本擬議發展為臨時性質。因此不會影響申請地點長遠作為住宅發展的發展。
  - 4. 為配合周邊的環境。申請用途的營業時間為每日早上九時到下午六時(已包括星期日及公眾假期)。
  - 5. 申請地點附近亦有農業相關構築物用途的先例：申請編號 A/I-TCV/17 作臨時商店及服務行業(蔬菜及雜貨店)連附屬辦公室及貯物用途。涉及面積約225.98 平方米的構築物。
  - 6. 城市規劃委員會近年屢次批准新界的「住宅(丙類)」地帶作為農業用途的規劃申請。因此申請人希望城市規劃委員會對本申請作出相同的對待。


