而在這個申請位置上用作地產中介寫字樓，二樓只是儲存有關地產行業的文件，並沒有上落貨物活動的。

另外關於有個公眾查詢問題，因上一個申請未能完成通過消防建議，是因為地政署在 2024 年足有 3 年半時間才批出開工紙，之後正式開始工程而申請水電設施需要一段長時間。在沒有任何建築物的情況下，所以未能完成消防裝備，在沒有任何商業活動情況下地政署由 2024 年已經開始徵收牌照費到現在。

並附上消防設備分佈圖。






