The Hong Kong Observatory (HKO) previously obtained approval from the Town Planning Board (TPB) for the proposed temporary office and warehouse uses on the application site (the site) for a period of three years to support radar replacement works. Although the replacement works have been completed, HKO continues to face operational requirements that necessitate renewal of the application. The justifications are outlined below -

1. The Annex Block Project, which aims to address the insufficient space at the HKO Headquarters site and to provide the essential space for future developments, is currently under construction and is expected to be completed in FY2029/30. Equipment and dismantled facilities originally located within the construction area require temporary storage until the project is completed. The captioned site provides an ideal location for such storage, offering readily available space and covered rooms.

2. The site is required to accommodate old parts originated from the dismantled weather radars at Tai Mo Shan and Tate's Cairn, which are pending disposal. As there is insufficient capacity at the radar stations and other HKO premises to store these items, the captioned site remains the most suitable option for temporary storage.

It is also confirmed that there is no change to the previously approved usage of the space. The site continues to serve as temporary storage and office accommodation to support HKO's operational needs.





We hereby submit Further Information to clarify the proposal under the captioned application and to confirm our responses to previous comments raised by Transport Department and Drainage Services Department.

Clarifications on the Application

Proposal

- The warehouse is mainly for accommodating equipment and dismantled facilities from the Annex Block construction site at the HKO Headquarters in Tsim Sha Tsui temporarily and old parts from the dismantled weather radars at Tai Mo Shan and Tate’s Cairn which are pending disposal.
- While the site is currently not used as an office, the possibility of office use will be retained to cater for any unforeseen operational needs. The potential office would accommodate a maximum of 25 HKO’s staff. Operating hours will be from 8:00 a.m. to 6:30 p.m., Mondays to Fridays, excluding Saturdays, Sundays and public holidays.
- No workshop activities will be undertaken at the site. The use will be limited to office accommodation for HKO staff and storage.

Justification

- The captioned site provides a suitable location for storage, offering readily available space and covered rooms, with Fire Service installations and equipment, security measures and regular tree pruning and cleansing services already in place under our management.
- The proposed development can fully utilise the vacant village school campus.
- The proposed development is on a temporary basis which will not frustrate the long-term planning intention of the “V” zone. The proposed use is not incompatible with the surrounding rural land uses.
- The proposed development will not induce adverse traffic, environmental, drainage and landscape impacts to the surrounding areas. Besides, we have complied with all the approval conditions imposed under the previous application.
