1. I am an indigenous villager of Chai Kek and the manager of Chung Yeung Tsit Tso. I apply for planning permission under section 16-3 of the Town Planning Ordinance.....
2. The application site is entirely within the village environs (“VE”) of Chai Kek and the village type development “V” Zone on Lam Tsuen Outline Zoning Plan S/NE-LT/11.
3. Car parking places are limited in Chai Kek. The car park does not open for public but only for local residents. It is opened for 24 hours in a day and 365 days including public holiday days in a year. It is also only for private cars with a valid motor vehicle licence.
4. The car park does not affect drainage and environment, and has no landscape impact.
5. Chai Kek Road of about 4.5 m wide is located immediately at east of the site providing the existing vehicular access to Lam Kam Road.
6. Town Planning Board granted a planning permission on private car park on subject site in March 2019 (TPB/A/NE-LT/661) and approved first renewal in March 2022 (TPB/A/NE-LT/714). Unfortunately, I missed the deadline to apply for extension of the planning permission in early 2025.
7. The site previously complied with planning approval conditions on providing boundary fencing on 11 December 2019, providing drainage facilities on 23 January 2020..... and providing grease trap and petrol interceptor on 1 September 2020.....


