Your preceding mail refers.

Regarding the comments from the Environment and Ecology Bureau (EEB), the applicant provides the following responses:

1. **Output Power of EV Chargers:**

The applicant will install ****3 nos.**** of EV chargers at the site. These are ****240kW DC Ultra-Fast Twin-gun Chargers**** (average 120kW per gun). These high-power chargers are intended to provide rapid charging services to maximize vehicle turnover.

2. **Compliance with HKPSG Chapter 8:**

To support the Government's policy, the applicant will:

* Prioritize the operation of the ****3 ultra-fast charging stations**** (total 6 charging nozzles) as the core facility.

* For the remaining parking spaces, the applicant will provide ****EV-ready infrastructure**** (including necessary conduits and trunking). This will facilitate the future installation of additional chargers with output power of not less than 7kW, subject to future market demand and technical assessment of the final power grid capacity.

3. **Power Supply Confirmation:**

As evidence of our commitment, the applicant has already applied to CLP for 3 separate ****400 AMP**** power supplies (Total 1200 AMP) to ensure sufficient loading for the high-speed charging infrastructure. Acknowledgement of our 3 applications from CLP are enclosed herewith for your information.
