Annex 1 Estimated Traffic Generation

- 1.2 The estimated average traffic generation and traffic generation rate at peak hours are as follow:

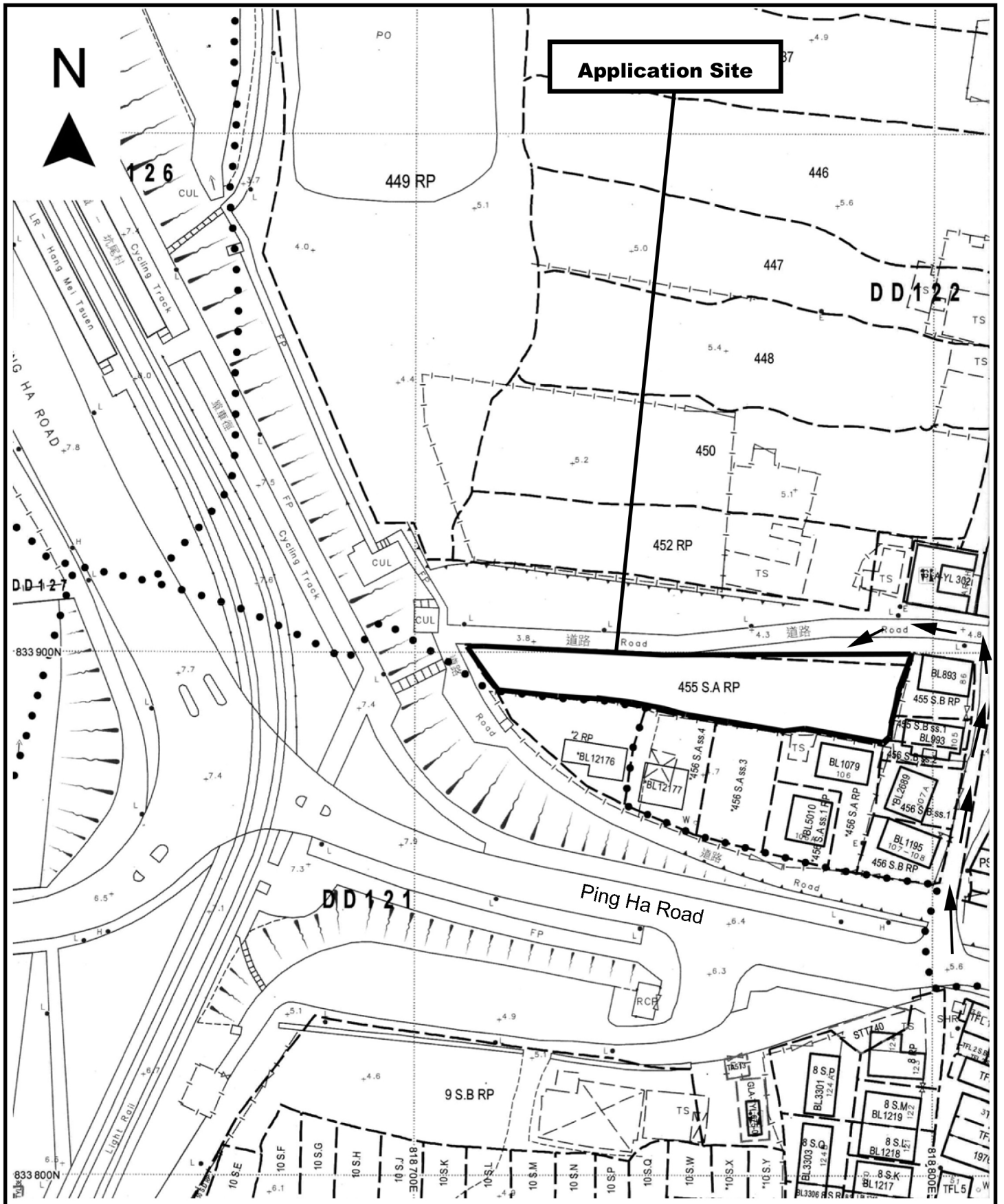

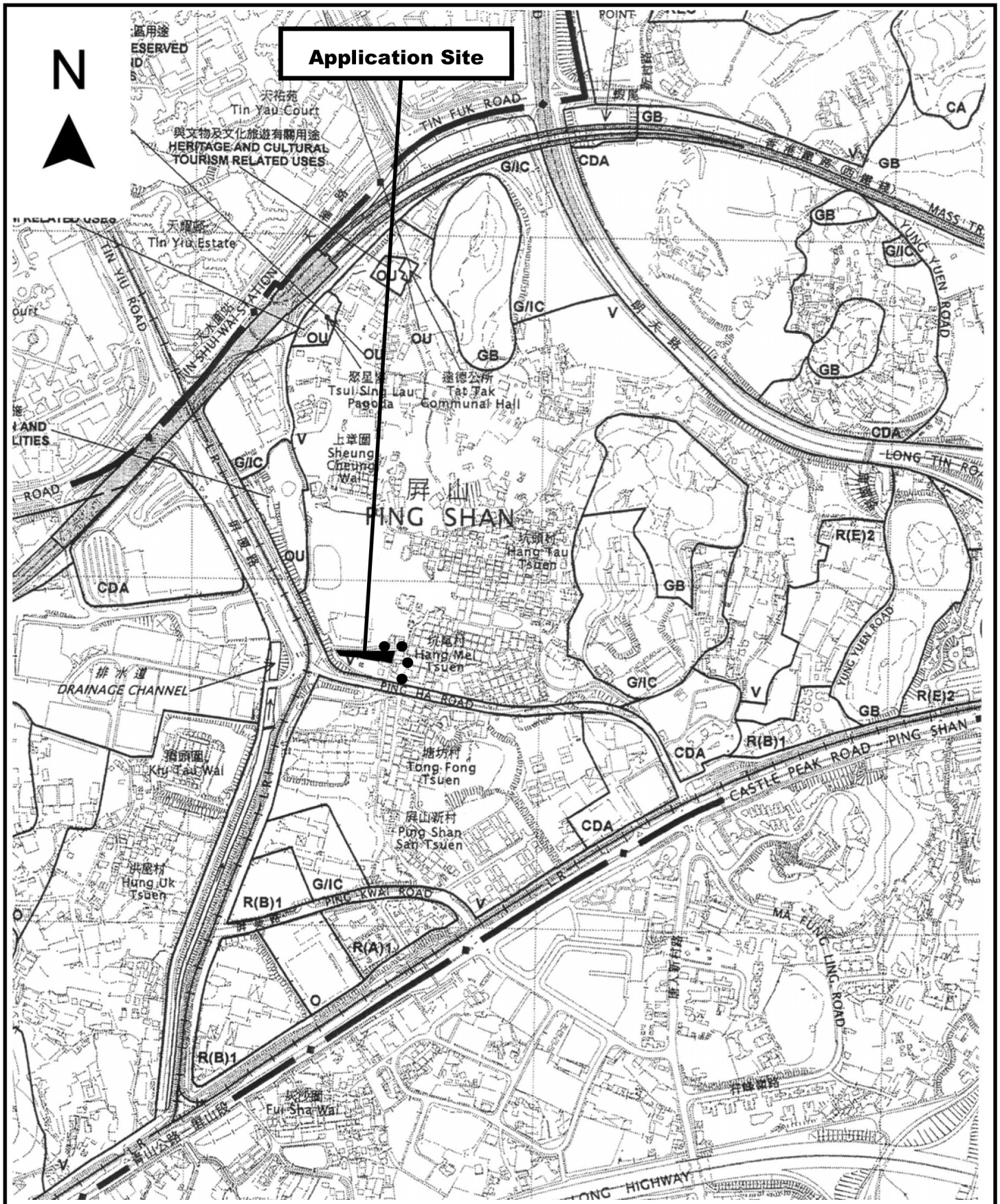

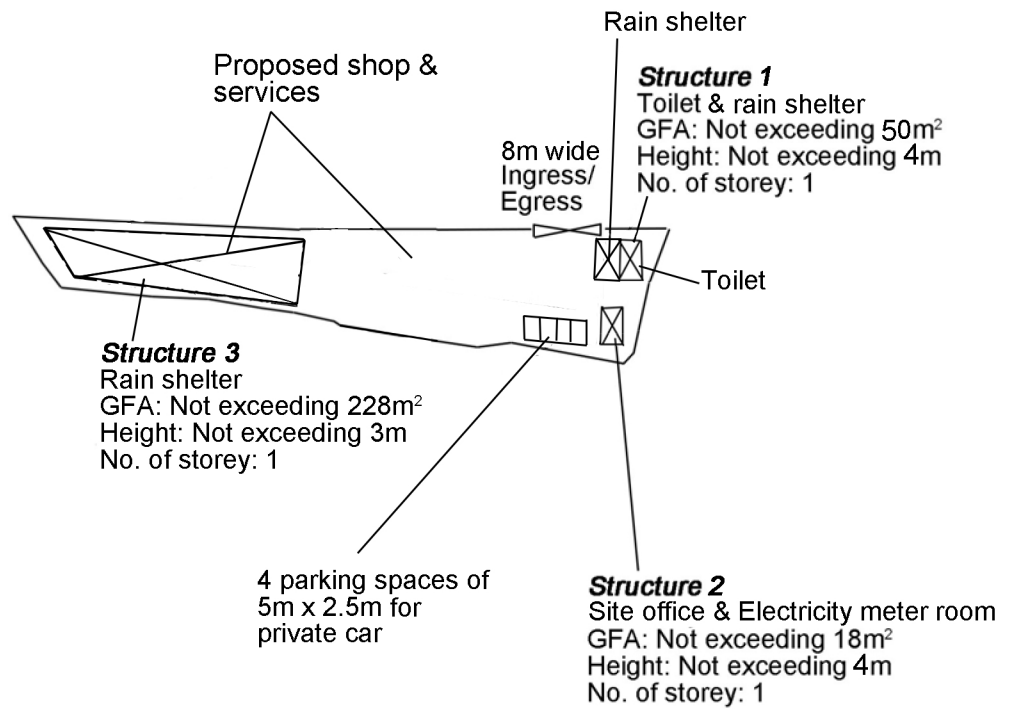
