**Historical backgrounds:**

1.1 The applicant Pang Garry Kuen Cheung (彭權章) submitted the planning application by himself to the Planning Board (TPB) on 26.11.2015 for proposed development of a New Territories Exempted House (NTEH)/Small House in Ma Mei Ha Leng Tsui, Fanling, N.T. The application site Lot 1759 S.B in D.D. 76 falls within an area zoned "Agriculture" (AGR) on the draft Lung Yeung Tau and Kwan Tei South Outline Zoning Plan No. S/NE-LYT/16.

1.2 The application (No. A/NE-LYT/584) was discussed and approved at Rural and New Town Planning Committee meeting (549<sup>th</sup>) on 22.1.2016. The validity of the planning permission set until 22.1.2020 with the approval conditions.

1.3. The applicant was staying aboard since the approval date of the application. Due to Covid -19 pandemic, he couldn't come back to Hong Kong for applying renewal or extension of the planning permission. Not until a recent notification from District Lands Office, North for the requisite of a valid planning permission in further processing his Small House application, this planning application is now submitted.

**Justifications:**


1. The applicant is the same applicant of planning application no. A/NE-LYT/584 approved by RNTPC of TPB on 22.1.2016.
2. The application is identical the same to the approved application no. A/NE-LYT/584 in terms of locality, uses, area, site coverage, building height and also the zonal uses at the application area of the current OZP No. S/NE-LYT/19.
3. There are no significant changes of the land profile, development on the application site and the adjoining area.
4. No material changes of this application with the approved application no. A/NE-LYT/584.
5. The applicant is an indigenous villager of Fanling Tsuen, Fanling, N.T.
6. The application site falls wholly within village environs of Ma Mei Ha Leng Tsui, Fanling which is under the jurisdiction boundary of Rural Committee of Fanling.
7. The application site is an infill site for a proposed New Territories Exempted House/Small House in a new cluster of village houses on the 'AGR' zone.
8. The applicant will plant trees and landscaping the uncovered area to enhance a green environment.
9. There are no river channels and stream courses close to the application site so the proposed NTEH development will not cause any environment and drainage Impacts.
10. The previous application (No. A/NE-LYT/584) of the same development/uses was approved on 22.1.2016 at RNTPC meeting (549<sup>th</sup>).

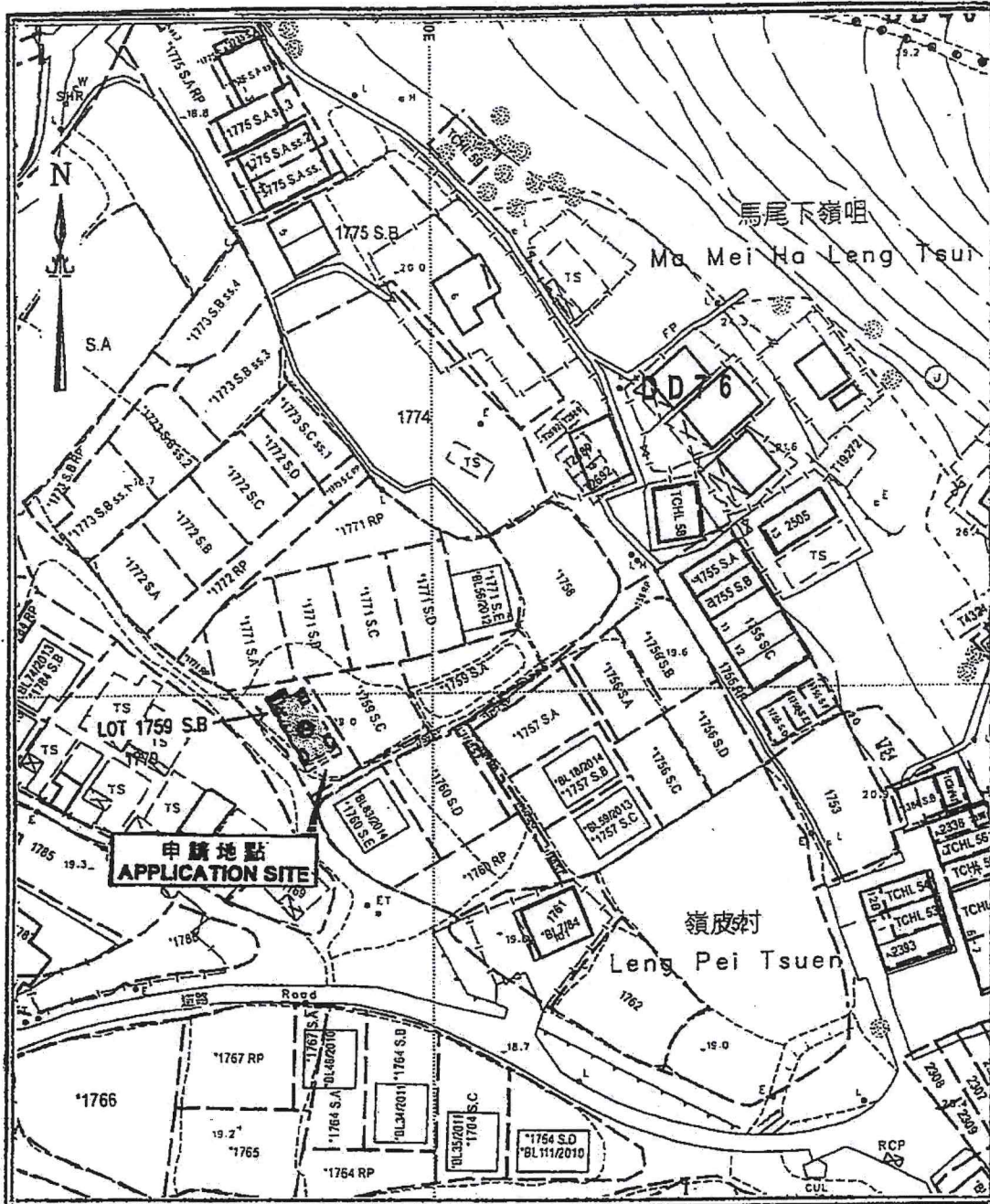
