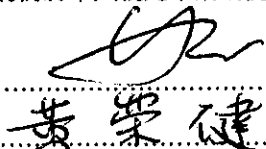
- 申請人經羅迅測計師行(Lawson David & Sung)於兩年前已向元朗地政處申請撥地發展住宅(丙類)2(註:見附夾元朗地政處 8/9/2025 有向換地信件),這申請最終獲批可能仍要等待一年半載。該處工作進度緩慢,真是有點差強人意!
- 2、在這漫長的等待期間,申請人去年二月曾在申請地點擺放車輛貨櫃等雜物,卻遭規劃署警告違例,事仲最終申請人糾正違例事宜,規劃署並沒有進一步行動(Ref.: () in CEP/E/YL-KTN/221)
- 3、現今整個新界元朗平原的土地,包括厦村,坪山,淡水橋及新田數十年經營的露天貯物用地,由於政府拓展城市发展,包括北部都會,東北發展等,已被政府大量徵收,弄到此類用地「買少見少」,民不聊生,現搬在新界找一幅合適的露天貯物用地,作為暫時存放車輛搬遷的用途,簡直是天方夜譚,絕有可能!
- 4、基於以上所述因由,既然撥地發展計劃須要時間去處理,而土地應該「地盡其用」,才合道理。搬遷用途的時間只是三個月,在情在理,敬希城市規劃委員會能夠審事求是,体谅民情,寬大處理,則不勝銘感!
- 5、就此初步預算,申請地點大概可以容納停泊擺放404部電動私家車輛(見附夾圖則)。該等車輛平常日子不會開駛進出申請地點,對錦泰路及週邊錦田公路等附近交通,絕對不會產生任何阻礙負荷。搬遷申請用途,亦不會對附近週邊環境做成任何滋擾。
- 6、申請地點不會用作維修汽車,增加電動車輛電池動能電量,洗車及其它拆卸汽車工業行為。
