UNDER SECTION 16 OF THE TOWN PLANNING ORDINANCE

APPLICATION NO. A/HSK/620

(for 1st Deferment)

- Applicant** : Honour Jet Development Limited represented by Llewelyn-Davies Hong Kong Limited
- Site** : Various Lots in D.D. 124 and adjoining Government Land (GL), Planning Area 32C (Southern and Lower Central Sites) of Hung Shui Kiu/Ha Tsuen New Development Area, Yuen Long
- Site Area** : About 17,503m² (including GL of about 96m² or 0.5%)
- Lease** : Block Government Lease (demise for agricultural use)
- Plan** : Draft Hung Shui Kiu and Ha Tsuen Outline Zoning Plan No. S/HSK/3
- Zonings** : (i) “Commercial (2)” (“C(2)”) (about 98.3%); and
[Restricted to a maximum plot ratio of 8 and a maximum building height of 200mPD]
(ii) area shown as ‘Road’ (about 1.7%)
- Application** : Proposed Mixed-Use Development (Proposed Flat with Permitted Commercial Uses)

1. Background

On 16.6.2026, the applicant sought planning approval for proposed mixed use development (proposed flat with permitted commercial uses) at the application site (**Plan A-1**). The application is scheduled for consideration by the Rural and New Town Planning Committee (the Committee) of the Town Planning Board (the Board) at this meeting.

2. Request for Deferment

On 30.7.2026, the applicant’s representative wrote to the Secretary of the Board and requested the Board to defer making a decision on the application for two months in order to allow time for preparation of further information (FI) to address departmental comments (**Appendix I**).

3. Planning Department's Views

- 3.1 The Planning Department has no objection to the request for the first deferment as the justification for deferment meets the criteria for deferment as set out in the Town Planning Board Guidelines on Deferment of Decision on Representations, Further Representations and Applications made under the Town Planning Ordinance (TPB PG-No. 33B) in that the deferment would allow the applicant to prepare FI to address outstanding issues.
- 3.2 Should the Committee agree to defer a decision on the application, the application will be submitted to the Committee for consideration within two months upon receipt of further submission from the applicant. If the FI submitted by the applicant is not substantial and could be processed within a shorter time, the application could be submitted to an earlier meeting for the Committee's consideration. The applicant should be advised that the Committee has allowed a period of two months for preparation of the submission of FI, and no further deferment would be granted unless under very special circumstances.

4. Decision Sought

The Committee is invited to consider whether or not to accede to the applicant's request for deferment. If the request is not acceded to, the application will be submitted to the Committee for consideration at the next meeting.
