Dear Mr. Chan,

Regarding the comments from DLO/TP, the applicant clarifies that the proposed structures under the current application are not the same as the unauthorized structures currently existing on the Site. There are some unauthorized structures on site that are located outside the application area. The lot owner is currently negotiating with the relevant occupier and has demanded the clearance of those structures. The applicant undertakes to ensure that all structures will strictly follow the proposed application plan and there will be no unauthorized structures on the site upon the granting of the planning permission.

In response to the landscape concerns raised by the Urban Design and Landscape Section, we are committed to providing landscape treatments. However, due to limited space and the need for vehicle access, the area for planting is restricted. We are willing to plant suitable shrubs as requested and hope for your understanding regarding the number of plants. We have attached a preliminary proposal for your review.

Additionally, we have attached the revised application form, as there have been minor adjustments to the site area and the locations of the structures. The structures outside the proposed application area are not involved in this application and will be removed by the occupier.

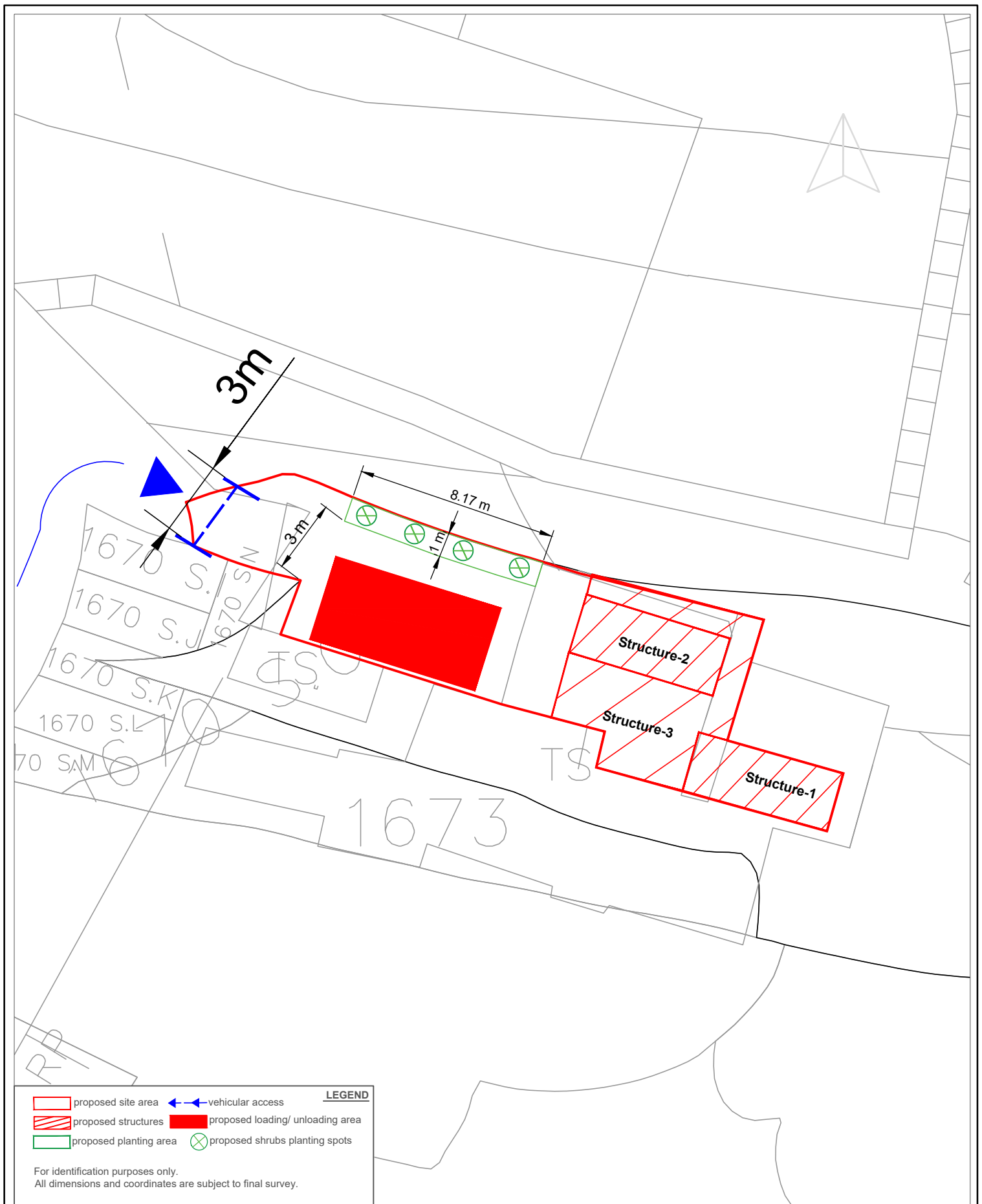
