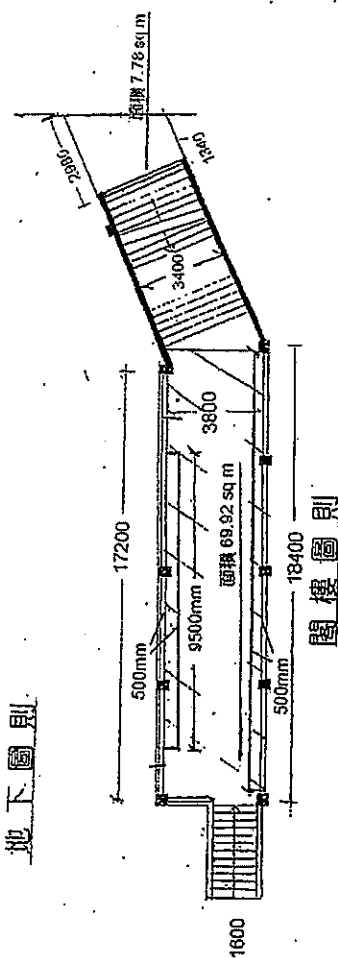

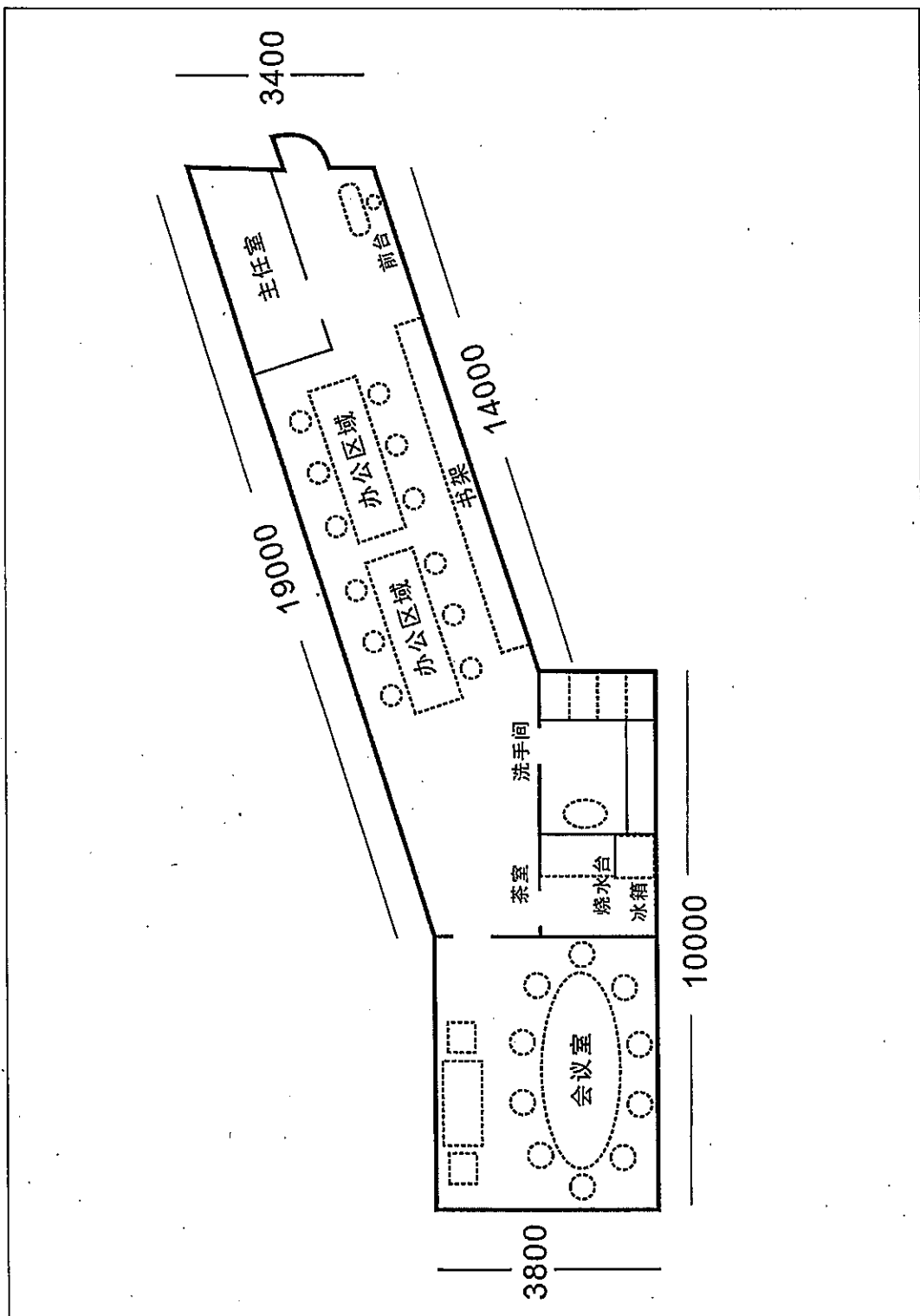

- The nearby North Point waterfront is a popular public space with public transportation interchange, residential development, hotel, shopping mall and community centre. Any environmental pollution including air, noise and water pollution from the proposed use would hinder the enjoyment from the user of this popular public open space.
- The proposed office use does not in line with the Urban Design Principles proposed by the Planning Department in 2019 under the *Urban Design Study for the Wan Chai North and North Point Harbourfront Areas*<sup>1</sup>.
- There are plenty of lands zoned as Commercial/Residential in North Point and land zoned as Commercial in Quarry Bay. We do not see any strong justification to approve this application for the proposed use.

Here we submit our concerns for your consideration.

**Recommended Advisory Clauses**

- (a) to note the comments of the Government Property Administrator that the tenant shall submit application for commercial concession for his consideration under the mechanism in the existing tenancy to implement the proposal. Such application, if received, will be circulated to relevant government departments for consideration and any approval given will be subject to terms and conditions based on the comments received;
- (b) to note the comments of the Director of Environmental Protection that the applicant is advised to install air conditioning system with fresh air intakes at the northern end of the pier as far as practicable to minimise potential air nuisances from the two air pollution sources i.e. ferry piers with ship emissions and the Island Eastern Corridor with vehicle emissions, in the vicinity of the application premises; and
- (c) to note the comments of the Director of Leisure and Cultural Services that the relevant operator of the proposed office is advised to make use of the loading and unloading area at the Harbour North and follow a specific route leading to the pier, and relevant operator(s), tenant(s) and stake-holder(s) of the said office should not induce adverse impact, such as hygienic problem on North Point Promenade and to the venue users.
