..The proposed tutorial school is located at Shop M3-201, Level 2, Kai Tak Mall 3, Kai Tak Sports Park, Kowloon City, Kowloon which is newly completed shopping mall building in the Kai Tak Sports Park. Although the whole district is zoned for "Other Specified Use (Stadium)", in the Kai Tak Outline Zoning Plan (No.: S/K22/8), the shopping mall is a building separating from stadium and is wholly for "retail" use.....

..The proposed school is not ordinarily school but it is a combination of tutorial teaching and recreation playing activities (e.g., skipping rope class and competition, etc.)

..The followings are the proposed tutorial information :

- School Area : 409.27 sq.m. (4,405 sq.ft)

..School Operation Hours : 11am - 7pm (Monday - Friday) and 11am - 6pm (Saturday)

- No. of Classrooms : 9 nos.

JUSTIFICATIONS :

a) Kai Tak area is a new district in Kowloon not only for sport stadium. Just adjacent to the Kai Tak Mall 3; there is a public housing which will be completed in 2025. After completion, there will generate a lot of household of youth families and children with great demands for education and tutorial schools. However, This part of Kai Tak is isolated and far away from any well-established districts with many education centres and tutorial schools, e.g., Kowloon and To Kwa Wan. Hence it is inadequate supply for this pressing needs for tutorial schools

b) The size of our proposed tutorial school is large in this new district to accommodate the coming big demands and pressing needs of students in the new housing estates nearby..

c) Our school teaching aim is to link the sports elements with the tutorial classes such that our students can obtain all-round knowledge, not just from books but also from the recreational sports. This shall be well compatible for the planning intention of the zoning:

d) The starting time and end time of our proposed school are not in the traffic peak hours. Hence there will not have any adverse impacts on the current pedestrian system and transportation infrastructure in the district.

e) We have notified the Kai Tak Sports Park Limited (the operator of Kai Tak Mall 3 under the government) via registered notification letter on 27 December 2024 that we intend to apply for planning permission under Section 16 of Town Planning Ordinance for tutorial school at the subject premises.







..The proposed tutorial school is located at Shop M3-101a, Level 1, Kai Tak Mall 3, Kai Tak Sports Park, Kowloon City, Kowloon which is newly completed shopping mall building in the Kai Tak Sports Park. Although the whole district is zoned for "Other Specified Use (Stadium)", in the Kai Tak Outline Zoning Plan (No.: S/K22/8), the shopping mall is a building separating from stadium and is wholly for "retail" use.....

..The proposed school is not ordinary school but it is a combination of tutorial teaching and recreation playing activities (e.g., skipping rope class and competition, etc.)

JUSTIFICATIONS :

a) Kai Tak area is a new district in Kowloon not only for sport stadium. Just adjacent to the Kai Tak Mall 3; there is a public housing which will be completed in 2025. After completion, there will generate a lot of household of youth families and children with great demands for education and tutorial schools. However, This part of Kai Tak is isolated and far away from any well-established districts with many education centres and tutorial schools, e.g., Kowloon and To Kwa Wan. Hence it is inadequate supply for this pressing needs for tutorial schools.....

b) The aim of our proposed tutorial school is to enhance the Chinese language of students which is rare in the district.

c) Our school teaching will link the sports elements with the tutorial classes such that students can obtain all-round knowledge, not just from books but also from the recreational sports. This shall be well compatible for the planning intention of the zoning.....

d) The starting time and end time of our proposed school are not in the traffic peak hours. Hence there will not have any adverse impacts on the current pedestrian system and transportation infrastructure in the district.....







BASIC INFORMATION :

...The proposed tutorial school is located at Shop M3-302, Level 3, Kai Tak Mall 3, Kai Tak Sports Park, Kowloon City, Kowloon which is newly completed shopping mall building in the Kai Tak Sports Park. Although the whole district is zoned for "Other Specified Use (Stadium)", in the Kai Tak Outline Zoning Plan (No.: S/K22/8), the shopping mall is a building separating from stadium and is wholly for "retail" use.

...The proposed school is not ordinarily school but it is a combination of tutorial teaching and recreation playing activities (e.g., skipping rope class and competition, etc.)

...The followings are the proposed tutorial information :

- School Area : 107.45 sq.m. (1,156.60 sq.ft)

...School Operation Hours : 11am - 7pm (Monday - Friday) and 11am - 6pm (Saturday)

- No. of Classrooms : 5 nos.

...Total Population : 25 nos. (max)

- Average Population Flow (estimate) : 16 nos. per hour

JUSTIFICATIONS :

a) Kai Tak area is a new district in Kowloon not only for sport stadium. Just adjacent to the Kai Tak Mall 3; there is a public housing which will be completed in 2025. After completion, there will generate a lot of household of youth families and children with great demands for education and tutorial schools. However, This part of Kai Tak is isolated and far away from any well-established districts with many education centres and tutorial schools, e.g., Kowloon and To Kwa Wan. Hence it is inadequate supply for this pressing needs for tutorial schools.

b) The size of our proposed tutorial school in each classroom is small to cater students preferring small class tutorials which are big demands in the new housing estates nearby.

c) Our school teaching aim is to link the sports elements with the tutorial classes in TA such that students can obtain all-round knowledge, not just from books but also from the recreational sports. This shall be well compatible for the planning intention of the zoning.

d) The starting time and end time of our proposed school are not in the traffic peak hours. Hence there will not have any adverse impacts on the current pedestrian system and transportation infrastructure in the district.

e) We have notified the Kai Tak Sports Park Limited (the operator of Kai Tak Mall 3 under the government) via registered notification letter on 27 December 2024 that we intend to apply for planning permission under Section 16 of Town Planning Ordinance for tutorial school at the subject premises.






