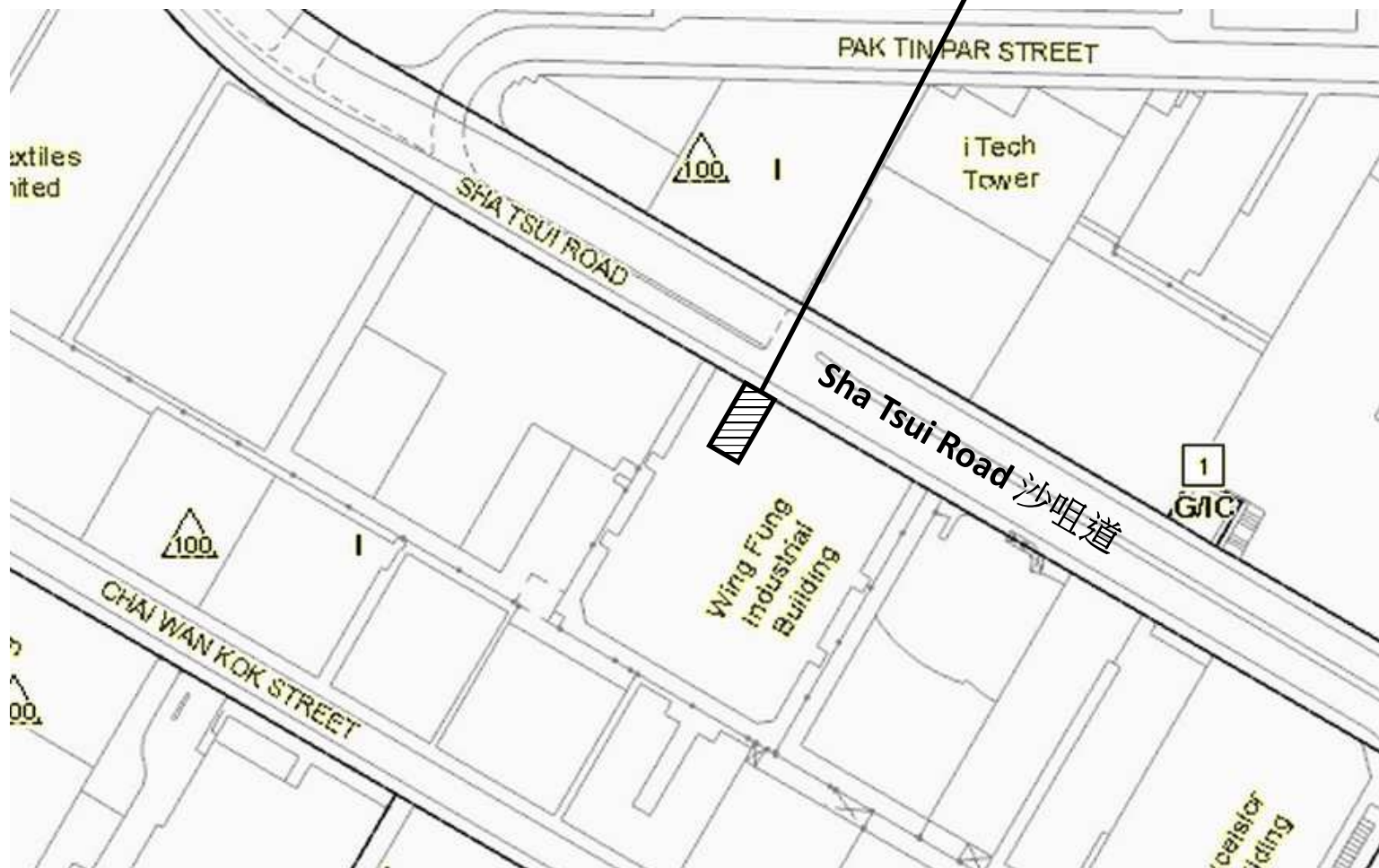

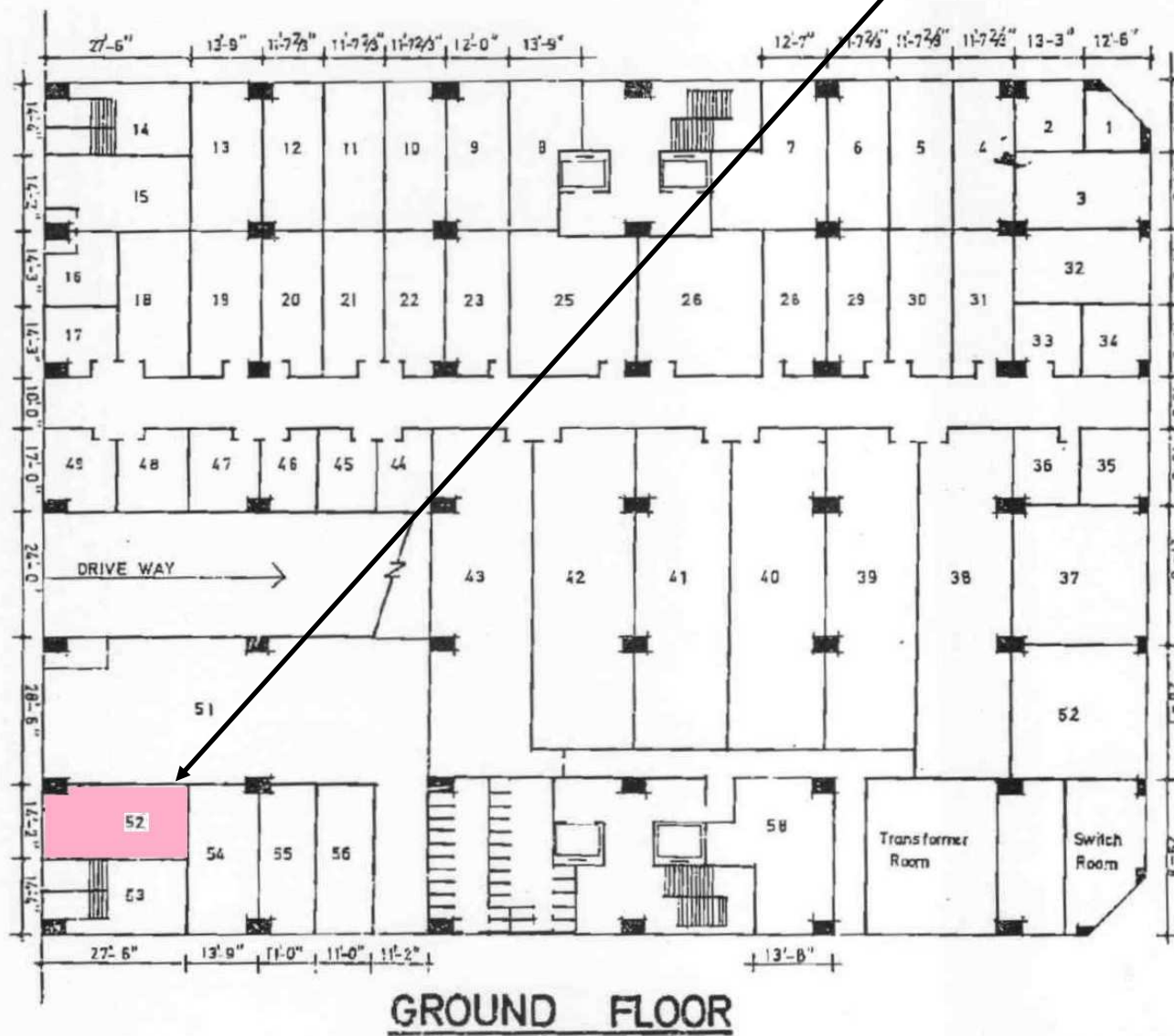

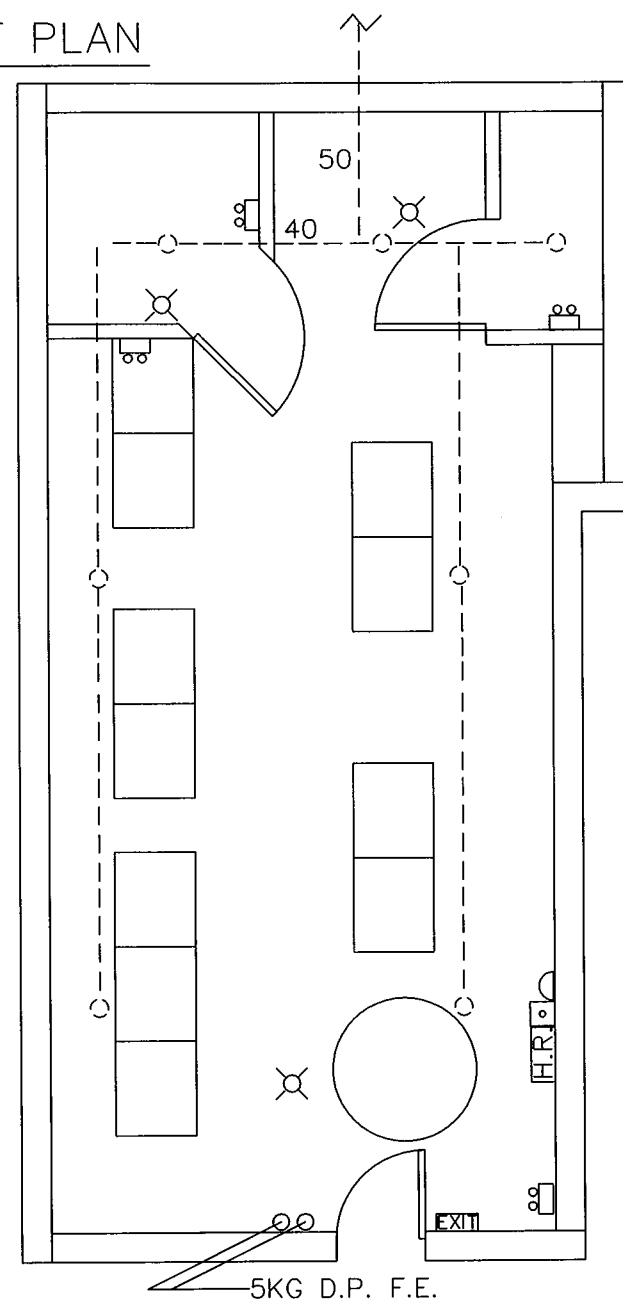

Approval Conditions

- (a) the submission and implementation of the fire safety measures including provision of a separate means of escape for and provision of fire service installations; and
- (b) if the above planning condition was not complied with before operation of the use / by the specified date, the approval hereby given should cease to have effect and should on the same date be revoked without further notice.

Recommended Advisory Clauses

- (a) to note the comment of the Director of Fire Services:

the applicant's attention is drawn to the 'Guidance Note on Compliance with Planning Condition on Provision of Fire Safety Measures for Commercial Uses in Industrial Premises' if the application is approved. For compliance with fire safety requirements for the application, the applicant should be advised to provide 2 sets of layout plan of the subject premises with FS Notes and certificate of FSI (FS 251) demonstrating the annual maintenance of the required FSIs in accordance with the Guidance Note on Compliance with Planning Condition on Provision of Fire Safety Measures for Commercial Uses in Industrial Premises.

- (b) to note the comments of the Chief Building Surveyor/New Territories West, Buildings Department that under the Buildings Ordinance (BO):

- (i) no person shall commence or carry out any building works without having first obtained approval and consent from the Building Authority before commencement of works unless they are exempted under s.41 of the BO, or fall within minor works under the Building (Minor Works) Regulation;
- (ii) any proposed building works should comply with the prevailing requirement under the BO and allied regulations and Code of Practices;
- (iii) adequate sanitary fitments complying with the Building (Standards of Sanitary Fitments, Plumbing, Drainage Works and Latrines) Regulations should be provided to the shop and services areas; and
- (iv) detailed comments will be given in the building plan submission stage.
