<b><u>Plan</u></b>	: Draft Kennedy Town and Mount Davis Outline Zoning Plan (OZP) No. S/H1/21
<b><u>Application Site</u></b>	: Inland Lot No. 7704 RP (Part)
<b><u>Site Area</u></b>	: about 22,170m <sup>2</sup>
<b><u>Land Status</u></b>	: Inland Lot No. 7704 RP (Part) and Government Land

<b><u>Proposed Amendment</u></b>	: To rezone the application site from “G/IC”, “GB” and area shown as ‘Road’ to “G/IC (2)”

**1. Background**

On 11.8.2021, the Town Planning Board (the Board) received a planning application to seek planning permission to rezone the application site (**Plan Z-1**) from “G/IC”, “GB” and area shown as ‘Road’ to “G/IC (2)” on the draft Kennedy Town and Mount Davis Outline Zoning Plan (OZP) No. S/H1/21 to facilitate a proposed academic complex development. The application is scheduled for consideration by the Metro Planning Committee (the Committee) of the Board at this meeting.

## **2. Request for Deferment**

On 28.9.2021, the applicant's representative wrote to the Secretary of the Board and requested the Board to defer making a decision on the application for a period of two months in order to allow sufficient time for the applicant to address departmental comments and submit further information (FI) accordingly (**Appendix I**).

## **3. Planning Department's Views**

- 3.1 The Planning Department has no objection to the request for the first deferment as the justifications for deferment meet the criteria for deferment as set out in the Town Planning Board Guidelines on Deferment of Decision on Representations, Comments, Further Representations and Applications made under the Town Planning Ordinance (TPB PG-No. 33A)<sup>1</sup> in that the applicant needs more time to prepare FI to address departmental comments, the deferment period is not indefinite, and the deferment would not affect the interests of other relevant parties.
- 3.2 Should the Committee agree to defer a decision on the application, the application will be submitted to the Committee for consideration within three months upon receipt of FI from the applicant. If the FI submitted by the applicant is not substantial and can be processed within a shorter time, the application could be submitted to an earlier meeting for the Committee's consideration. The applicant should be advised that the Committee has allowed a period of two months for preparation of FI, and no further deferment would be granted unless under very special circumstances.

## **4. Decision Sought**

The Committee is invited to consider whether or not to accede to the applicant's request for deferment. If the request is not acceded to, the application will be submitted to the Committee for consideration at the next meeting.
