- Convivial open space for resident/ public use & gathering place for all.
- Acting as a central link along the "heritage/ cultural axis" between Tin Hau Temple and Lei Yue Mun Barracks.
- Meandering path from Miu Tung Street to A Kung Ngam Road with intermittent resting spaces & landscape feature to provide tranquil & enjoyable journey for people - a modern interpretation of traditional Chinese landscape.
- Iconic tree as anchor point of the open space.
- Overall spatial arrangement likened to a traditional Chinese Painting with overlapping landscape layers & yet represented in a 'Minimalist' manner.
- Fenestration design of shuttle lift tower to pay homage of the brick pattern and to echo the green glazed tile roof (青瓦頂) of Tin Hau Temple.
- Inclusion of species like 羅漢松, 桂花,山茶 & 鋪地柏 etc. in planting design to enhance the Chinese theme & atmosphere.
- Synthetic timber pergola & landscape feature near the central plaza as well as along the periphery wall is a reminiscence of traditional Chinese timber construction adopted in the roof construction of Tin Hau Temple.
- The steps will be equipped with synthetic wooden railing to enhance the safety of future users, especially the elderly.
