Annex 1 DRAINAGE PROPOSAL

1.1 Existing Situation

A. Site particulars

- 1.1.1 The application site had been paved and occupied an area of about 2,900m².
- 1.1.2 The application site is occupied for the parking of vehicle and ancillary vehicle repair workshop at the moment. The land to the east is also occupied for parking of vehicles. A public road is found to the west of the site. Some temporary structures are found to the north of the application site.
- B. Level and gradient of the subject site & proposed surface channel
- 1.1.3 The lowest point of the site is at the northwestern part which is about +7.9mPD. The highest point at the site is at the southeastern part which is about +8.3mPD.
- C. Catchment area of the proposed drainage provision at the subject site
- 1.1.4 According to **Figure 4**, it is noted that the land to the north, east and west of the application site commands a lower level. The land to the south until Castle Peak Road (which is served by public drainage) commands a higher level than the application site.
- 1.1.5 As such, an external catchment as shown in **Figure 4** is taken into account when designing the drainage facilities for the proposed development.
- D. Particulars of the existing drainage facilities to accept the surface runoff collected at the application site
- 1.1.6 As shown in **Figure 4** and photos in Annex 2, an open drain is found to the north of the application site. It flow to the west and eventually joins the public drain.

1.2 Runoff Estimation

1.2.1 Rational method is adopted for estimating the designed run-off

$$Q = k \times i \times A/3,600$$

- i. The area of the entire catchment is approximately 3,760m² including the application site which is about 2,900m²; (Figure 4)
- ii. Though the catchment is predominant rural in character, it is assumed that the value of run-off co-efficient (k) is taken as 1.

With reference to the Intensity-Duration-Frequency Curves provided in the abovementioned manual, the mean rainfall intensity (i) for 1 in 50 recurrent flooding period is found to be 250mm/hr

In accordance with the Chart or the Rapid Design of Channels in "Geotechnical Manual for Slopes", 525mm surface U-channel at 1:260 gradient is considered adequate to dissipate all the stormwater accrued by the application site and adjacent land.

1.3 Proposed Drainage Facilities

- 1.3.1 Subject to the calculations in 1.2 above, it is determined that proposed 525mm concrete surface U-channel at gradient of about 1:260 along the site periphery is adequate to intercept storm water passing through and generated at the application site (Figure 4).
- 1.3.2 The collected stormwater will then be discharged to the existing 600mm surface drain to the north of the application site.
- 1.3.3 All the proposed drainage facilities will be provided and maintained at the applicant's own expense. Also, surface channel will be cleaned at regular interval to avoid the accumulation of rubbish/debris which would affect the dissipation of storm water.

- 1.3.4 Sand trap or alike will be provided at the terminal catchpit so as to avoid the addition of load to the public drainage.
- 1.3.5 All the proposed drainage facilities will be constructed and maintained at the expense of the applicant.
- 1.3.6 The development would neither obstruct overland flow nor adversely affect existing natural streams, village drains, ditches and the adjacent areas, etc.
- 1.3.7 We would consult District Lands Officer/North (DLO/N) and seek consent from the relevant owners for any drainage works to be carried out outside our lot boundary before commencement of drainage works.
- 1.3.8 All proposed works at the site periphery would not obstruct the flow of surface runoff from the adjacent areas, the provision of trees and surface channel at site boundary is detailed hereunder:
 - (a) Soil excavation at site periphery, although at minimal scale, is inevitably for the provision of surface channel and landscaping. In the reason that the accumulation of excavated soil at the site periphery would obstruct the free flow of the surface runoff from the surroundings, the soil will be cleared at the soonest possible after the completion of the excavation process.
 - (b) In view of that soil excavation may be continued for several working days, surface channel will be dug in short sections and all soil excavated will be cleared before the excavation of another short section.
 - (c) No leveling work will be carried at the site periphery. The level of the site periphery will be maintained during and after the works. As such, the works at the site periphery would not either alter or obstructed the flow of surface runoff from adjacent areas.
 - (d) Openings will be provided at the toe of hoarding so as to allow unobstructed flow of surface runoff from adjacent area.

Annex 3 Estimated Traffic Generation

- 3.1 The application site is abutting Castle Peak Road Kwu Tung. - 3.2 The estimated average traffic generation and traffic generation rate at peak hours are as follow:

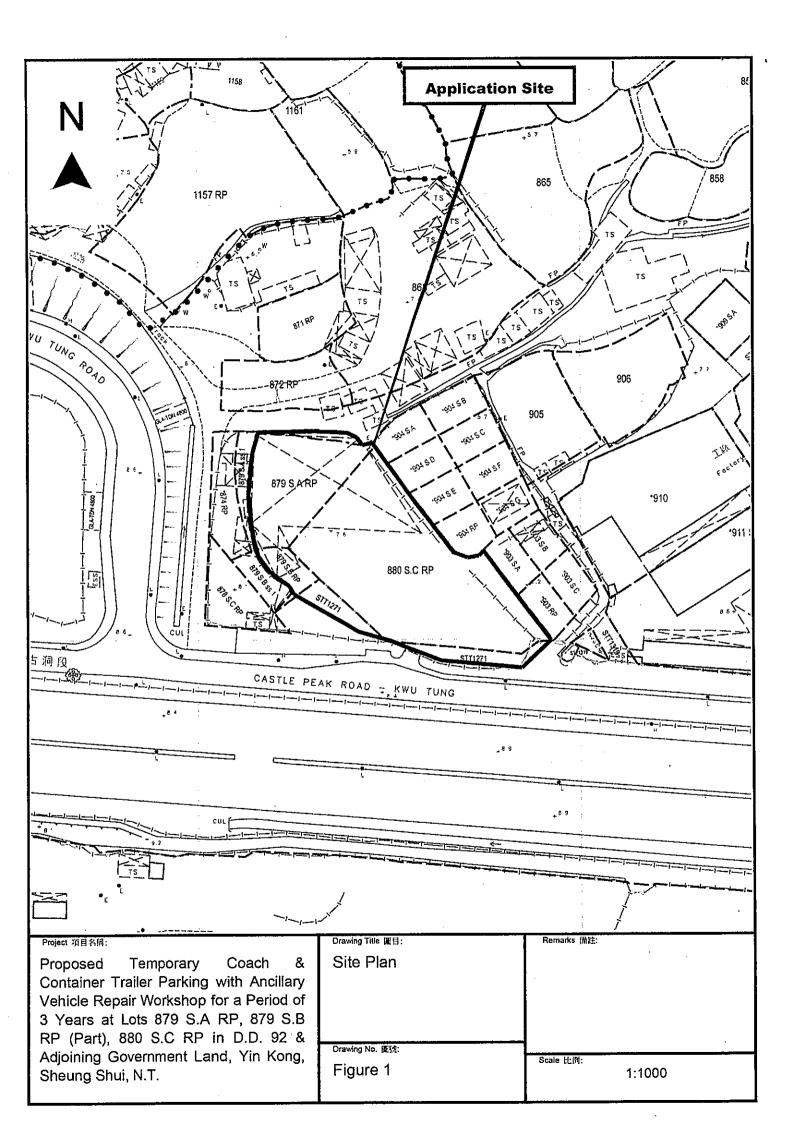

Relevant Extracts from the Town Planning Board Guidelines for Application for Open Storage and Port Back-up Uses (TPB PG-No. 13F)

3. Applications in New Development Areas (NDAs)

- 3.1. The planning for various NDAs (including potential development areas) in the New Territories has been in progress and the land use proposals for some of these areas have been incorporated as appropriate into relevant statutory town plans. The NDAs will be implemented by phases. While it is envisaged that the existing open storage and port back-up uses in these areas will be gradually phased out, sympathetic consideration may be given to applications for continued operation of these uses during the interim period before the sites are required for NDA development. For applications in NDAs with new/amended OZPs gazetted, the assessment criteria set out in the following paragraphs, instead of those in paragraph 2.1 above, should be adopted.
- 3.2. For existing open storage and port back-up uses with previous planning approval(s) and/or permitted under the previous OZPs, sympathetic consideration may be given to the application (irrespective of whether the application is submitted by the applicant of previous approval or a different applicant) until the concerned site is required for implementation of NDA development, provided that the relevant approval conditions, if any, have been complied with. Technical assessments, where appropriate, should be submitted to demonstrate that the continued operation of the current uses would not have adverse drainage, traffic, visual, landscaping and environmental impacts on the surrounding areas and the concerns of the departments and local residents, if any, can be addressed through the implementation of the approval conditions.
- 3.3. In view of the impending implementation of NDAs, new open storage and port back-up uses are generally not encouraged to infiltrate into the NDAs. There is a general presumption against such uses at greenfield areas and/or at sites with land use compatibility issue, e.g. in close proximity to existing residential dwellings which may be subject to environmental nuisances caused by the OS and PBU uses. Applications will normally be

rejected unless under exceptional circumstances.

- 3.4. Any approved temporary use and development should not jeopardize the long-term planned development on the respective site/the surrounding area under the NDA and the applicant should be advised that the site would be required by the government at any time during the planning approval period for implementation of government projects.
- 3.5. The above paragraphs are applicable to areas covered by the Kwu Tung North/Fanling North NDA and Hung Shui Kiu/Ha Tsuen NDA, as well as future NDAs upon the gazetting of the relevant new/amended OZPs for such areas.

- The Site comprises of (i) Lots 879 S.A RP, 879 S.B RP (Part) and 880 S.C RP in D.D. 92; (ii) Short Term Tenancy (STT) No. 1271; and (iii) the adjoining Government land (GL). The lots are Old Schedule agricultural lots held under Block Government Lease. The applicant should make his own arrangement for acquiring access to the Site, and there is no guarantee that any adjoining GL will be allowed for vehicular access to the Site for the applied use.
- The said private lots are also covered by a Short Term Waiver (the STW) No. 1413 for the purpose of a lorry and container trailer park. STT is let for the purpose of lorry and container trailer park. The applicant is not the waiveree of the STW nor the tenant of the STT.
- Our site inspection revealed that the use and the built-over area of the existing structures on site do not tally with those permitted under the STW and the STT. His office reserves the right to take enforcement action against the STW and the STT as appropriate.
- The actual occupation area does not tally with the Site. A portion of adjoining GL outside the Site is fenced off without approval from his office. The application should cease the occupation of the GL concerned. His office reserves the right to take necessary land control actions against the irregularities on GL as appropriate.
- His advisory comments are at Appendix VI.

2. Drainage

Comments of the Chief Engineer/Mainland North, Drainage Services Department (CE/MN, DSD):

- No objection to the application.
- Should the application be approved, conditions should be included to request the applicant to submit and implement a drainage proposal for the Site to ensure that it will not cause adverse drainage impact to the adjacent area; and the implemented drainage facilities at the Site shall be maintained at all times.
- The Site is in an area where no public sewerage connection is available.
- His advisory comments are at Appendix VI.

3. Landscape

Comments of the Chief Town Planner/Urban Design and Landscape, Planning Department (CTP/UD&L, PlanD):

- She has no objection to the application. Based on the aerial photo of 2021 and site photos in July 2022, it is observed that there is no significant change in the landscape character of the adjacent area since the last application (No. A/KTN/67). There is no significant change in the major development parameters and layout of this application when compared to that in the previous approved one. Besides, existing trees of common species within the Site are generally in fair condition and will be preserved. Further adverse landscape impact arising from the development within the Site is not anticipated.
- Her advisory comments are at Appendix VI.

4. Fire Safety

Comment of the Director of Fire Services (D of FS):

- He has no objection in principle to the application subject to fire service installations (FSI) being provided to his satisfaction.
- His advisory comments and comments on the FSI proposal are at Appendix VI.

5. Other Departments

• Commissioner for Transport, Chief Building Surveyor/New Territories West, Buildings Department, Chief Estate Surveyor/ New Development Area, LandsD, Head of Geotechnical Engineering Office, CEDD, Chief Highway Engineer/New Territories East, Highways Department, Commissioner of Police and Chief Engineer/Construction, Water Supplies Department have no comment on/ no objection to/ no adverse comment on the application and their advisory comments, if any, are in Appendix VI.

Recommended Advisory Clauses

- (a) The Site falls within the Remaining Phase of Kwu Tung North New Development Area project. The Site may be resumed by the Government at any time during the planning approval period for the implementation of government projects.
- (b) Prior planning permission should have been obtained before commencing the development at the Site.
- (c) The planning permission is given to the development/uses under application. It does not condone any other development/uses which currently exist on the Site but not covered by the application. The applicant shall be requested to take immediate action to discontinue such development/use not covered by the permission.
- (d) Should the applicant fail to comply with the approval conditions again resulting in the revocation of the planning permission, sympathetic consideration would not be given by the Committee to any further application.
- (e) To note the comment of District Lands Officer/North, Lands Department that:
 - The applicant should make his own arrangement for acquiring access to the Site, and there is no guarantee that any adjoining Government Land (GL) will be allowed for vehicular access to the Site for the proposed use.
 - The use and the built-over area of the existing structures on site do not tally with those permitted under the Short Term Waiver ("STW") and Short Term Tenancy ("STT"). His office reserves the right to take enforcement action against the STW and the STT as appropriate.
 - The actual occupation area does not tally with the Site. A portion of adjoining GL outside the Site is fenced off without approval from his office. The applicant should cease the occupation of the GL concerned. His office reserves the right to take necessary land control actions against the irregularities on GL as appropriate.
 - Any proposed toilet facility should meet the current health requirements.
 - The applications for STW and Short Term Tenancy STT submitted by the lot owner to regularize the unauthorized structures on the Site and to cover all the actual occupation area will be considered by the Government in its landlord's capacity. There is no guarantee that they will be approved. If they are approved, their commencement date would be backdated to the first date of occupation and they will be subject to such terms and conditions to be imposed including payment of waiver fee/rent and administrative fees as considered appropriate by his office.
- (f) To follow the environmental mitigation measures as set out in the latest "Code of Practice on Handling the Environmental Aspects of Temporary Uses and Open Storage Sites" issued by the Director of Environmental Protection.

- (g) To note the comments of the Chief Engineer/Mainland North, Drainage Services Department:
 - The application is advised the following general requirements in the drainage proposal:
 - i. Surface channel with grating covers should be provided along the site boundary.
 - ii. A drainage plan should be provided clearly showing the size, levels and routes of the proposed drainage. The details (invert level, gradien, general sections etc.) of the proposed drain/ surface channel, catchpits and the discharge structure shall be provided.
 - iii. The cover levels of proposed channels should be flush with the existing adjoining ground level.
 - iv. A catchpit with covers should be provided where there is a change of direction of the channel/ drain. The details of the catchpit with covers shall be provided.
 - v. Catchpits with sand trap shall be provided at the outlets of the proposed drainage system. The details of the catchpit with sand trap should be provided.
 - vi. The applicant should check and ensure that the existing drainage downstream to which the proposed conection will be made have adequate capacity and satisfactory condition to cater for the additional discharge from the Site. The applicant should also ensure that the flow from this Site will not overload the existing drainage system.
 - vii. Where walls are erected or kerbs are laid along the boundary of the same, peripheral channels should be provided on both sides of the walls or kerbs, and/ or adequate openings should be provided at the walls/ kerbs to allow existing overland flow passing through the Site to be intercepted by the drainage system of the Site with details to be agreed by his office, unles justified not necessary.
 - viii. All existing flow paths as well as the run-off falling onto and passing through the Site should be intercepted and disposed of via proper discharge points. The applicant shall also ensure that no works, including any site formation works, shall be carrid out as may adversely interfere with the free flow condition of the existing drains, channels and watercourses on or in the vicinity of the Site any time during or after the works.
 - ix. The proposed drainage works, whether within or outside the site boundary, should be constructed and maintained properly by the applicant and rectify the system if it is found to be inadequate or ineffective during operation at his/her own expense.
 - x. For works to be undertaken outside the lot boundary, the applicant

- should obtain prior consent and agreement from District Lands Officer/North, Lands Department and/ or relevant private lot owners.
- xi. The applicant should make good all the adjacent affected areas upon the completion of the drainage works.
- xii. The applicant shall allow all time free access for the Government and its agent to conduct sire inspection on his completed drainage works.
- xiii. The applicant and the successive lot owners shall allow connections from the adjacent lots to the completed drainage works on GL when so required.
- xiv. Photos should be submitted clearly showing the current conditions of the area around the site, the existing drainage/ flowpaths around the site, the proposed drainage from the site to the downstream existing watercourse and the existing watercourse at about 20m intervals. The locations of the camera and the direction of each photo should also be indicated on a plan.
- (h) To note the comment of Chief Town Planner/Urban Design and Landscape, Planning Department that:
 - Approval of the application does not imply approval of tree works such as pruning, transplanting and felling under lease. The applicant is reminded to seek approval for any proposed tree works from relevant departments prior to commencement of works.
- (i) To note the comments of the Director of Fire Services that:
 - The applicant is advised to submit relevant layout plans incorporated with the proposed Fire Service Installations (FSI) to his department for approval.
 - The layout plan should be drawn to scale and depicted with dimensions and nature of occupancy and the location of where the proposed FSIs to be installed should be clearly marked on the layout plans.
 - If the proposed structure(s) is required to comply with the Building Ordinance (Cap. 123), detailed fire service requirements will be formulated upon receipt of formal submission of general building plans.
 - He has the following comments on the submitted FSI proposal:
 - i. Fire detection and alarm system shall be provided in accordance with BS 5839 Part 1:2017 and the FSD Circular Letter 4/2021.
 - ii. Schematic drawings will not be vetted at this stage and shall be omitted from future submission.
- (j) To note the comments of the Chief Building Surveyor/New Territories West, Buildings Department that:
 - If the existing structures are erected on leased land without approval of the Buildings

Department (BD) (not being a New Territories Exempted House), they are unauthorized under the Building Ordinance (BO) and should not be designated for any approved use under the application.

- Before any new building works are to be carried out on the Site, prior approval and consent of the Building Authority (BA) should be obtained unless they are exempted building works or commenced under the simplified requirement under the Minor Works Control System. Otherwise they are Unauthorized Building Works (UBW). An Authorized Person (AP) should be appointed as the coordinator for the proposed building works in accordance with the BO.
- For UBW erected on leased land, enforcement action may be taken by the BA to effect their removal in accordance with BD's enforcement policy against UBW as and when necessary. The granting of any planning approval should not be construed as an acceptance of any existing building works or UBW on the Site under the BO.
- If the proposed use under application is subject to the issue of a licence, any existing structures on the Site intended to be used for such purposes are required to comply with the building safety and other relevant requirements as may be imposed by the licensing authority.
- Any temporary shelters or converted containers for storage or office, canteen or other
 uses are considered as temporary buildings are subject to the control of Part VII of the
 Building (Planning) Regulations.
- The Site shall be provided with means of obtaining access thereto from a street under the Building (Planning) Regulation 5 and emergency vehicular access shall be provided under the Building (Planning) Regulation 41D.
- If the Site is not abutting on a specified street having a width not less than 4.5m, the development intensity shall be determined by the BA under Building (Planning) Regulation 19(3) at building plan submission stage.
- In general there is no requirement under the BO in respect of provision of car parking spaces for a proposed development. However, the applicant's attention is drawn to the provision of accessible car parking spaces designated for the use of persons with a disability as per the requirements under the Building (Planning) Regulation 72 and Division 3 of Design Manual: Barrier Free Access 2008 (BFA) if BFA requirements are applicable to the subject development.
- The applicant's attention is drawn to the provision under regulations 40 and 41 of the Building (Standards of Sanitary Fitments, Plumbing, Drainage Works and Latrines) Regulation in respect of disposal of foul water and surface water respectively.
- Formal submission under the BO is required for any proposed new works, including any temporary structures, site formation works like filing of ponds and land and site formation drainage works. Detailed comments under BO on individual sites for private developments such as permissible plot ratio, site coverage, emergency vehicular access, private streets and/or access roads, barrier free access and facilities, compliance with the sustainable building design guidelines (SBD), etc will be formulated at the formal building plan submission stage.
