1. Background

- 1.1 On 2.2.2021, the applicants seek planning permission to build a NTEH (Small House) on each of the application sites (**Plan A-1**).
- 1.2 On 26.3.2021, the Rural and New Town Planning Committee (the Committee) of the Town Planning Board (the Board) agreed to defer making a decision on the applications for two months, as requested by the applicants, to allow time for the applicants to prepare Further Information (FI) to address the departmental comments. The applicants submitted FI on 31.5.2021 to address the comments of Transport Department (TD). The applications are scheduled for consideration by the Committee on 23.7.2021.

2. <u>Request for Deferment</u>

On 16.7.2021, the applicants' representative wrote to the Secretary of the Board and requested the Board to defer the consideration of the applications for two months in order to allow time to prepare further information (FI) to address the comments of TD (**Appendix I**).

3. <u>Planning Department's Views</u>

- 3.1 The applications have been deferred once for two months at the request of the applicants to allow more time to address the departmental comments. Since the last deferment on 26.3.2021, the applicants have submitted FI on 31.5.2021 to address comments from TD. Nevertheless, the applicants need more time to prepare FI to address further comments from TD.
- 3.2 The Planning Department has no objection to the request for deferment as the justification for deferment meets the criteria for deferment as set out in the Town Planning Board Guidelines on Deferment of Decision on Representations, Comments, Further Representations and Applications made under the Town Planning Ordinance (TPB PG-No. 33) in that the applicants need more time to prepare FI to address the departmental comments, the deferment period is not indefinite, and the deferment would not affect the interests of other relevant parties.
- 3.3 Should the Committee agree to defer a decision on the applications, the applications will be submitted to the Committee for consideration within two months upon receipt of further submission from the applicants. If the FI submitted by the applicants is not substantial and can be processed within a shorter time, the applications could be submitted to an earlier meeting for the Committee's consideration. Since it is the second deferment of the applications, the applicants should be advised that the Committee has allowed a total of four months for preparation of submission of FI, and no further deferment would be granted unless under very special circumstances.

4. <u>Decision Sought</u>

The Committee is invited to consider whether or not to accede to the applicants' request for deferment. If the request is not acceded to, the applications will be submitted for the Committee's consideration at the next meeting.
