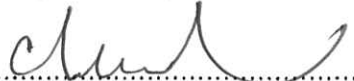

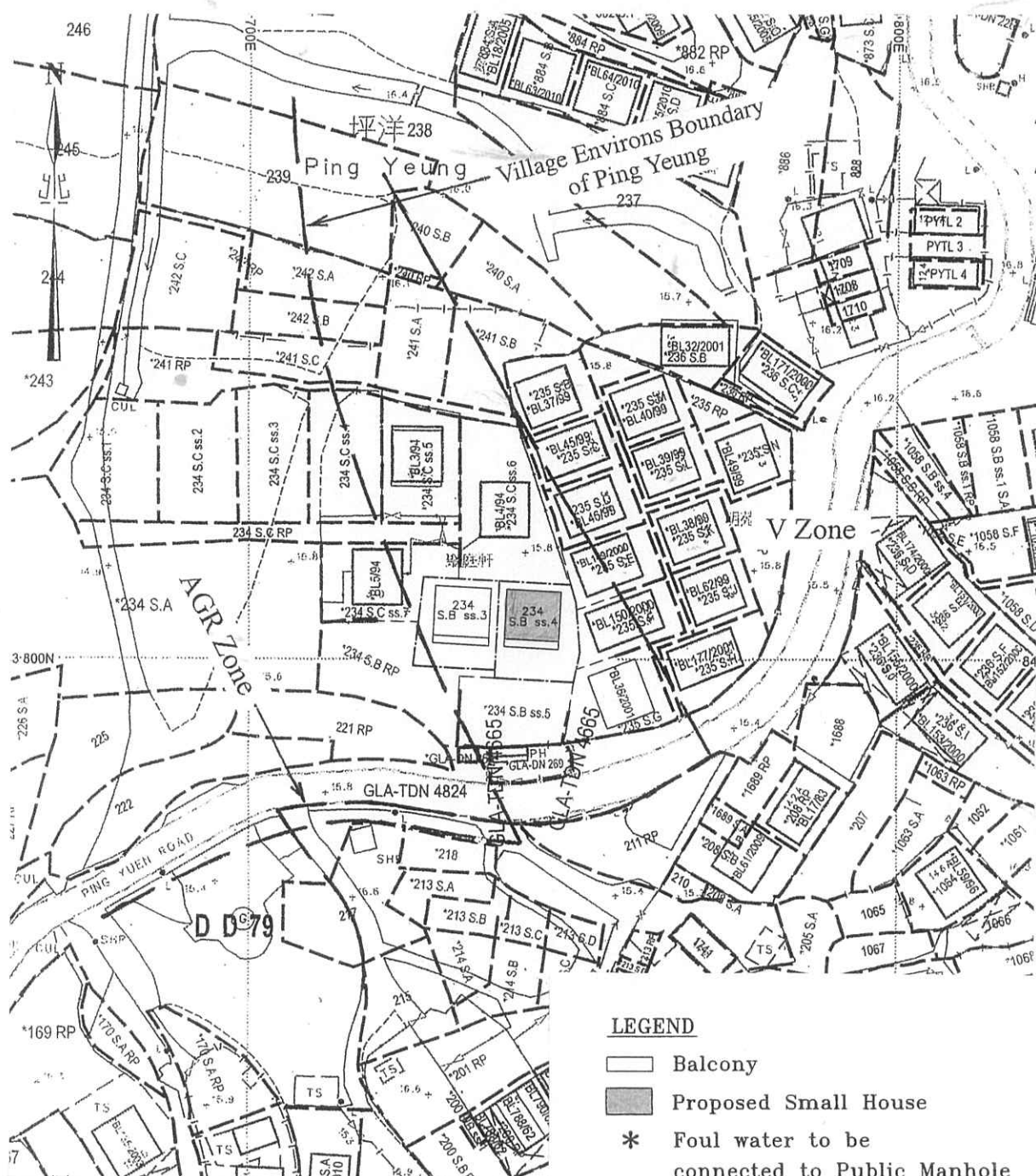

Proposed Small House Plan of Lot No. 234 S.B ss.4 in D.D. 79



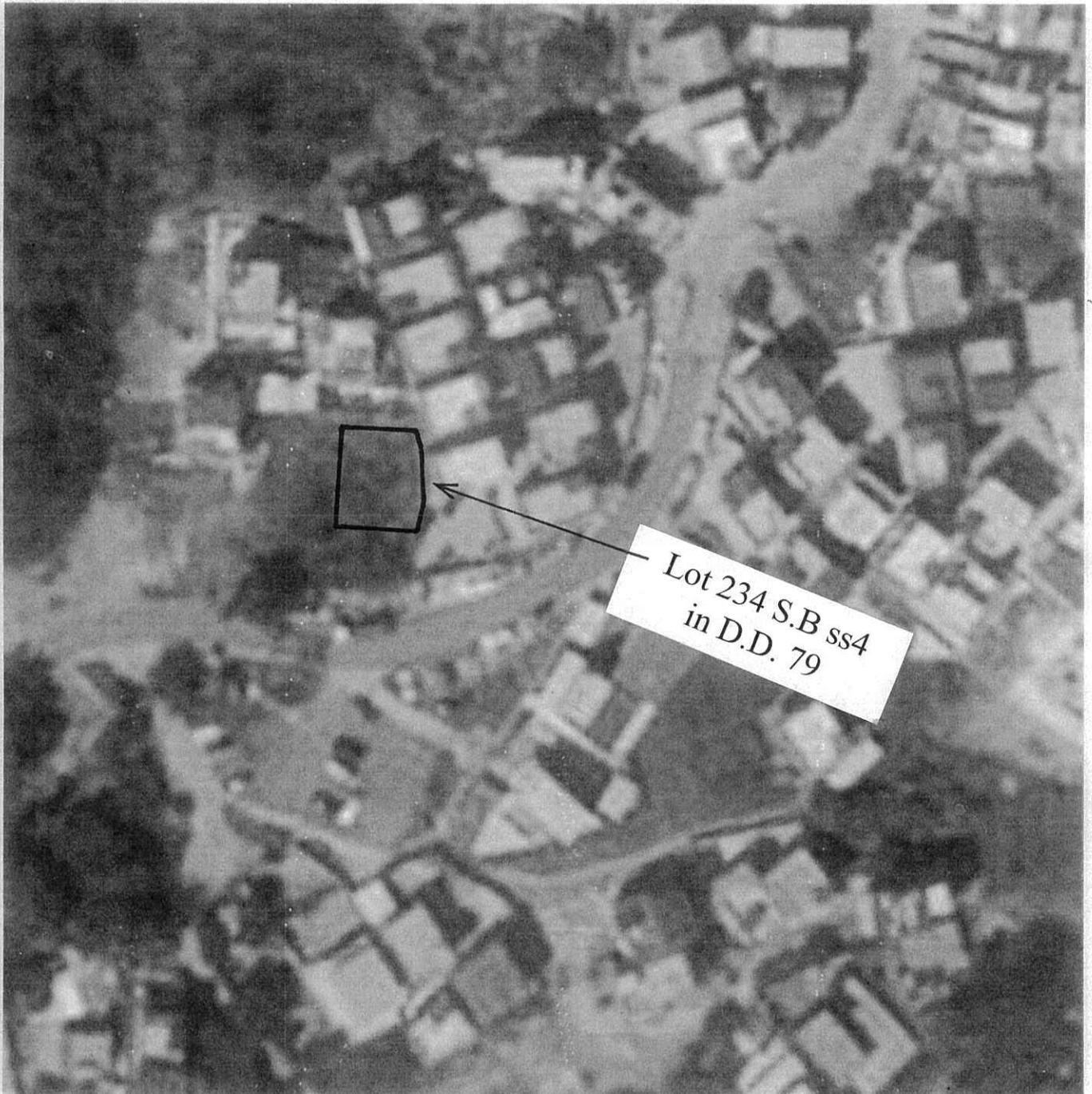

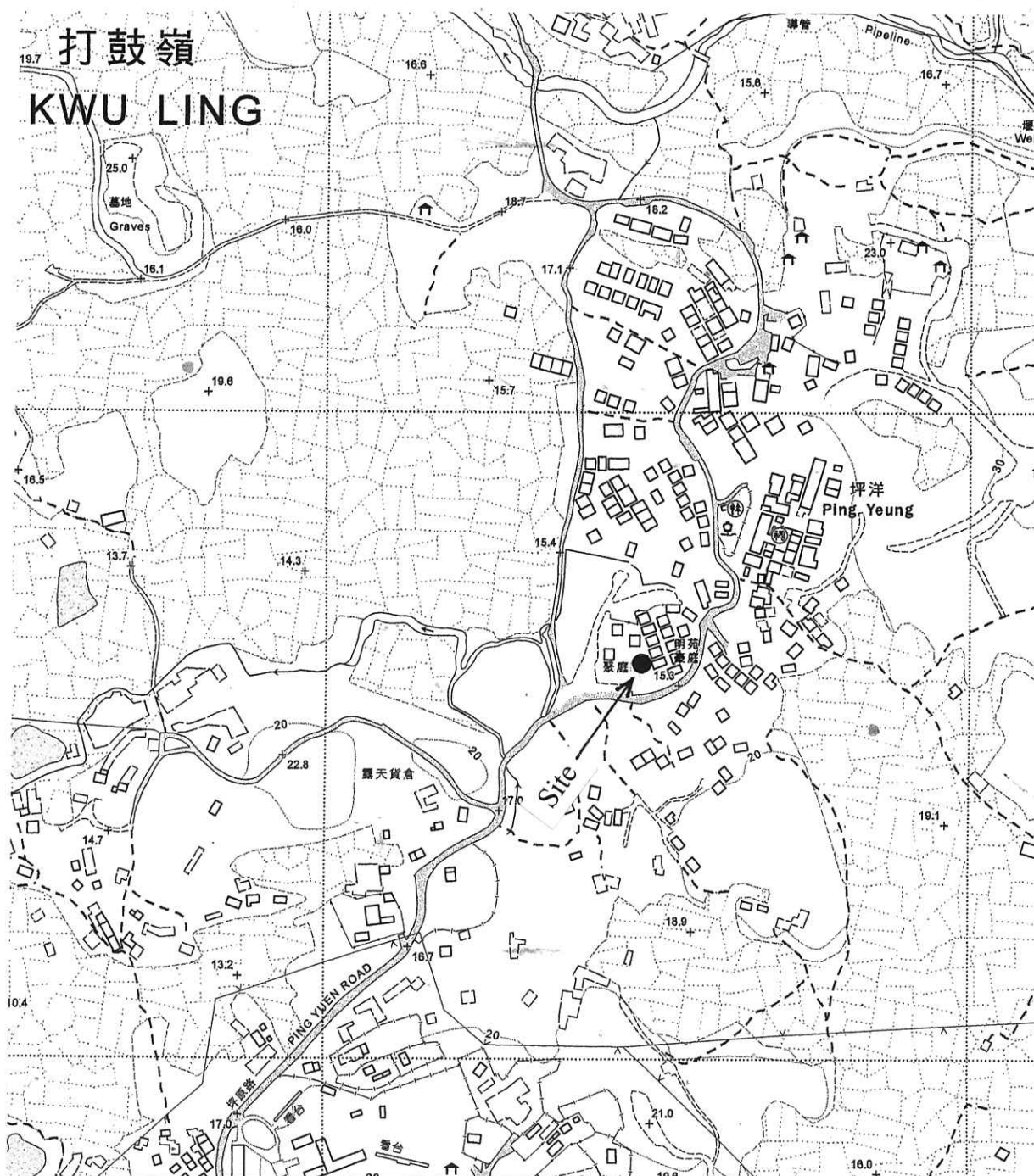

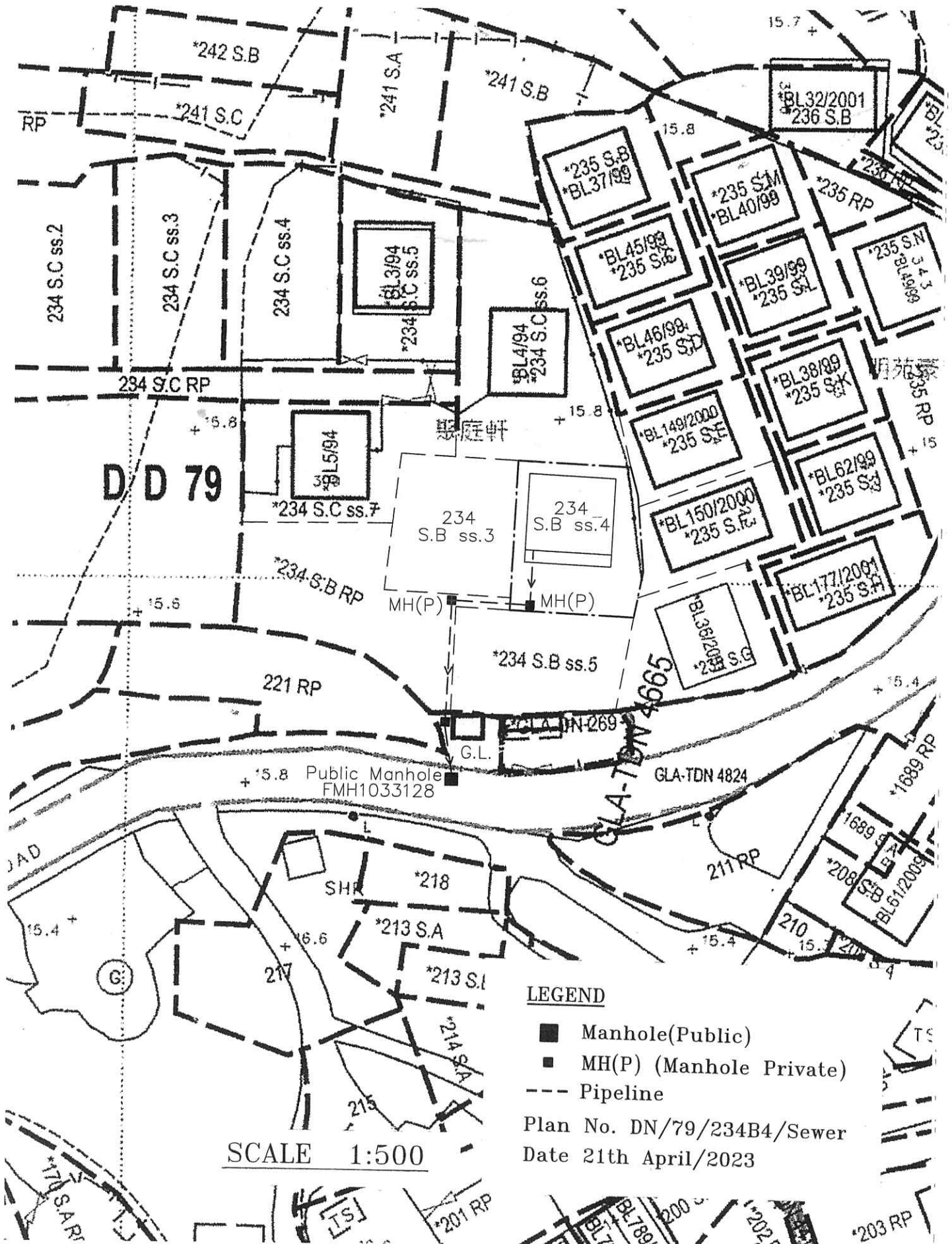

JustificationsLot No. 234 S.B ss4 in D.D. 79

1. The applicant Mr. Chan, James Richard (陳嘉輝) is an indigenous villager of Ping Yeung, District North. Who wishes to apply permission to build a small house under S.16 of the Town Planning Ordinance;
2. The application site is entirely within the village environs boundary of Ping Yeung District North. Centre of the proposed house site is about 12 metres in average away from the Village Type Development "V" zone on the Ping Che and Ta Kwu Ling Outline Zoning Plan S/NE-TKL/14;
3. Land Supply within the "V" zone of Ping Yeung is very limited and there is a high demand of small house applications. It is impossible to purchase land such that the foot-print of the proposed small house is completely falling inside the "V" zone;
4. The proposed development is considered compatible with the rural environment and will be visually un-intrusive to the surrounding;
5. There is NO trees to be trimmed in the proposed small house development;
6. There is NO ditches or stream courses within 30 metres of the proposed site;
7. At present, there is NO vehicular access leading to the subject site, it can only be accessed on foot. Therefore the development would not cause any adverse traffic impact to the surrounding area;
8. Similar applications (Application Nos. A/DPA/NE-TKL/56, A/DPA/NE-TKL/57, A/DPA/NE-TKL/58 and A/NE-TKL/116) for small houses development within "VE" of Ping Yeung were approved by the Town Planning Board in the past;
9. Applicant wishes a sympathetic consideration would be given to his application.

**Relevant Interim Criteria for Consideration of
Application for New Territories Exempted House (NTEH)/Small House in New Territories
(promulgated on 7.9.2007)**

- (a) sympathetic consideration may be given if not less than 50% of the proposed NTEH/Small House footprint falls within the village 'environs' ('VE') of a recognized village and there is a general shortage of land in meeting the demand for Small House development in the "Village Type Development" ("V") zone of the village;
- (b) if more than 50% of the proposed NTEH/Small House footprint is located outside the 'VE', favourable consideration could be given if not less than 50% of the proposed NTEH/Small House footprint falls within the "V" zone, provided that there is a general shortage of land in meeting the demand for Small House development in the "V" zone and the other criteria can be satisfied;
- (c) development of NTEH/Small House with more than 50% of the footprint outside both the 'VE' and the "V" zone would normally not be approved unless under very exceptional circumstances (e.g. the application site has a building status under the lease, or approving the application could help achieve certain planning objectives such as phasing out of obnoxious but legal existing uses);
- (d) application for NTEH/Small House with previous planning permission lapsed will be considered on its own merits. In general, proposed development which is not in line with the criteria would normally not be allowed. However, sympathetic consideration may be given if there are specific circumstances to justify the cases, such as the site is an infill site among existing NTEHs/Small Houses, the processing of the Small House grant is already at an advance stage;
- (e) if an application site involves more than one NTEH/Small House, application of the above criteria would be on individual NTEH/Small House basis;
- (f) the proposed development should not frustrate the planning intention of the particular zone in which the application site is located;
- (g) the proposed development should be compatible in terms of land use, scale, design and layout, with the surrounding area/development;
- (h) the proposed development should not encroach onto the planned road network and should not cause adverse traffic, environmental, landscape, drainage, sewerage and geotechnical impacts on the surrounding areas. Any such potential impacts should be mitigated to the satisfaction of relevant Government departments;
- (i) the proposed development, if located within water gathering grounds, should be able to be connected to existing or planned sewerage system in the area except under very special circumstances (e.g. the application site has a building status under the lease or the applicant can demonstrate that the water quality within water gathering grounds will not be affected by the proposed development*);
- (j) the provision of fire service installations and emergency vehicular access, if required, should be appropriate with the scale of the development and in compliance with relevant standards; and

- (k) all other statutory or non-statutory requirements of relevant Government departments must be met. Depending on the specific land use zoning of the application site, other Town Planning Board guidelines should be observed, as appropriate.
- *i.e. the applicant can demonstrate that effluent discharge from the proposed development will be in compliance with the effluent standards as stipulated in the Water Pollution Control Ordinance Technical Memorandum.

Reasons for Rejection:

- R1 The proposed development was not in line with the planning intention of the “Agriculture” zone in the Ping Che and Ta Kwu Ling area which was primarily to retain and safeguard good quality agricultural land/farm/fish ponds for agricultural purposes and to retain fallow arable land with good potential for rehabilitation for cultivation and other agricultural purposes. There was no strong planning justification in the submission for a departure from the planning intention.
- R2 Land was still available within the “Village Type Development” zone of Ping Yeung where land was primarily intended for Small House development. It was considered more appropriate to concentrate the proposed Small House development close to the existing village cluster for orderly development pattern, efficient use of land and provision of infrastructures and services.

- R3 The proposed development did not comply with the Interim Criteria for Consideration of Application for New Territories Exempted House/Small House in New Territories in that the application site and the proposed houses were entirely outside both the village 'environs' and the "Village Type Development" zone of recognised villages.
- R4 The approval of the application would cause adverse landscape and drainage impacts on the surrounding areas.

Detailed Comments from Government Departments

1. Land Administration

Comments of the District Lands Officer/North, Lands Department (DLO/N, LandsD):

- (a) the application site (the Site) falls within the village ‘environs’ of Ping Yeung Village;
- (b) the applicant claimed himself to be the indigenous villager of Ping Yeung Village in Ta Kwu Ling Heung. His eligibility for Small House grant has yet to be ascertained;
- (c) the Site is not covered by any Building Licence nor Modification of Tenancy;
- (d) the number of outstanding Small House applications and the number of 10-year Small House demand forecast for Ping Yeung Village is 32 and 1,035 respectively;
- (e) Small House application in respect of the Site was submitted to her office on 6.9.2016 but it was subsequently rejected on 9.3.2023 because no planning approval for Small House development on the Site has been obtained by the applicant; and
- (f) according to her record, there is no “fung shui” area at Ping Yeung Village.

2. Traffic

Comments of the Commissioner of Transport (C of T):

- (a) she has reservation on the application. Such type of development should be confined within the “Village Type Development” (“V”) zone as far as possible. Although additional traffic generated by the proposed development is not expected to be significant, such type of development outside the “V” zone, if permitted, will set an undesirable precedent case for similar applications in the future. The resulting cumulative adverse traffic impact could be substantial;
- (b) notwithstanding the above, the application only involves the construction of one Small House. She considers that the application can be tolerated unless being rejected on other grounds; and
- (c) the local track leading to the Site from Ping Che Road is not managed by Transport Department.

Comments of the Chief Highway Engineer/ New Territories East, Highway Department (CHE/NTE, HyD):

- (a) no comment on the application; and
- (b) the access road adjacent to the Site is not maintained by HyD.

3. **Environment**

Comments of the Director of Environmental Protection (DEP):

- (a) in view of the small scale of the proposed development, the application is unlikely to cause major pollution; and
- (b) septic tank and soakaway system is an acceptable means for collection, treatment and disposal of the sewage provided that its design and construction follow the requirements of the ProPECC PN 5/93 “Drainage Plans subject to Comment by the Environmental Protection Department” and are duly certified by an Authorized Person.

4. **Landscape**

Comments of the Chief Town Planner/Urban Design and Landscape, Planning Department (CTP/UD&L, PlanD):

- (a) she has no objection to the application from landscape planning perspective;
- (b) according to the aerial photo, the Site is located in an area of miscellaneous rural fringe landscapes character comprising small houses, clusters of tree groups and vegetated areas. Based on google map images taken in 2022 and PlanD’s UAV photo taken on 25.4.2023, the Site is covered by self-seeded vegetation and some trees of invasive species. Significant adverse impact on the landscape character and existing landscape resources within the Site arising from the proposed use is not anticipated; and
- (c) should the application be approved by the Town Planning Board, it is considered not necessary to impose a landscape condition as there is limited space within the Site for meaningful landscaping and the effect of additional landscaping on enhancing the quality of public realm is not apparent.

5. **Drainage**

Comments of the Chief Engineer/Mainland North, Drainage Services Department (CE/MN, DSD):

- (a) he has no objection to the application from public drainage viewpoint; and
- (b) should the application be approved, a condition should be included to request the applicant to submit and implement a drainage proposal for the Site to ensure that it will not cause adverse drainage impact on the adjacent area, and the drainage system should be properly maintained at all times during the planning approval period and rectified if they are found inadequate / ineffective during operation.

6. **Water Supply**

Comments of the Chief Engineer/Construction, Water Supplies Department (CE/C, WSD):

- (a) he has no objection to the application; and
- (b) for provision of water supply to the development, the applicant may need to extend

his/her inside services to the nearest suitable government water mains for connection. The applicant shall resolve any land matter (such as private lots) associated with the provision of water supply and shall be responsible for construction, operation and maintenance of the inside services within the private lots of WSD's standards.

7. Agriculture

Comments of the Director of Agriculture, Fisheries and Conservation (DAFC):

- (a) the application is not supported from agricultural perspective as the Site possesses potential for agricultural rehabilitation; and
- (b) the Site falls within the "AGR" zone and is abandoned. The agricultural activities are active in the vicinity, and agricultural infrastructures such as road access and water sources are also available. The Site can be used for agricultural activities such as open-field cultivation, greenhouses, plant nurseries, etc.

8. Fire Safety

Comments of the Director of Fire Services (D of FS):

- (a) he has no in-principle objection to the application at this stage provided that the proposed house would not encroach onto any existing emergency vehicular access (EVA) or planned EVA under application in accordance with LandsD's record; and
- (b) the applicant is reminded to observe 'New Territories Exempted Houses – A Guide to Fire Safety Requirements' administrated by LandsD. Detailed fire safety requirements will be formulated upon receipt of formal application via LandsD.

9. District Officer's Comments

Comments of the District Officer (North), Home Affairs Department (DO(N), HAD):

- (a) he has consulted the locals regarding the application;
- (b) the Chairman of Fung Shui Area Committee, the incumbent North District Councilor of N16 Constituency and three Indigenous Inhabitant Representatives (IIRs) of Ping Yeung had no comment; and
- (c) the Ta Kwu Ling District Rural Committee, one IIR of Ping Yeung and the Resident Representative of Ping Yeung did not reply.

10. Demand and Supply of Small House Sites

According to DLO/N's records, the total number of outstanding Small House applications for Ping Yeung Village is 32 while the 10-year Small House demand forecast for the same village is 1,035. According to the latest estimate by PlanD, about 4.5 ha (equivalent to 181

Small House sites) of land is available within the “V” zones of Ping Yeung Village for Small House development. There is insufficient land in the “V” zones of Ping Yeung Village to meet the future demand of land for Small House development (i.e. about 26.7 ha of land which is equivalent to 1,067 Small House sites).

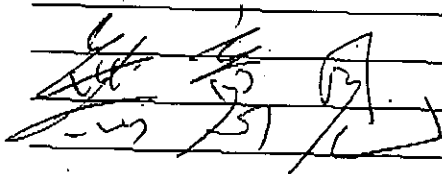

1. We refer to the captioned.
2. Although there are some approved applications for 'Small House' (e.g., A/DPA/NE-TKL/56, 57 & 58; approved in 1993) around the current site, there are also rejected applications nearby in the same Agriculture (AGR) zone, and the reasons to reject one of these applications (A/NE-TKL/619; almost entirely within AGR zone and a tiny corner within Village Type Development zone; rejected in 2019) are shown below:

(a) the proposed development is not in line with the planning intention of the "Agriculture" zone in the Ping Che and Ta Kwu Ling area which is primarily to retain and safeguard good quality agricultural land/farm/fish ponds for agricultural purposes and to retain fallow arable land with good potential for rehabilitation for cultivation and other agricultural purposes. There is no strong planning justification in the submission for a departure from the planning intention; and

(b) land is still available within the "Village Type Development" zone of Ping Yeung where land is primarily intended for Small House development. It is considered more appropriate to concentrate the proposed Small House development close to the existing village cluster for orderly development pattern, efficient use of land and provision of infrastructures and services.

3. We urge the Board to consider whether the above reasons are applicable to the current application.

Recommended Advisory Clauses

- (a) to note the comments of Director of Fire Services that the applicant should observe ‘New Territories Exempted Houses – A Guide to Fire Safety Requirements’ administrated by Lands Department (LandsD). Detailed fire safety requirements will be formulated upon receipt of formal application via LandsD;
- (b) to note the comments of the Director of Environmental Protection that septic tank and soakaway system is an acceptable means for collection, treatment and disposal of the sewage provided that its design and construction follow the requirements of the ProPECC PN 5/93 “Drainage Plans subject to Comment by the Environmental Protection Department” and are duly certified by an Authorized Person;
- (c) to note the comments of the Chief Engineer/Mainland North, Drainage Services Department that;
 - (i) the Site is in an area where public sewerage connection is available; and
 - (ii) there is no public stormwater system in the vicinity of the Site. The applicant should construct and maintain the proposed drainage works whether within or outside the lot boundary by lot owner at their own expense;
- (d) to note the comments of the Commissioner of Transport that the local track leading to the Site from Ping Che Road is not managed by TD;
- (e) to note the comments of the Chief Highway Engineer/ New Territories East, Highway Department that the local access road adjacent to the Site is not maintained by HyD; and
- (f) to note that the permission is only given to the development under application. If provision of an access road is required for the proposed development, the applicant should ensure that such access road (including any necessary filling/excavation of land) complies with the provisions of the relevant statutory plan and obtain planning permissions from the Town Planning Board where required before carrying out the road works.
