2. We sincerely apologise for the oversight that our responsible staff had overlooked the need to apply for the renewal in a timely manner, hence this application.
3: "We hope to be able to continue the "First Aid services".
4. The layout and development parameters of the applied use is similar to the preivous application.
4:1: (The following content is the same as last submission) The first aid post is a pre-fabricated container unit consists of a unit approximately 8.00m x 2.75m (i.e. 22 sqm in terms of covered area) with service station area, lockers, and storage for custom-made bicycles which carry first aid boxes. Open area access to the unit is also included in this application, such open area will not be fenced off, the open area is about 22 sqm; hence the grand total of both covered area & open area is about 44 sqm.
5. The approval conditions had been fully complied with on 27 May 2021.







First Aid bicycles are custom made with a longer bicycle frame in order to facilitate easy usage when first aid boxes are attached to both sides of the bicycles. Since they are custom made, they would have to be securely stored during non-operational hours. Also due to their field patrol nature, they would have to be stored separately (in **Unit 2**) for hygiene reasons to avoid contamination of the treatment unit (**Unit 1**).

The applicant should have its own stormwater collection and discharge system to cater for the runoff generated within the Site and overland flow from surrounding of the Site, e.g. surface channel of sufficient size along the perimeter of the Site; sufficient openings should be provided at the bottom of the boundary wall/fence to allow surface runoff to pass through the Site if any boundary wall/fence are to be erected. Any existing flow path affected should be re-provided. The applicant should neither obstruct overland flow nor adversely affect the existing natural streams, village drains, ditches and the adjacent areas. The applicant is required to maintain the drainage systems properly and rectify the systems if they are found to be inadequate or ineffective during operation. The applicant shall also be liable for and shall indemnify claims and demands arising out of damage or nuisance caused by failure of the systems;
 - (ii) there are existing public sewers in the vicinity of the Site. Drainage record plan at **Appendix IVa** is attached for the applicant's ease of reference; and
 - (iii) the applicant(s) shall resolve any conflict/disagreement with relevant lot owner(s) and seek LandsD's permission for laying new drains/channels and/or modifying/upgrading existing ones in other private lots or on Government land (where required) outside the Site(s).
- (b) to note the comments of the Director of Fire Services (D of FS):
 - (i) the applicant should submit relevant layout plans incorporated with the proposed fire service installations (FSIs) for approval. The layout plans should be drawn to scale and depicted with dimensions and nature of occupancy and the location of the proposed FSIs to be installed should be clearly marked; and
 - (ii) the applicant is reminded that if the structure(s) is required to comply with the Buildings Ordinance (BO) (Cap. 123), detailed fire service requirements will be formulated upon receipt of formal submission of general building plans.
