
- (a) There is serious shortage of parking facilities at the local village. It was proven that the temporary vehicle park has relieved that situation.

**Relevant Extracts of Town Planning Board Guidelines
on Renewal of Planning Approval and Extension of Time for Compliance
with Planning Conditions for Temporary Use or Development
(TPB PG-No. 34D)**

1. The criteria for assessing applications for renewal of planning approval include:
 - (a) whether there has been any material change in planning circumstances since the previous temporary approval was granted (such as a change in the planning policy/land-use zoning for the area) or a change in the land uses of the surrounding areas;
 - (b) whether there are any adverse planning implications arising from the renewal of the planning approval (such as pre-emption of planned permanent development);
 - (c) whether the planning conditions under previous approval have been complied with to the satisfaction of relevant Government departments within the specified time limits;
 - (d) whether the approval period sought is reasonable; and
 - (e) any other relevant considerations.
2. Under normal circumstances, the approval period for renewal should not be longer than the original validity period of the temporary approval. In general, the Town Planning Board (the Board) is unlikely to grant an approval period exceeding three years unless there are strong justifications and the period is allowed for under the relevant statutory plans. Depending on the circumstances of each case, the Board could determine the appropriate approval period, which may be shorter than the time under request.

Approval Conditions

- (a) No vehicle without valid license issued under the Road Traffic Ordinance is allowed to be parked/stored on the Site during the planning approval period.
- (b) Only private car and light good vehicles as defined in the Road Traffic Ordinance is allowed to enter/be parked on the Site at all time during the planning approval period.
- (c) A notice should be posted at a prominent location of the Site to indicate that only private cars and light goods vehicles as defined in the Road Traffic Ordinance are allowed to enter/be parked on the Site at all times during the planning approval period.
- (d) The submission and implementation of fire service installations and equipment for firefighting proposal within a specified period from the date of planning approval.
- (e) The submission and implementation of landscape proposal within a specified period from the date of planning approval.
- (f) The existing planters and landscape features within the Site should be maintained at all times during the planning approval period.
- (g) Permission shall cease to have effect and be revoked if the approval conditions (a), (b) or (c) listed above is not complied with during the specified planning approval period.
- (h) Permission shall cease to have effect and be revoked if the approval conditions (a), (b), (c), or (f) listed above is not complied with during the specified planning approval period.
- (i) Permission shall cease to have effect and be revoked unless the relevant planning conditions on the submission and implementation of fire service installations and equipment for firefighting proposal and landscape proposal are complied with by the specified date.
- (j) Permission shall cease to have effect and be revoked unless the relevant planning conditions on the submission and implementation of fire service installations and equipment for firefighting proposal are complied with by the specified date.

Government Departments' General Comments

1. Land Administration

Comments of the District Lands Officer/Sai Kung, Lands Department (DLO/SK, LandsD):

- (a) the application site (the Site) is an old schedule agricultural lot held under the Block Government Lease within the village 'environs' of Mang Kung Uk Village;
- (b) there is no Small House application at the Site;
- (c) the number of outstanding Small House applications in Mang Kung Uk is 82. However, his office has no information regarding the 10-year Small House Demand Forecast;
- (d) the use of the subject lot for private car park purpose does not constitute a breach of the lease under which the subject lot is held;
- (e) as no structure is proposed to be erected on the subject lot, no temporary waiver or consent under lease from his office is involved following planning permission (if approved);
- (f) the proposed car park should be contained within the subject lot only; and
- (g) it is noted that the Site is accessible from Mang Kung Uk Road via a strip of Government land and a private lot adjoining the Site. His office does not provide maintenance works for this strip of Government land nor guarantees any right-of-way to the Site.

2. Traffic

Comments of the Commissioner for Transport:

- (a) she supports the application based on the observed parking demand;
- (b) based on the observation, the Site is operating as a carpark with relatively high utilisation. Additionally, illegal parking at Mang Kung Uk Road and associated village roads are observed. Since the nearest public car parking spaces managed by Transport Department are at distance of over 800m from this Site, there is an apparent demand in parking spaces in the vicinity;
- (c) should the application be approved, the following approval conditions are recommended:
 - no vehicle without valid license under the Road Traffic Ordinance is allowed to be parked/stored on the Site during the planning approval period;
 - only private cars and light goods vehicles as defined in the Road Traffic Ordinance are allowed to enter/be parked on the Site at all time during the planning approval period; and
 - a notice should be posted at a prominent location of the Site to indicate that only private cars and light goods vehicles as defined in the Road Traffic Ordinance are allowed to enter/be parked on the Site at all time during the planning approval period.

3. **Landscape**

Comments of the Chief Town Planner/Urban Design & Landscape, Planning Department:

the Site (about 1,158m²) is the subject of three previous approved planning applications (No. A/SK-CWBN/35, 44 and 62). According to the aerial photo of 2022, the Site is a hard paved car park with some planters along the southern periphery within the Site. There is no existing tree within the Site. Significant change to the landscape character and adverse impact to the landscape resources arising from the continued use of the development is not envisaged.

- (j) Head of Geotechnical Engineering Office, CEDD;
- (k) Chief Engineer (Works), Home Affairs Department (HAD); and
- (l) District Officer/Sai Kung, HAD.

Recommended Advisory Clauses

- (a) to note the comments of the District Lands Officer/Sai Kung (DLO/SK) that the Site is accessible from Mang Kung Uk Road via a strip of government land and a private lot adjoining the Site, DLO/SK does not provide maintenance works for this strip of government land or guarantee any right-of-way to the Site;
- (b) to note the comments of the Director of Environmental Protection that the applicant is advised to follow the ‘Code of Practice on Handling Environmental Aspects of Open Storage and Temporary Uses’ issued by the Environmental Protection Department; and
- (c) to note the comments of the Chief Engineer/Construction, Water Supplies Department (CE/Construction, WSD) that for provision of water supply to the development, the applicant may need to extend his/her inside services to the nearest suitable government water mains for connection. The applicant shall resolve any land matter (such as private lots) associated with the provision of water supply and shall be responsible for the construction, operation and maintenance of the inside services within the private lots to WSD’s standard.
