Application: Temporary Storage of Vehicle Parts and Accessories for a Period of

3 Years

1. Background

- 1.1 On 11.6.2020, the applicant sought planning permission to use the application site (the Site) for temporary storage of vehicle parts and accessories for a period of 3 years (**Plan A-1**).
- 1.2 On 15.9.2020 and 8.1.2021, the Rural and New Town Planning Committee (the Committee) of the Town Planning Board (the Board) agreed to defer a decision on the application for two months each, as requested by the applicant, to allow time for the applicant to prepare further information (FI) to address departmental comments. After the last deferment, the applicant submitted FI on 2.3.2021 providing responses to departmental comments. The application is scheduled for consideration by the Committee at this meeting.

2. Request for Deferment

On 7.4.2021, the applicant wrote to the Secretary of the Board and requested the Board to defer making a decision on the application for two months so as to allow time to prepare FI to address the departmental comments (**Appendix I**).

3. Planning Department's Views

- 3.1 The application has been deferred twice for a total of four months at the request of the applicant. Since the last deferment on 8.1.2021, the applicant has submitted FI providing responses to departmental comments. The applicant has indicated that he needs more time for the preparation of submission of FI in response to departmental comments.
- 3.2 The Planning Department has <u>no objection</u> to the request for deferment as the justification for deferment meet the criteria for deferment as set out in the Town Planning Board Guidelines on Deferment of Decision on Representations, Comments, Further Representations and Applications made under the Town Planning Ordinance (TPB PG-No. 33) in that the applicant needs more time to address departmental comments, the deferment period is not indefinite and the deferment would not affect the interests of other relevant parties.
- 3.3 Should the Committee agree to defer a decision on the application, the application will be submitted to the Committee for consideration within two months upon receipt of FI from the applicant. If the FI submitted by the applicant is not substantial and can be processed within a shorter time, the application could be submitted to an earlier meeting for the Committee's consideration. The applicant should be advised that the Committee has allowed a further two months for preparation of submission of FI. Since it is the third deferment of the application, the applicant should be advised that the Board has allowed a total of six months for preparation of submission of FI, and no further deferment would be granted unless under very special circumstances.

4. <u>Decision Sought</u>

The Committee is invited to consider whether or not to accede to the applicant's request for deferment. If the request is not acceded to, the application will be submitted to the Committee for consideration at the next meeting.
